- Neither the AQHA, AQHA Youth or Board of Directors shall intervene between the purchaser of the stallion service fee and the stallion owner
- All contracts, arrangements and negotiations that arise in the service of any mare designated for the AQHA Youth Online Stallion Auction will be strictly between the mare owner and stallion owner.
- The Stallion owner is responsible for advising prospective purchasers of the mare breeding of all fees beyond normal breeding expenses if requested.
- All services purchased through the AQHA Youth Stallion Service program and intended for the 2024 breeding season only.
- All chute fees, mare care, shipping fees or any other applicable fees are the responsibility of the purchaser. To find out any other fees that may apply, it is the purchaser's responsibility to check with the breeding facility that the stallion is presently standing.
- Services purchased through the AQHA Youth Online Stallion Auction program are not transferable and may not be re-sold by the purchaser.
