The Mare Owner agrees to breed their mare _____ Registration No: _____

to our Stallion BRANCHVALE METAL ALLOY Registration No: Q-93525

1. Breeding fee:-

- 1.a **The total breeding fee payable** \$ 2750.00 (Incl GST)
The breed fee entitles the mare owner to a Live Foal Guarantee
- 1.b **Non-refundable booking fee** \$ 550.00 (Incl GST)
A non-refundable booking fee is payable on the signing of this Breeding Agreement. This fee must be paid before the semen shipped or mare bred.
- 1.c **Balance of Service Fee** \$2,200.00 (incl GST)
Payable on a positive 45-day pregnancy test.
- 1.d **Is the semen to be shipped** YES ☐ NO ☐
Shipped Semen fee is the responsibility of the Mare Owner.
- 1.e **Embryo Transfer** YES ☐ NO ☐
If more than one foal results from any (1) embryo flush, an additional stallion breeding fee of \$2,500 plus GST will be due and payable upon each successful pregnancy of said embryos on 45-day positive pregnancy test.

2. Live Foal

- 2.a The mare is entitled to a free rebreed to the said Stallion if the foal dies within forty-eight (48) hours of foaling or if the foal is stillborn, in both cases a report certified by a practising Veterinary Surgeon is required. It is agreed that the mare owner provides certification by a licenced veterinarian attesting that the mare aborted or that the foal failed to stand and nurse. This vet certification shall be made within ten (10) days of the date that the mare aborts or the foal is born.
- 2.b The Free Rebreed is only applicable to the year immediately following the breeding of same stallion.
All expenses including shipment incurred in achieving rebreeds shall be upon the mare owner.
- 2.c THE LIVE FOAL GUARANTEE FOR THIS CONTRACT IS A NON-TRANSFERABLE AND NON-ASSIGNABLE unless authorised by KPH. Should mare be sold or otherwise disposed of prior to the birth of the foal, the LFG shall be void unless prior authorisation by KPH.
- 2.d There shall be no liability upon KPH on account of said guarantee except to grant the mare owner a rebreed. Said rebreed shall refer to the breeding fee only. A Rebreed contract must be filled out and returned to KPH immediately.

3. Semen

- 3.a Koobah Performance Horses guarantee to ship the highest quality semen, however, will make no guarantees or warranties and shall not be held liable for contamination or damage of semen during or after shipment, loss of viability or any other cost arising from shipments delayed, damaged, or lost in transit.
SEMEN WILL NOT BE SHIPPED UNTIL THE BOOKING FEE IS PAID IN FULL AND A SIGNED CONTRACT PLUS A COPY OF MARES REGISTRATION PAPERS ARE ON FILE WITH KPH.
- 3.b Where a service fee has been purchased through a Charity Auction – A contract must be completed in its entirety (excluding payment) and the mares registration papers received before the semen will be collected and shipped.
The contract will be valid for one season only, and if a second season required an admin fee of \$250 will be due.

4. Mares

- 4.a Mare owner agrees to notify KPH in writing (text 0438 815 472 or email admin@koobahperformancehorses.com.au) of the pregnancy status of the mare at the 45 day pregnancy scan regardless of if the mare is pregnant or not.
- 4.b A copy of the mare's registration certificate showing owner at the time of breeding must be furnished and returned with this contract.
- 4.c Mare owner to advise KPH of breed certificate/s required for AQHA & ASHS registered mares. Should a mare's registration status change into the future and a breeding certificate is required the mare owner is liable to pay any late lodgement fees incurred. Unregistered mares can be covered.
- 4.d Should the mare on the original contract need to be substituted please contact KPH office for a substitution form. The substitution needs to be approved before the mare can be bred.

5. Assignment

- 5.a This contract shall not be assigned or transferred by the mare owner without written consent of the stallion owner. When the mare owner or authorised representative, signs and returns one copy of this contract to KPH, it will then be a binding contract on both parties subject to the above terms and conditions.
