### 4. Mares

- 4.b A copy of the mare's registration certificate showing owner at the time of breeding must be furnished and returned with this contract.
- 4.c Mare owner to advise KPH of breed certificate/s required for AQHA & ASHS registered mares. Should a mare's registration status change into the future and a breeding certificate is required the mare owner is liable to pay any late lodgement fees incurred. Unregistered mares can be covered.

#### 5. Assignment

5.a This contract shall not be assigned or transferred by the mare owner without written consent of the stallion owner.

When the mare owner or authorised representative, signs and returns one copy of this contract to KPH, it will then be a binding contract on both parties subject to the above terms and conditions.
