Guidelines for Acceptable Use of Kudos Kids & Co Policy for Educators and Students:

Purpose:

To ensure that teachers and students use the Kudos Kids & Co platform responsibly, particularly in managing content that respects privacy, follows consent protocols, and upholds responsible digital citizenship.

Guidelines:

1. Avoiding Unintentional Captures:

3. Content Moderation:

Teachers are responsible for moderating all student-generated content. Any inappropriate content, captions, or comments must be removed immediately. Teachers should also encourage students to practice responsible digital citizenship when sharing their work.

4. Posting on a Student's Behalf:

Teachers may post on behalf of students only when it directly supports their learning, and/or the student is unable to do so themselves. This should be done with transparency, ensuring that the content reflects the student's own work and achievements.

5. Supervision of Student Use:

Teachers must supervise student use of the Kudos Kids & Co platform in the classroom to ensure compliance with acceptable use guidelines.

6. Student Guidance:

Teachers must provide clear guidance to students on how to use the software, including:

- A reminder of the schools Acceptable Use Agreement for digital technologies and adherence to student conduct rules.
- Direction not to share sensitive information.

7. Regular Platform Moderation:

Teachers should regularly monitor the platform to ensure that all content adheres to the school's policies and community standards. Any inappropriate or irrelevant content should be promptly removed.

8. Educational Use Only:

All digital devices and the Kudos Kids & Co platform must be used strictly for educational purposes. Personal use of the platform is prohibited unless explicitly allowed by the school or educational institution.

9. Protection of Personal Data:
