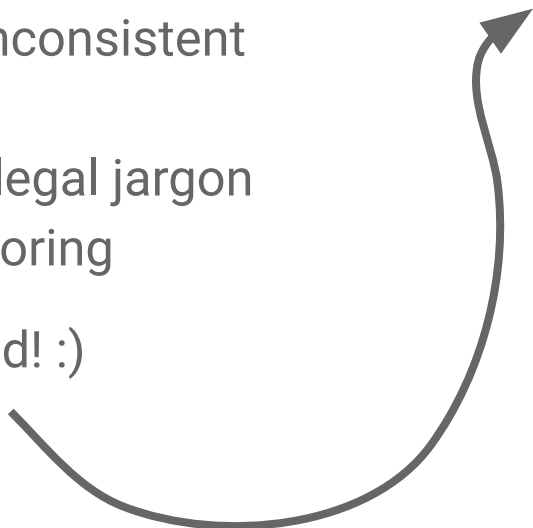

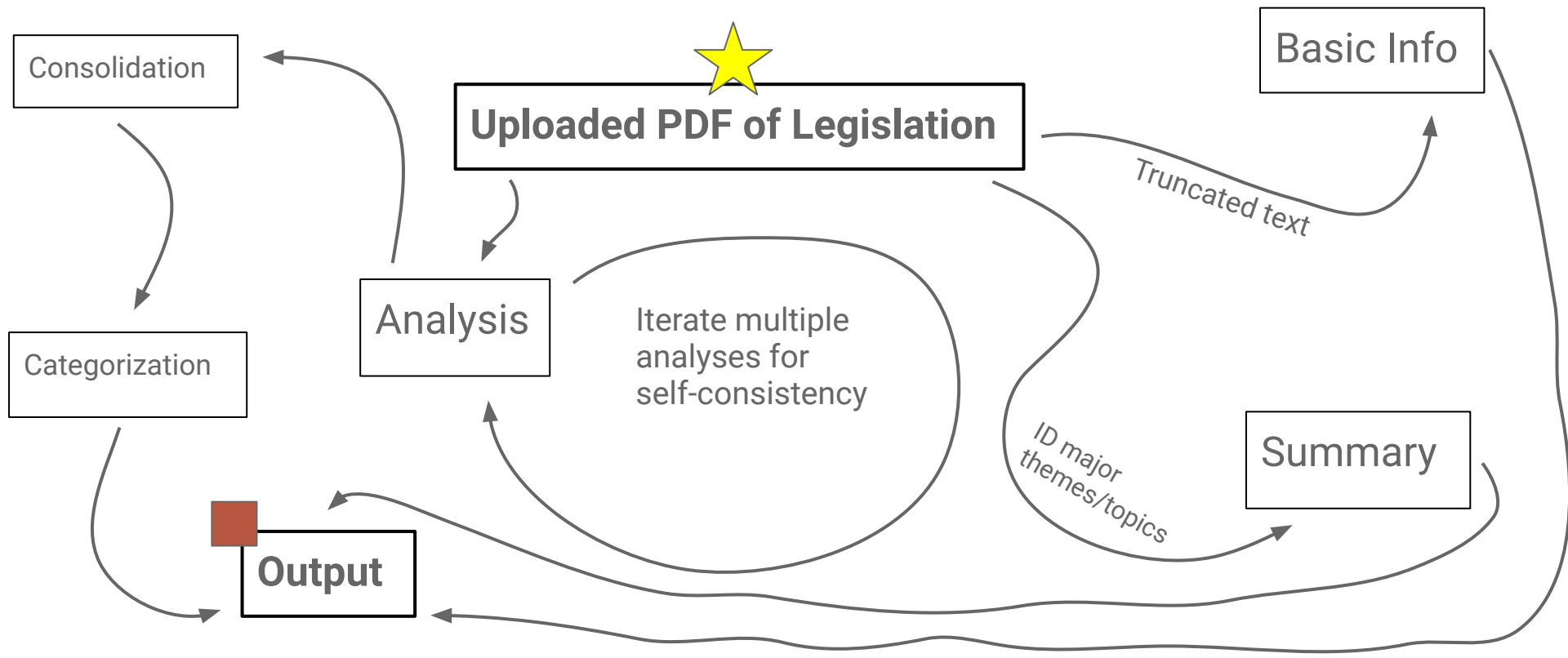

Analysis of Bill includes topics: *Free Speech & Expression, Civil Rights, Accurate IDs*

The bill specifically targets and seeks to prohibit "drag shows targeting minors," which are defined as shows where performers dress in clothing and makeup that does not match their gender assigned at birth. This targets expression that is core to Trans identities and culture.

The bill also seeks to cut off funding for any institution or facility that hosts such shows, which could threaten resources for LGBTQ organizations and spaces.

The definition of "drag show targeting minors" is overly broad and could be interpreted to include shows that are not actually targeting minors, threatening Trans expression more generally.

The bill promotes the harmful and factually incorrect notion that Trans identities and expression are inherently sexual or inappropriate for minors.

"C. FOR THE PURPOSES OF THIS SECTION, "DRAG SHOW TARGETING MINORS" MEANS A SHOW OR PERFORMANCE FOR ENTERTAINMENT AT WHICH A SINGLE PERFORMER OR GROUP OF PERFORMERS DRESS IN CLOTHING AND MAKEUP OPPOSITE OF THE PERFORMER'S OR GROUP OF PERFORMERS' GENDER AT BIRTH TO EXAGGERATE GENDER SIGNIFIERS AND ROLES AND ENGAGE IN SINGING, DANCING OR A MONOLOGUE OR SKIT IN ORDER TO ENTERTAIN A TARGET AUDIENCE OF PERSONS UNDER EIGHTEEN YEARS OF AGE."

The bill promotes discrimination against the Trans community.

In summary, this bill should be opposed due to the threats it poses to Trans identities, expression and community. It is rooted in harmful and factually incorrect stereotypes about Trans people and promotes discrimination.

The legislation requires schools, state institutions of higher education, and private colleges in Ohio to designate separate single-sex interscholastic and intercollegiate athletic teams and sports for females, males, and co-ed participants. It prohibits these entities from knowingly allowing males to participate on athletic teams or in competitions designated only for females. However, it does not restrict males from participating on teams or in competitions designated as male or co-ed.

The legislation prohibits any agency, political subdivision, or athletic organization in Ohio from taking adverse action against schools, state institutions, or private colleges for maintaining separate single-sex athletic teams or sports for females. It provides a private cause of action for injunctive relief, damages, and other remedies for any harm resulting from violations of these provisions.

The purpose of the legislation is to require the designation of separate single-sex athletic teams and sports in order to protect opportunities for female athletes to participate in athletics.

Yes, there are anti-Trans notions.

The bill explicitly prohibits Trans women from participating on women's sports teams, referring to "individuals of the male sex" not being allowed to participate on teams "designated only for participants of the female sex." This policy discriminates against Trans women by denying them the ability to participate in athletics consistent with their gender identity.

Quote: "(B) No school, interscholastic conference, or organization that regulates interscholastic athletics shall knowingly permit individuals of the male sex to participate on athletic teams or in athletic competitions designated only for participants of the female sex."

The bill frames Trans women as a threat to women's sports and as having an "unfair advantage," which is a harmful and medically inaccurate stereotype not supported by scientific evidence. Trans women do not have an inherent athletic advantage after undergoing hormone therapy.

Quote: "A B I L L To enact sections 3313.5319 and 3345.562 of the Revised Code to enact the Save Women's Sports Act to require schools, state institutions of higher education, and private colleges to designate separate single-sex teams and sports for each sex."

The bill encourages retaliation against those who report violations, and protects schools that discriminate against Trans athletes. This fosters a culture where Trans people face backlash and barriers to participation.

"(D) No agency or political subdivision of the state and no accrediting organization or athletic association that operates or has business activities in this state shall process a complaint, begin an investigation, or take any other adverse action against a school or school district for maintaining separate single-sex interscholastic athletic teams or sports."
