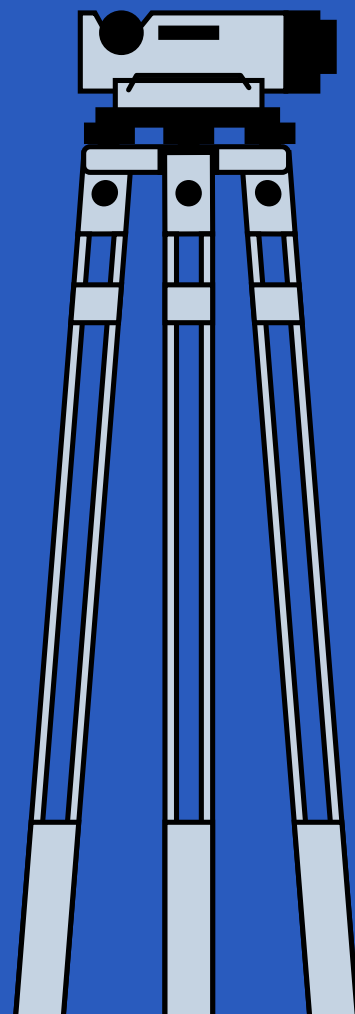




TurboTax For Permits



Problem Statement

By analyzing and interpreting user responses, the assistant can pre-fill repetitive or standard information across multiple forms, minimizing errors and saving time.

STREAMLINED PERMITTING

Simplify the permitting journey with a streamlined, question-based interface that reduces redundancy and speeds up applications.

KEY FEATURES

- Natural language chatbot to guide users step-by-step through the permit process.
- Document auto-filling using AI to identify and populate required fields.
- Permitting dashboard with visual progress tracking.
- Personalized prompts based on the type of business/project and region.

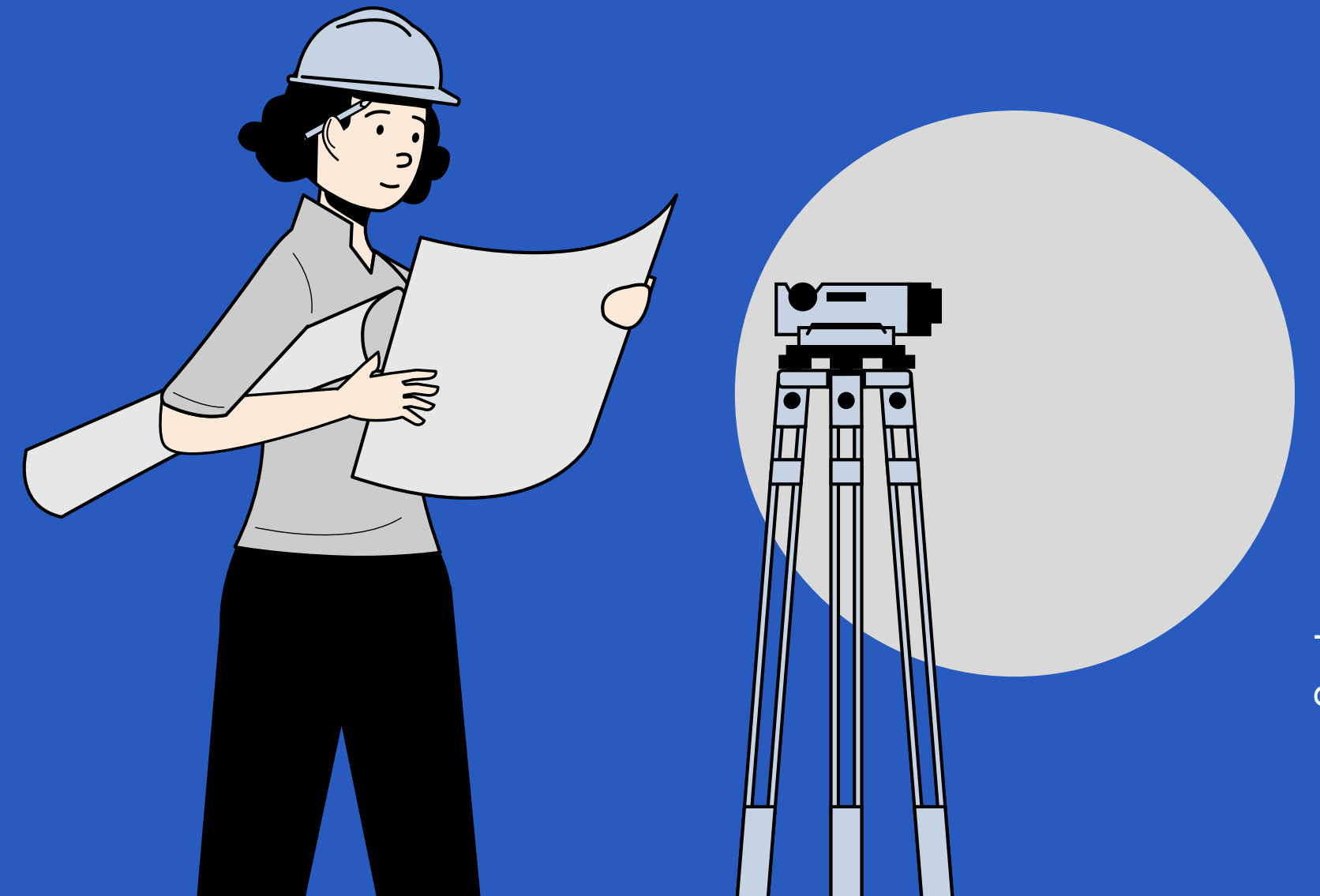
OBJECTIVES

- Customizable for different permitting requirements across regions.

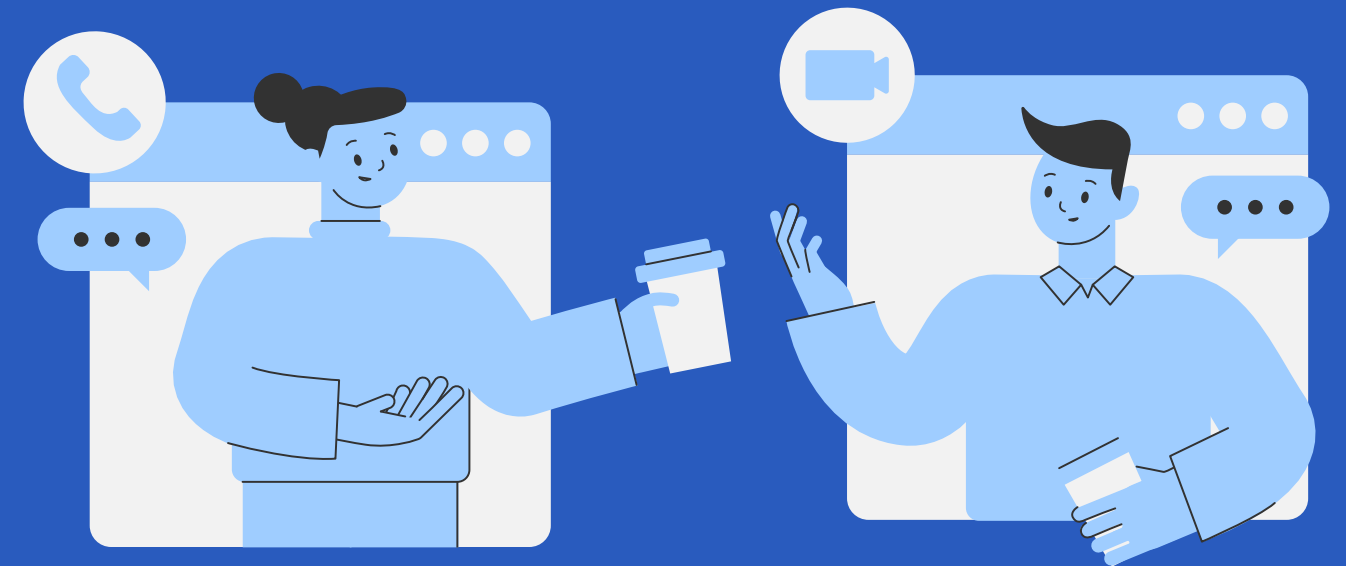
Product Features



Minimum Viable Product:




- Basic conversational bot using Llama to guide users through a questionnaire that captures all required information.
- Progress-tracking bar to show users their stage in the process.
- PDF form completion, using the captured data to auto-fill required fields on standard permits.
- One or two pilot use cases, e.g., opening a restaurant or initiating a construction project.

3 AI Agents

-  **Personable TurboTax-Style Guide** A friendly assistant that guides users through each step
-  **Information Extractor** – Pulls key details from chat history to streamline the process
-  **PDF Filler** – Formats information and auto-populates documents

PDF data scraper with MindsDB

Due dates are pulled from documents with **MindsDB** automation, and displayed on user dashboard

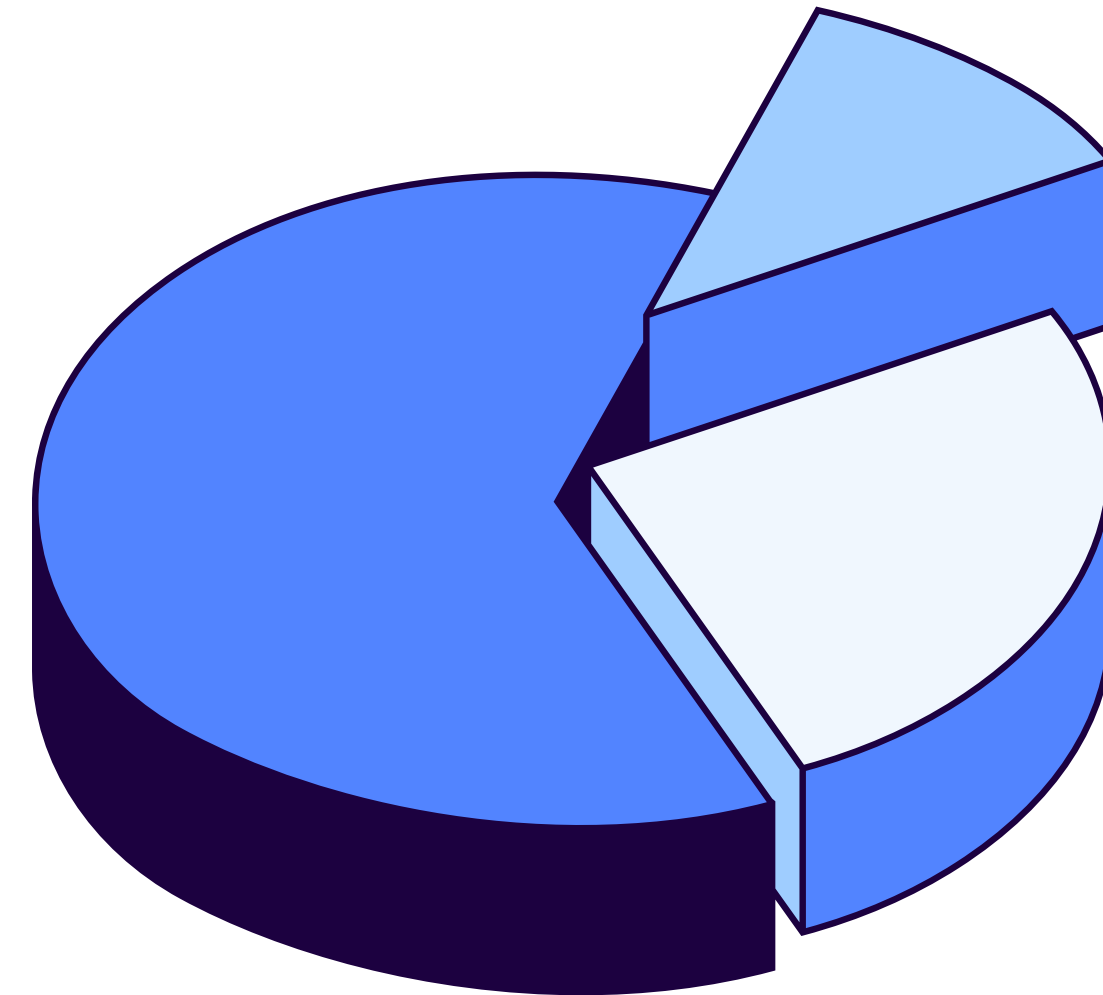
Number of users completing the permit guide without dropping off.
