If the woman refuses to come before the Beth-Din for the Divorce, what action can the Beth-Din (which has no court powers) initiate? Can the husband be permitted to marry a second time, and after what period?

A year or so back, I had written to the Chief Rabbi of England to send me a few copies of his book on Laws of Marriage and Divorce. Although his Secretary promised to send me the required copies, he has not done Jo. Could it be possible for you to obtain atleast one copy for the use of our Union. There is absolutely no news about Tefillin from Israel. I wonder if certain other arrangements can be made to obtain atleast 100 pairs immediately?
