

MEMORANDUM OF AGREEMENT

made this 27th day of October, 1970

- I. AUTHOR'S GRANT. The Author hereby grants and undersigns to B'nai B'rith the following rights for the volume in the Jewish Heritage Classics Series entitled THE COMPASSIONATE SOCIETY
- (A) Book and volume publishing in the English language and in all translations throughout the world;
 - (B) Abridgement, digest, selection, anthology, first and second serialization and syndication;
 - (C) The right to dispose of and/or to grant licenses for the exercise of any or all of the rights herein granted.
- II. SPECIFICATIONS. The Author agrees to deliver to B'nai B'rith, within a reasonable time after commissioning the work, a finally revised copy of said work, as agreed upon between the Author and the General Editor of the Series Dr. David Patterson. The text of the work is to approximate 250 to 300 pages with Introduction of 20 to 25 pages followed by substantial extracts of the given writer's work or of works of a specified period or related to a specific theme. Each of the extracts is to be self-contained, and arresting, and is to be preceded by a short introduction.
- III. COPYRIGHT. B'nai B'rith will have the exclusive right to take out copyright in its name for said work in the U.S. of America and in any foreign country covered by this agreement.

- IV. AUTHOR'S ROYALTIES. The B'nai B'rith agrees to pay to the Author or to his duly authorized representatives the following royalties and other payments, subject to the terms and conditions stated as follows, which royalties and other payments will be accepted by the Author as full compensation for any and all rights, grants, and undertakings provided in this contract;

5% of the retail price of each volume to the first 5,000 copies sold


6-3/4% of the retail price of each volume to the next 5,000 copies sold

7½% of the retail price of each volume thereafter

A subsidiary arrangement will be made between B'nai B'rith and the Author for a paperback edition if and when such an issue is contracted for.

- V. AUTHOR'S WARRANTIES. The Author hereby warrants to the Publisher that he is the sole proprietor of all the material which appears over his own name in the said volume. He further agrees to turn over to the Publisher written permission from the proprietor or copyright owner for the use of all quoted material.
- VI. STATEMENTS OF ACCOUNTS AND PAYMENTS. After publication of the work, the B'nai B'rith will send to the Author an annual statement of royalties together with payment for said amount.
- VII. AUTHOR'S COPIES. The Publisher shall supply free to the Author five copies of the work.
- VIII. RIGHTS RESERVED TO AUTHOR. Forty per cent of any remuneration for any rights in or to the work not specifically granted herein.
- IX. ADVANCE. As an advance against and on account of all monies to accrue to the Author under this agreement B'nai B'rith will pay to the Author the sums of \$500 on the execution of this contract; and \$500 on the delivery of the manuscript to B'nai B'rith. This advance and all other royalties are subject to ten per cent discount for the agent's fee, in this instance, Gerard McCauley Agency, Inc.
