Dear David:

I'd like to invite you to join me in a dvar mitzvah -- and one that is urgent and <u>pikuach nefesh</u>. The enclosed letter is one I received from a Russian Jew who spent 27 years in Siberia, and is now trying to get his son, daughter-in-law, and gramddaughter out of Russia. The letter is self-explanatory. We have to help, and I'd like it to be done as soon as humanly possible if we're to be of any assistance.

First, call Western Union or RCA and send off the following telegram (a night-letter os cheapest) to:

1. Ambassador Dobrynin, USSR Embassy, Washington DC; and

2. Minister of Interior, Moscow, USSR

JUSTICE AND DECENCY DEMAND PERMISSION FOR DR. BENIAMIN A SCHAPIRA AND FAMILY OF BELGOROD OBLASTNOI TO BE REUNITED WITH THEIR FAMILY IN ISRAEL. URGENTLY IMPLORE YOUR INTERCESSION.

Ask the telegram people to send you copies of the cables as soon as possible.

as well as the news clipping Next, send a Xerox copy of the letter to me/to Dr.Seymour Glick Association of Orthodox Jewish Scientists, 84 Fifth Avenue, NY, NY, and enclose a copy of the above cable (i.e., typed by Pauline or Mrs. Scheinberg) and the addresses of the people to whom I sent them. On my stationary, write to Dr.Glick:

Dear Seymour:

I just recieved the enclosed letter, xxx and it speaks volumes. I responded by cabling the Russians, as per the enclosed copy.

I believe this is an opportunity for AOJS to be of major service by getting various (non-Jewish) scientific and technical organizations to intercede both on behalf of this individual, as well as protesting the new Russian scheme of high blackmail for educated Russian Jews to get out. Please send copies of all documents to Rabbi Shalom Yosef Schapira in Israel (Neve Sharet 92/5, Tel Aviv) as per his request, mentioning that you're doing this at my request.
