My dear Rabbi Lamm

I welcome your letter of May 26th and am glad to note your awareness of the unhealthy situation prevalent in the community to-day. Nevertheless sympathy and understanding from your side without immediate action will do nothing for us but lead to the inevitable crises. The voice of righteousness in the face of monetary temptation will be completely ignored as community, as you have seen for yourself, is a very poor one; and it will respond best to the hand that feeds them. This is what the O.R.T. and joint are doing and will be doing in the future. Therefore these self-appointed men on the committee, who have wormed their way into the confidence very ingenously from the Head Office in geneva, have now attained positions over and above the genuine leaders in the community who have no voice at all in the Management of what is today the most powerful financial organisation in Bombay. The talk is, and I am inclined to take it seriously that completely swayed by certain of these committee members and his actions are subtly dictated by them as for example the case of the Sir Jacob Sassoon School. The fear is that these personalities, using the ORT and JOINT orgainsations as their chief weapon, will institute themselves as virtual dictators of our community and with such people as I know them to be, it means virtual spiritual disaster to our jewish people here. I am as disturbed as yourself and even more so as I can see the situation first hand. I am glad you spoke to Rabbi Jung about our position here and I earnestly hope that the whole present situation will be reversed and brought to order with genuine representation of Communal leaders at the helm of the organisation I quite understand that it is necessary to place in question. confidence in the JOINT's fieldmen. As business men ourselves we also have field morkons and we have to put confidence in them but if and when field workers create strife and allow themselves to be influenced by bther than their own bosses, which in the end will tell against the firm, such fieldmen must be pulled up or called back to save further confusion in the business.

to resign from the Orthodox Organisation, I am sure he has the to you in a state of despondency over the embarasiss situation he has found himself in and I can assure you that I shall put pressure on him not to take drastic action but stand firm for one's religious principles. Nevertheless the incursion of two rank outsiders in the Trusteeship of the school is not a tactical defeat, but a complete disaster. My viewpoint is absolutely correct and I cannot impress you enoug with it. If immediate staps are not taken by Rabbi Jung to balance this situation, it will not be very long when you will see how very right I am. As regards the crisis developed in Bombay regarding the Ben-Israel Marriage opposition in Israel

though I have been even approached by the press Trust of India to issue a statement, I declined to do so and have not involved myself in this controversy, knowing the situation is a most delicate one for us here. However, I hope the mattery will settle itself in the near future to the satisfaction of all.
