

WOMEN TO WATCH AWARD - Nomination Form

The AICPA's Women's Initiatives Executive Committee (WIEC) initiated the Women to Watch Award Program in 2005 in partnership with several state CPA societies to honor outstanding women in the profession. The Women to Watch awards highlight the accomplishments of women in the profession, and demonstrate to emerging female leaders that success is not out of reach. The event provides a forum for state CPA societies to lead important conversations about issues their female members face.

The awards are given in two categories: EMERGING LEADERS and EXPERIENCED LEADERS.

EMERGING LEADERS are those who are up-and-coming stars in their organizations. While every item is not required for consideration, nominees will be judged on the following criteria:

- Public and/or community service
- Demonstration of leadership
- Contribution to the profession
- Creation and implementation of unique initiative(s)
- Involvement with alma mater or other local colleges and universities

EXPERIENCED LEADERS are those who have established their roles as leaders in their organizations by advancing to the highest levels of management or ownership, and by mentoring those following in their footsteps. While every item is not required for consideration, nominees will be judged on the following criteria:

- Authorship of articles
- Major or unique contribution to the profession
- Public and/or community service
- Mentoring other professionals (*most heavily weighted item)
- Improvement to the workplace

Please provide supporting documentation as evidence of a nominee's accomplishments. This may include letters of recommendation for supervisors, peers, students, community organizations, etc. Résumés are not required, but strongly recommended.

Winners will be selected by a special task force of MACPA's Board of Directors and recognized at the Women to Watch Award event on September 18.
