- **Travel Teams (Bogaty)**
 - **12u Team Issue** - 12u has only 10 players for the summer season and cooperstown tournament. A former 11u travel player volunteered to play on the team for summer travel and cooperstown. Board voted and approved both request.
 - **9u Blue Team issue** - A player was not offered a spot on the 9u travel team. The player's parent posted incendiary remarks about the coach's children in a private thread on social media. Team and coaches became irate and contacted the board. Ari/Ian met with Parent and he was remorseful and apologized about the posting. Coaches parents also went to the police and school and filed complaints. E-committee enforcing that parent will not be allowed to coach permanently. The Parent will also be banned on the Plainview Fields when games are played indefinitely.
