

HIGH DESERT PONY LEAGUE

POST COVID-19 RETURN TO PLAY WAIVER

HIGH DESERT PONY LEAGUE HAS LIMITED OPERATIONS DUE TO THE COVID-19 PANDEMIC. THIS IS A WAIVER TO ALLOW PLAYERS TO PARTICIPATE IN HIGH DESERT PONY LEAGUE ACTIVITIES UNDER CERTAIN CONDITIONS.

IN CONSIDERATION OF ALLOWING THE BELOW PLAYER TO PARTICIPATE IN ANY WAY IN THE ACTIVITIES AND/OR BEING HEIRS, OR NEXT OF KIN, I HEREBY AGREE TO ENTER ANY RELATED PREMISES, EACH OF THE UNDERSIGNED, ON BEHALF OF THEMSELVES, THEIR EXECUTORS, ADMINISTRATORS, HEIRS, NEXT OF KIN, SUCCESSORS, PERSONAL REPRESENTATIVES, AND ASSIGNS, HEREBY VOLUNTARILY AGREE THAT:

A. THE PLAYER OR PARENT/GUARDIAN AGREE TO A BIDE BY HIGH DESERT PONY LEAGUE POST COVID-19 RETURN TO PLAY GUIDELINES.

B. THE PLAYER OR PARENT/GUARDIAN AGREE THAT IF AT ANY TIME THEY BELIEVE SOMETHING TO BE UNSAFE, IT WILL BE BROUGHT TO THE ATTENTION OF A HIGH DESERT PONY LEAGUE OFFICIAL. OFFICIALS INCLUDE, BUT ARE NOT LIMITED TO, BOARD MEMBERS, DIRECTORS, COORDINATORS, COACHES, ASSISTANT COACHES, OR UMPIRES.

C. THE PLAYER AND PARENT GUARDIAN ASSUME FULL RESPONSIBILITY FOR THE RISK OF BODILY INJURY, DEATH, PROPERTY DAMAGE DUE TO THE ACTIONS OR NEGLIGENCE OF HIGH DESERT PONY LEAGUE, THEIR BOARD MEMBERS, OFFICERS, EMPLOYEES, VOLUNTEERS, REPRESENTATIVES AND AGENTS (HEREINAFTER, "RELEASEES") OR OTHERWISE, WHILE IN OR ON THE PREMISES, USE OF EQUIPMENT OR PARTICIPATING IN ACTIVITIES. THE MINOR AND PARENT/GUARDIAN RECOGNIZE AND UNDERSTAND THAT THERE ARE RISKS AND DANGERS ASSOCIATED WITH PARTICIPATING IN THE ACTIVITIES. FURTHER THE RISKS AND DANGERS MAY BE CAUSED BY THE ACTIONS OR NEGLIGENT FAILURE TO ACT OF THE RELEASEES AND OTHERS. ALL OF THE RISKS AND DANGERS ASSOCIATED WITH PARTICIPATING IN THE ACTIVITIES, ENTRY INTO THE PREMISES, OR USE OF EQUIPMENT ARE ASSUMED AND NOTWITHSTANDING.

D. THE PLAYER AND PARENT/GUARDIAN ASSUME FULL RESPONSIBILITY FOR THE RISK OF ILLNESS, HOSPITALIZATION OR DEATH, DUE TO DIRECT OR INDIRECT CONTACT WITH INDIVIDUALS WHO HAVE OR MAY HAVE BEEN EXPOSED TO AND/OR DIAGNOSED WITH ONE OR MORE COMMUNICABLE DISEASES, INCLUDING BUT NOT LIMITED TO, COVID-19 OR OTHER MEDICAL CONDITIONS, DISEASES, OR MALADIES AND/OR ANY MUTATION OR VARIATION THEREOF.

E. THE PLAYER AND PARENT/GUARDIAN WAIVE RELEASE AND DISCHARGE THE RELEASEES FROM ANY AND ALL LIABILITY FOR MY DEATH, DISABILITY, PERSONAL INJURY, PROPERTY DAMAGE, PROPERTY THEFT OR ACTION OF ANY KIND MAY HEREAFTER ACCRUE TO THE PLAYER PARENT/GUARDIAN AND THEIR ESTATES.

F. THE PLAYER AND PARENT/GUARDIAN INDEMNIFY, SAVE AND HOLD HARMLESS, THE RELEASES AND EACH OF THEM PERSONALLY FROM AND AGAINST ANY AND ALL LIABILITIES , LOSS, DAMAGE, CAUSES OF ACTIONS AND CLAIMES ARISING FROM THE MINOR'S PARTICIPATION IN THE ACTIVITIES IDENTIFIED HEREIN OR PRESENCE IN PREMISES WEATHER CAUSED BY REALESSES, THE MINOR OR OTHERWISE.
