### FINANCIALS

On a consolidated basis, 2023 was a solid year for LifeSpire. Net operating income was \$1.2M, compared with a loss of \$4.4M in 2022, and our net asset position improved by \$7.6M. While we are confronted with the same staffing challenges and persistent inflation as the entire senior living industry, strong occupancy (more than 95% at the end of April) and the diligent efforts of our communities' operating teams are mitigating these impacts as much as possible. LifeSpire continues to reinvest in its communities and execute its strategic plan, updated in 2023.

LifeSpire remains comfortably in compliance with its debt covenants, and its debt remains rated "BBB" by Fitch Ratings, Inc. For more details, please see the most recent tax-exempt bond continuing disclosure ("EMMA") filing on our website: *lifespireliving.org/financial-disclosures/.*



### KNITTING FOR A CAUSE



A close-"knit" group of residents at Lakewood use their knitting and crocheting talents to support The St. Mary's Hospital NICU and Pediatric Wards. The group meets weekly and hand-knits hats for newborns and children at the hospital. These extraordinary ladies selflessly give their time to the cause throughout the year while enjoying precious time and fellowship together.

Leading this initiative are residents Peggy Harvey, Janice Gravitt, Phylis Doswell and Gail White.

Peggy, also fondly known as the knitting lady at Lakewood, began her knitting journey while attending college. She taught herself how to knit from a book and her passion has only grown stronger over the years. "It takes

about five hours to knit a hat for the hospital," said Harvey. "We love doing it and spending time together each week."

Peggy and her husband, Albert Dabney Harvey, attended numerous knitting conferences worldwide, from Niagara Falls to the British Isles. Wales. Scotland. Norway, Alaska, Sweden and Denmark, blending her love for knitting with their love for travel.

"My husband is a bit of an enabler! He would attend conference sessions for me while I was attending another and when I would find yarn that I thought I couldn't live without, he encouraged me to seize the opportunity and buy it. I am so grateful for his support over the past 58 years we have been married.'

Lakewood newcomer Janice Gravitt generously donated her extensive yarn collection when she downsized to move into the community. At the age of 15, she was taught by her mother, Phylis Doswell, through a mirror image technique. Throughout the years, she has honed her skills to make anything, from hats to scarves and shawls. Janice also enjoys crocheting



just as much as knitting and uses both techniques for various projects. Her grandchildren, unfamiliar with which technique she may be using, has nicknamed her skillsets yarning. "It's so funny when my grandchildren call me and ask if I'm varning today," said Gravitt. "It makes me giggle every time they call."

Janice's mother Phylis learned to crochet when she was 10 years old and has taken a preference to it over knitting. The dynamic knitting and crocheting duo are both active members of the prayer shawl ministry at St. Andrews United Methodist Church, further extending their talents to provide comfort and solace to those in need.

Knitting has shown to have many health benefits such as helping with muscle memory and coordination. For Gail, knitting is something she can still do, despite losing most of her eyesight. She shows up every week to knit with her friends at Lakewood. "Seeing detail up close is difficult," she admits, "but I can still knit." Gail's passion for the craft was kindled at a young age when her mother and grandmother taught her the art of creating intricate patterns with yarn. Over the years, she has created countless hats, chemo caps, dialysis knits and scarves, each one a testament to her unwavering commitment to serving others.

With each stitch, these ladies pour their hearts into creating cozy gifts, knowing that they will provide not only physical warmth but also a sense of care and compassion for the little ones and their families.

### FIVE SENIOR COMMUNITIES, **ONE PURPOSE**

ach year, all five LifeSpire communities and AgeSmart raise money for local Alzheimer's associations with the goal to help find a cure. In total,

\$28.000 was raised in 2023 by residents and team members with another \$5,000 sponsored by the Virginia Baptist Homes Foundation. LifeSpire communities held events such as 5K walks. longest day summer kickoff, doughnut sales and flowers for a cause. These efforts not only raise funds to help find a cure for Alzheimer's, but also bring awareness to this unforgiving

disease. According to research by the Alzheimer's Association, 55 million people worldwide are living with Alzheimer's and other dementias. Alzheimer's is a type of dementia that affects memory, thinking and behavior. Symptoms eventually

grow severe enough to interfere with daily tasks. Alzheimer's is the most common cause of dementia, a general term for symptoms like a decline in memory or other cognitive abilities. Living with Alzheimer's is not a normal part of

Thoughtful design of LifeSpire's Memory Support neighborhoods reduces confusion and provides around-the-clock security. With

# **OUR BENEVOLENT**

Every year, the Virginia Baptist Homes Foundation raises over \$1 million to benefit seniors in LifeSpire of Virginia communities, thanks to those committed to taking care of residents who need help. Gifts to the Benevolent Fund support those residents who, through no fault of their own, need additional financial resources to stay in their homes. In 2023, 43 residents were provided peace of mind with benevolent assistance.

Supporting the Benevolent Fund assists residents like Barbara. She and her husband spent their married years serving Baptists throughout Virginia. He was a wellloved pastor throughout the commonwealth. and she worked at her local Baptist Association serving its churches and leaders. Their ministerial work made them familiar with the mission of Virginia Baptist Homes, and Barbara remembers fondly when the fundraising office for her future LifeSpire of Virginia community opened in the same building where she worked.

At the time, she had no thoughts of ever living in a retirement community. Time proved her wrong, and she and her husband found a way to move to into a LifeSpire community. Her husband passed away shortly after moving in, but Barbara kept active with her church ministry, new friends and so many activity choices. For a number of years, her community has been her safe and comfortable home.

As the cost of living increased, Barbara's anxiety also increased. Savings for retirement dwindled to a dangerous level. "Much to my relief, our community's Benevolent Fund came to my rescue! It provides a subsidy which gives me security and peace of mind. I truly believe that my community's leaders try to meet the daily needs of residents by providing attractive living spaces. nourishment and activities. I continue to offer my sincere appreciation for these blessings."


