The Live Conscious Terms and Conditions and the Live Conscious Influencer Terms & Conditions (collectively, the "Terms" or "Agreement") are a legally binding contract between you and Live Conscious. BY BECOMING A LIVE CONSCIOUS INFLUENCER, YOU AGREE TO ALL OF THE TERMS AND TO FULLY COMPLY WITH AND ABIDE BY THE AGREEMENT. Therefore, we ask that you **PLEASE READ THE FOLLOWING TERMS CAREFULLY**.
