THE TRANSFORMATIONAL POWER OF TRANSACTIONS

Transactions can be transformative in the shipping business. They can transform a company's strategy, as CPLP did, or transform its balance sheet, as GasLog did. And every deal is a struggle in its own way. For some deals, it's a struggle to get it done at all. But even the strongest deals struggle to be completed with the best possible terms and pricing based on market conditions. And while some are more dramatic than others, every transaction that received a Deal of the Year award has its own unique story. Like all good stories, each deal has a beginning, a middle, and an end. Deals begin as an idea, or a need, followed by a plan, followed by a lot of suspense and struggle, and finally, a positive outcome. Each deal features its own cast of characters that bring the energy and the action — owners and investors, lawyers and lenders — and we are honored to recognize the outstanding people and outcomes in this highlight-reel issue of Marine Money.

Thematically speaking, 2023 was a year of shipowners playing

offense, thanks to the fact that every shipping sector was profitable. Most owners didn't really need to raise money, so the tone of the transactions you will read about in these pages is more strategic than defensive. Some refinanced existing facilities to streamline balance sheets and deal with coming maturities, others did M&A, and still others used creative financing to renew their fleets with environmentally superior vessels. Equity issuance

was almost nonexistent, because owners didn't need equity and valuations below net asset value didn't provide temptation. Other trends this year included non-bank shipping funds raising more capital and a convergence of debt pricing around 9 percent. Whether borrowing money from a bank or a fund or in the bond or leasing market, the pricing was similar.

On the offshore side, a fascinating market that now straddles traditional fossil fuels and green energy, growth was the defining story, as the mature oil and gas market continued its resurgence and the fledgling offshore wind market tried to build a new fleet of specialized assets to meet growing demand for clean energy. In 2023, the bond market and direct lenders were notable go-to sources of capital for offshore oil and gas, as the

pool of banks supporting the sector continued to shrink, while banks and funds with greener mandates were there for the wind market. In every case, expert teams found the right fit between sources of capital and the companies whose efforts, in combination, will lead us through a successful energy transition.

Every deal is different, but they have common elements: teams of professionals working together, and overcoming challenges, to accomplish a goal while achieving the best possible outcome. Also, most deals are even given a project name by the deal team, to maintain confidentiality and provide a shorthand way of referencing them. We are delighted to have the privilege of highlighting these deals and the dollars in this issue, but we are especially proud to recognize the outstanding teams behind the transactions. We appreciate how much hard work goes into deal-making in a high-stakes, big-ticket business like shipping, which is why we will be celebrating the winners at Marine Money Week with an award ceremony and photo opportunity. We look forward to seeing all the winners there so we, and the rest of the ship finance community, get a chance to raise a glass and congratulate them on a well-earned award!
