Session 1 course will enable healthcare professionals to quickly update themselves with fundamental knowledge on Diabetes in a self-learning mode.


The course will provide basic knowledge in quick time (3 months) through online modules and assessments.



This online learning program will be for duration of 12 months. This will be delivered in 3 stages- Session I, Session II and Session III.



Live Virtual Classes:
