

Auto Accident Checklist

Steps to take after a car accident in Superior, CO

Based on Auto Accident Lawyer Superior Co by McCormick and Murphy

1. Immediate Actions at the Scene

Prioritize safety and gather essential information right after the accident.

- Check yourself and others for injuries.
- Call 911 if anyone is hurt.
- Move vehicles to a safe location if possible.
- Call the police to file an accident report.
- Document the scene with photos (vehicles, damage, road, signs, etc.).
- Exchange contact and insurance information with the other driver.
- Get names and phone numbers of any witnesses.

2. Medical Attention

Ensure your health is properly assessed, even if injuries seem minor.

- Seek medical attention, even if you don't think you are seriously injured.
- Be aware that some symptoms may not appear immediately.

3. Reporting the Accident

Follow the correct procedures for notifying relevant parties.

- Report the accident to your insurance company.
- Do not give a recorded statement to any insurer until you speak with an attorney.

4. Legal Consultation

Understand when and why to seek legal advice.

- Contact an attorney before saying anything that could be used against you.
- Consider consulting with McCormick & Murphy, P.C. for guidance.

5. Information Gathering Checklist

Keep track of all the crucial details you need to collect.

- Driver's Name(s)
- Driver's Contact Information
- Driver's License Number(s)
- Insurance Company Name(s)
- Policy Number(s)
- Witness Name(s)

- Witness Phone Number(s)
- Police Report Number (if available)

6. Scene Documentation Checklist

Ensure you capture comprehensive visual evidence.

- Photos of all involved vehicles' damage
- Photos of the overall accident scene
- Photos of road conditions
- Photos of traffic signs and signals
- Photos of any debris on the road
- Photos of skid marks or other evidence
