Factor	USAA's Alleged Actions	McCormick & Murphy's Perspective	Legal Implications
Claim Handling	Unreasonable delays, denials, and lowball offers.	USAA may be acting in bad faith by not honoring policy terms.	Potential for breach of contract and bad faith claims.
Policy Interpretation	Interpreting policies narrowly to avoid coverage.	USAA may be misrepresenting policy coverage.	Claims of misrepresentation and deceptive practices.
Investigation	Failing to conduct thorough investigations.	USAA may not be diligently investigating claims.	Evidence of inadequate investigation can support bad faith.
Communication	Poor communication with policyholders.	USAA may be failing to communicate in good faith.	Lack of good faith communication can be a factor in bad faith cases.
Settlement Offers	Offering inadequate settlement amounts.	USAA may be pressuring policyholders into unfair settlements.	Unfair settlement offers can indicate bad faith.
Colorado Law	USAA's practices may violate Colorado's insurance laws.	Colorado law requires insurers to act in good faith.	Violations can lead to significant damages for the policyholder.
