Based on Sample Case Result by McCormick and Murphy

Initial Consultation: Case Evaluation and Intake

- Client meets with McCormick & Murphy attorneys.
- Initial assessment of the case merits and potential.
- Gathering preliminary client information and documentation.



Investigation Phase: Evidence Gathering and Analysis

- Thorough investigation of the accident circumstances.

Litigation Commencement: Filing the Lawsuit

- If negotiations fail, filing a lawsuit to protect the client's rights.
- Serving the defendant(s) with legal documents.



Discovery Phase: Information Exchange

- Formal exchange of information and evidence between parties.
- Depositions of parties and witnesses.
- Interrogatories and requests for production of documents.



Settlement Negotiations: Continued Resolution Efforts

- Ongoing negotiations based on discovery findings.

- Exploring mediation as a potential resolution tool.



Trial Preparation: Preparing for Court

- Finalizing trial strategy.
- Preparing witnesses and exhibits for trial.
- Motions and pre-trial hearings.



Resolution: Settlement or Verdict

- Achieving a favorable settlement agreement.
- Or, proceeding to trial and obtaining a verdict.
- Finalizing all legal paperwork and distributing proceeds.
