

Colorado Springs Dog Bite FAQ

Answers to common questions about dog bite incidents in Colorado Springs.

Based on Dog Bite by McCormick and Murphy

Q: What should I do immediately after a dog bite?

A: Seek medical care right away, even if the bite seems minor. Dog bites carry a high risk of infection and need professional cleaning and treatment.

Q: What information should I gather after a dog bite?

A: Take photos of your injuries, get the dog owner's contact information, and report the bite to Colorado Springs Animal Control.

Q: Should I keep records after a dog bite?

A: Yes, save all medical records and bills related to your injury.

Q: What are the risks associated with dog bites?

A: Dog bites carry a high risk of infection and require professional cleaning and treatment.

Q: Who should I contact after a dog bite in Colorado Springs?

A: Contact McCormick & Murphy at 719-389-0400 for a free consultation to understand your legal rights.

Q: Do I need to see a doctor for a minor dog bite?

A: Yes, seek medical care right away even if the bite seems minor, as dog bites have a high risk of infection.

Q: What is the first step after a dog bite?

A: The first step is to seek immediate medical attention for the bite.

Q: What should I photograph after being bitten by a dog?

A: You should take photos of your injuries sustained from the dog bite.

Q: Who is responsible for handling dog bites in Colorado Springs?

A: You should report the bite to Colorado Springs Animal Control.
