Denying Claims	Improperly denying valid claims.	Challenging wrongful claim denials.	Reversal of denials and payment of benefits.
Lowball Offers	Offering significantly less than the claim's value.	Negotiating fair settlements for policyholders.	Securing full and fair compensation.
Lack of Investigation	Failing to conduct thorough investigations.	Highlighting investigative failures.	Establishing liability for bad faith.
Misrepresenting Policy Terms	Distorting policy language to deny coverage.	Clarifying policy terms and coverage.	Enforcing rightful policy benefits.
Bad Faith Tactics	Employing deceptive or unfair tactics.	Exposing and combating bad faith conduct.	Holding insurers accountable.
Colorado Law	Violating Colorado's insurance laws.	Applying Colorado's bad faith statutes.	Seeking damages under Colorado law.
