

Motorcycle Accident Process Flow

Steps to take after a motorcycle accident in Colorado Springs

Based on Motorcycle Accidents by McCormick and Murphy

Step 1: Ensure Safety and Call 911

If possible, move your motorcycle and yourself to a safe location away from traffic. Immediately call 911 to report the accident.

- Prioritize your safety and the safety of others.



Step 2: Seek Medical Attention

Even if you believe your injuries are minor, get medical attention. Adrenaline can mask pain and the severity of injuries.

- Document all medical visits and treatments.



Step 3: Document the Scene

Take photographs of the accident scene, including the vehicles involved, road conditions, traffic signals, and any visible injuries.

- Capture as much detail as possible from multiple angles.



Step 4: Exchange Information

Collect the name, contact information, and insurance details from the other driver involved in the accident. Also, gather information from any witnesses.

- Ensure you have the other driver's insurance policy number.



Step 5: Avoid Admitting Fault

Do not admit fault or apologize at the scene of the accident, as this can be used against you later.

- Stick to the facts when speaking with anyone involved.



Step 6: Notify Your Insurance Company

Report the accident to your own insurance company. Provide only the basic facts of what happened.

- Keep a record of when and to whom you reported the accident.



Step 7: Contact McCormick & Murphy

Before providing any statement to the other driver's insurance company, contact McCormick & Murphy at 719-389-0400.

- Protect your rights by speaking with an attorney first.
