Immediately After the Bite: Immediate Actions and Medical Care

- Seek medical attention promptly, even for minor bites.
- Document injuries with photographs.
- Obtain the dog owner's contact information.
- Report the bite to Colorado Springs Animal Control.



Following Medical Treatment: Gathering Essential Documentation

- Collect and save all medical records related to the bite.
- Keep all medical bills and expenses incurred.



Initial Legal Consultation: Understanding Your Legal Rights

- Contact McCormick & Murphy for a free consultation.
- Discuss the details of your dog bite incident.
- Learn about your legal options and rights.



Legal Process - Investigation: Building Your Case

- McCormick & Murphy will investigate the circumstances of the bite.
- Gather further evidence, including witness statements if available.



Legal Process - Negotiation: Seeking Resolution

- Engage in discussions with the dog owner's insurance company.
- Negotiate a fair settlement based on damages and liability.



Legal Process - Litigation (If Necessary): Pursuing Your Claim in Court

- If settlement is not reached, prepare for litigation.
- File a lawsuit to pursue compensation through the court system.



Resolution: Claim Conclusion

- Receive compensation for your injuries and losses.
- Close the legal case.
