Initial Consultation: Understanding Attorney Compensation

- Discuss attorney fee structures (e.g., contingency fees).
- Clarify how attorneys are paid (percentage of recovery).
- Understand the difference between fees and costs.
- Inquire about costs advanced by the attorney.



Case Assessment: Factors Influencing Costs

- Evaluate the complexity of your specific case.
- Consider the attorney's level of experience.
- Determine the applicable fee structure.



Contingency Fee Basis: Contingency Fee Explained

- Understand that payment is contingent on winning the case.
- Note that the attorney receives a percentage of the settlement or judgment.
- Recognize this is a common fee arrangement.



Cost Reimbursement: Separate Cost Recovery

- Acknowledge that costs are separate from attorney fees.
- Understand that advanced costs are reimbursed to the attorney.
- Clarify when cost reimbursement occurs (typically at case conclusion).



Transparency: Ensuring Clarity

- Prioritize open communication about all financial aspects.
- Seek detailed explanations of all potential charges.
- Confirm all fee and cost details in writing.
