- 1. General provisions
- 1.1 This Agreement is concluded between the Company LLC Medusa Project (hereinafter "Meduza"), registered in the Republic of Latvia (registration number: 40103797863), and an individual or legal person, regardless of residence (hereinafter the Donor), who intends to make a donation in favor of "Meduza".
- 1.2 "Meduza" accepts the terms of this Agreement at the time of its publication on the site meduza.jo.
- 1.3 The published Agreement is valid indefinitely. "Meduza" has the right to terminate the Agreement at any time by removing it from the site meduza.io
- 1.4 "Meduza" reserves the right to amend this Agreement. The amendments take effect immediately after they are published on the website.
- 2. Terms of the Agreement
- 2.1 The Donor shall donate funds or cryptocurrency to the ownership of "Meduza" free of charge in the amount determined by the Donor.
- 2.2. Purpose of the donation: compensation of expenses for the creation of journalistic content and its distribution on the "Meduza" websites the website Meduza.io, the "Meduza" mobile app, social networks and instant messengers, email newsletters or through any other channel. The donation can as well be used as compensation for any other costs associated with the creation and distribution of journalistic content by Meduza's editorial team.
- 2.3 The moment of conclusion of the Agreement is considered to be the transfer of funds or cryptocurrency by the Donor by any of the methods indicated on the page support.meduza.io or save.meduza.io.
- 2.4 By agreeing to this Agreement, the Donor consents to the processing of personal data, to the extent necessary for the execution of this Agreement, in accordance with the rules published on the following page: https://meduza.io/en/feature/2018/05/25/how-we-process-your-personal-data-stored-by-meduza
- 2.5 If the Donation is made using a bank card or the Paypal payment system, the Donor has the right to make either one-time or regular payments once a month or once a year.

The Donor can cancel their recurring payment at any time by sending an e-mail to support@meduza.io

- 2.6 In case of an erroneous payment, the Donor has the right to cancel it within 7 days by sending a payment cancellation request to support@meduza.io
- 2.7 By making a payment, the Donor confirms:
- 2.7.1 That they act on their own behalf, at their own expense and in their own interest. Or, acting on behalf of a legal entity, they have the necessary authority to do so.
- 2.7.2 That, as an individual or legal entity, they are not subject to sanctions imposed by Latvia, the EU, the US or the UK.
- 2.8 In the event that "Meduza" becomes aware that at the time of transferring the Donation, the Donor did not meet the conditions of clause 2.7, "Meduza" has the right to unilaterally, out of court, refuse to fulfill the Agreement and return the funds received to the Donor, as well as demand compensation for losses caused to the Company.
- 2.9 "Meduza" may refuse a Donation at any time prior to its transfer or within 500 days of its receipt. In case of refusal of a donation, "Meduza" will return it within 7 days that the relevant decision is made. In this case, this Agreement is considered terminated from the moment the refusal is decided. If it is not possible to return the Donation, it will remain at the disposal of "Meduza".
- 2.10 When making a Donation, the Donor may remain anonymous or, on the contrary, provide "Meduza" with any additional information by writing to support@meduza.io.
- 2.11 "Meduza", in turn, reserves the right to contact the Donor to identify them in cases provided for by the legislation of Latvia and the EU on prevention of the legalization of proceeds from crime, as well as in case of relevant requirements from banks, financial operators and tax authorities. In particular, the law requires the identification of all Donors who transfer 10 thousand euros (or equivalent in other currencies) or more to "Meduza" within a calendar month.
- 2.12 If the Donation is made by bank card through the form on the site meduza.io, "Meduza" will automatically provide the Donor with a receipt confirming the transfer, sent by email to the address indicated by the Donor.
- 2.13 Donations made under this Agreement cannot be used to claim a tax deduction.
