

SPAR WIN A YEARS WORTH OF DATA 2025

TERMS AND CONDITIONS:

- 1. The promoter is The SPAR Group LTD ("the Promoter").
- 2. This promotional competition is open to all South African residents who are 18 years or older, in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
- 3. This promotional competition starts on 26 May 2025 and ends 31 July 2025. Any entries received after the closing date and time will not be considered.
- 4. To enter, participants will be required to:
 - Be an active SPAR Mobile Subscriber (i.e. you must own an activated SPAR Mobile SIM Card);
 - Purchase SPAR Mobile products (i.e. Data, Voice Minutes, SMS, Airtime) worth at least R50 within the competition period;
 - Be a SPAR Rewards member to be entered.
- 5. The prizes will be 1 (one) of 10 (ten) data prizes where each winner will receive a year's worth of data. Ten (10) winners will be chosen at the end of the competition and will be announced by Monday 4 August 2025. The value and size of such data prize is 12 months of 6GB each month valid for 30 Days.
- 6. Any prize not taken up for any reason within 72 hours of notification will be forfeited.

- 7. All winners must provide their full names and surnames, contact details and daytime physical address eligible for their prize.
