Prop 12. and Market Hogs

Due to Prop 12 we will be requiring **ALL** Market Hog entries to include a document signed by the breeder of their hog stating that they are Prop 12 compliant. We have created the attached form for use, or you may submit a letter from your breeder on their letterhead stating compliance.

In 2023 Hog breeders will be self certifying, however 2024 will require breeders to be certified by a 3rd party auditor.
