# Miss California Mid-State Fair Scholarship Pageant

## GENERAL ELIGIBILITY REQUIREMENTS

***Mandatory Orientation/Workshop: Wednesday, May 2, 2018 @ 6:00pm***

Each contestant must turn in a letter of recommendation, a current wallet photo, a completed official application and contract by 4:00 p.m., Friday, April 27, 2018, to the Paso Robles Event Center Administration Office, 2198 Riverside Ave., Paso Robles, CA or mailed to Paso Robles Event Center, PO Box 8, Paso Robles, CA 93447. All mailed in applications must be postmarked by April 27, 2018. **NO EXCEPTIONS!**

Contestant must be between the ages of 17 – 24 years old, the day of the pageant (July 17, 2018).

Contestant must be female, single, have never been married nor is planning to be married until after her reign, and have never given birth to a child.

Contestant must be a current resident of San Luis Obispo County for at least 6 months as of the day of the pageant – Tuesday, July 17, 2018.

Contestants may compete in the Miss California Mid-State Fair Pageant more than once, provided they have never previously been selected as “Miss California Mid-State Fair”.

Contestants **must** be able to attend rehearsals and scheduled activities relating to the pageant and the California Mid-State Fair.

Unauthorized absences will be cause for disqualification from the pageant. The Pageant Director will make the final decision in case of illness or emergencies.

All contestants must conduct themselves as a professional representative for the California Mid-State Fair and exhibit good sportsmanship at all times. Contestants and winners must keep a positive attitude toward the public, the Pageant Director, Asst. Director, all Pageant Officials, Fair Personnel, and fellow contestants including postings on social media. Any negative attitude or inappropriate behavior will be cause for disqualification from the pageant.

For one year following the Fair, arrangements between Miss California Mid-State Fair and any person or organization desiring publicity photos, public relations work, etc., must be cleared with the California Mid-State Fair. All photographs and videos taken are the property of the California Mid-State Fair.

Fair management reserves the right to close entries early and limit the number of contestants. The committee will have the final say on how an elimination process is handled, i.e. interview, lottery, impartial pre-judging panel, essay, etc.

Contestants will compete in five areas: Interview, Platform, Talent, Swimsuit, and Evening Wear.

All contestants will establish a platform of service for the California Mis-State Fair. The platform will be completed during the 2019 Fair. (This will be explained further during orientation meeting).

All rehearsals are closed to the public.

The decision of the judges is final and scoring sheets will not be released.

Contestants understand that if they is selected as “Miss California Mid-State Fair” or either of the two Fair Princesses, that she will be a year-round ambassador of the Fair, and that her daily presence during the Fair is mandatory and she must make herself available for events promoting the California Mid-State Fair and the community until such time her reign is completed, or is crowned another title. A Fair-time schedule and Community Event schedule (all subject to change) will be provided.

On Wednesday, July 18, 2018 at 9:00 a.m. pageant winners will meet with Fair Officials to discuss duties, responsibilities and their daily Fair schedule. Fair management reserves the right to dictate a year-round schedule as they see fit.

If chosen as “Miss California Mid-State Fair” or a Princess, your day will start at 3:00 p.m. daily, unless otherwise stated.

Only winners receive admission to all events. Concert tickets, meals, and other miscellaneous benefits are a privilege and not a guaranteed prize.

Only Pageant Staff will be permitted to escort the Queen and her Princesses as they fulfill their duties during the Fair. Family and/or friends will not be permitted to provide additional escorting services.

Responsibilities include, but are not limited to making public appearances, assisting with fundraisers, visiting local civic group events, attending parades, fairs, holiday celebrations, other pageants, ribbon cuttings, dinners, and those events deemed appropriate by the Pageant Director. Reasonable notice will be given in advance of events where attendance is required.

If chosen as a winner, it is understood that the contestant or parents, if contestant is a minor, will be responsible for any taxes or fees involving prizes awarded and agree.

Dress code will be strictly enforced at all public appearances. Clothing must be free from holes and the appropriate length. If clothing does not meet the dress code, contestants and winners will be required to change. If in doubt, ask. Dress code will be discussed in complete detail and informational paperwork will be provided at the first meeting.

It is understood that the failure to fulfill any of the requirements stated above during the reign of the Miss California Mid-State Fair will result in the forfeit of the title and all gifts, prizes and scholarships associated with the pageant. It is also understood that no refunds will be issued of any kind. It is at the discretion of the Pageant Director and the California Mid-State Fair that the title be given to the next highest scoring contestant.

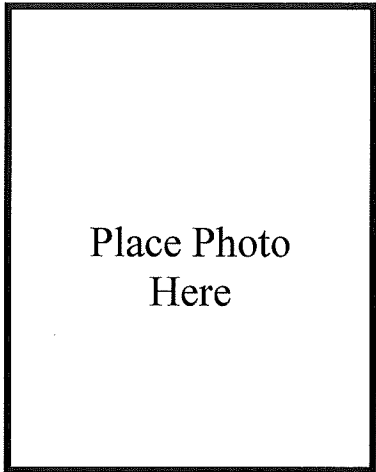
