Director Sabin reported the County of San Luis Obispo will continue using the Association as a COVID-19 testing site. CDFA has waived the rental fee but approved a consumable fee to be charged to the County. She said upcoming approved events include the Christmas Tree farm and Toys for Tots. Daniels Woodland is currently moving into the Adelaide Building to begin a PPE gown manufacturing facility. Production is scheduled to begin on Monday and will run 6 days per week, 20 hours per day. Their contract is through the end of June with extension options through September. The contract covers all expenses incurred by the Association and a 10% building rental fee. January scheduled horse shows have canceled due to the stringent guidelines provided by the County of SLO, and the remaining events are on hold until restrictions have eased.

Director Sabin reported the Finance Committee will meet Tuesday, January 19th to discuss the 2021 budget.
