



Virtual Show Rules and Parameters:



****Exhibitors who are Novice showman will not lose their novice status by participating in this virtual show and will be eligible to compete as novice exhibitors at the 2021 California Mid-State Fair****

Rules for Participation:

1. Exhibitors must be 9-19 years of age as of January 1, 2020, in good standing with their 4-H club, FFA Chapter or qualify to be an independent exhibitor.
2. Exhibitors must participate in both the sale and show. No exceptions.
3. Animals must be dropped off at the appropriate date and time to qualify entry video in the virtual show.
4. Exhibitors must submit videos on or before July 22nd at 4pm to be qualified to be listed in the sale.
5. All exhibitors must enter animals using their fair DNA tag.
6. All Exhibitors must submit a complete Drug and Residue Release for their projects on the day they are dropped off. (Release must be with animal when unloaded, not in another vehicle. Releases will be checked before animals are unloaded off of vehicle, please have each driver with organized releases for animals on their vehicle only, upon arrival.)

Video Parameters:

1. Videos need to be at least 60 seconds and must NOT exceed 90 seconds.
2. A virtual code will be provided to each exhibitor on July 17th at 5:00 pm. Exhibitors must show the provided virtual code and ear tag in the first 10 seconds of video. Exhibitors need to enter their virtual video show AFTER the code is provided but before the deadline of July 22nd at 4:00 pm
3. Videos cannot be altered or photoshopped in any way. Any exhibitor that violates this rule will be removed from the show and will not be permitted to be an exhibitor at the 2021 California Mid-State Fair.
4. No coaching or talking to the exhibitor in the video
5. Show animals must be clean, clipped and fit for show as they would be normally for our in-person show. (Sheep with ¼ inch or less of wool, heifers slick shorn, and swine clipped, goats clipped)
6. Exhibitors must wear their 4-H, FFA or Independent uniform in its entirety (please see handbook for specific requirements). Exhibitors who do not meet this qualification will be disqualified.
7. No previously won awards may appear in the video.
8. No Sponsors, feed companies or products used can be shown during exhibitors video.
9. Exhibitors must be in the video for the entire duration.
10. Exhibitors must exhibit their own animal.

11. The animal should be the main focus of the video.
12. Videos should be taken in the horizontal orientation if using a phone or tablet.
13. Videos may not change orientation during filming

Awards:

All awards will be available on or after August 1st 2020. Awards not picked up will be mailed to exhibitors on August 6th 2020. Awards can be picked up by calling or texting Hailey Rose Switzer at 805-458-4334 and scheduling an appointment. All Supreme Champion and Reserve Supreme Champions will receive awards.

Auction Rules:

1. Auction Photos must be submitted July 20th 2020 by 4pm
2. A 7.25% commission will be charged to the seller for both the livestock sale and add-ons.
3. Sellers of Market Beef, Swine and Sheep will be charged fees required by livestock
