Remember our ownership deadline for Market Sheep, Market Hogs and Market Goats is quickly approaching, that date is May 22nd 2019. DNA kits must be purchased by May 22nd and returned, completed with DNA samples by May 23rd to the Fair Office. Remember **Entries must be submitted on ShoWorks by June 11, 2019.**

Important Reminders and updates:

- **Competition Handbook** - The 2019 Livestock Competition Handbook is now available on our website under the livestock show tab. The book and entries will be 100% online and no hard copies are available. Please go to www.midstatefair.com
- **ShoWorks Entry System**- You may begin entries for the show starting May 16, 2019. Enter at www.cmsfl.fairmanager.com
- **4-H Field Day will be held June 1st.** The Fairgrounds Staff will also be putting on an entries clinic from 8:30AM-1:30PM for those that need help using our online system!
- **Poultry Show**- has been canceled due to the outbreak of Newcastle Disease, the shows will return in 2020! Poultry exhibitors and other youth however, will be able to participate in the first ever Poultry Knowledge Bowl competition on Wednesday, July 17. Entries will be accepted through ShoWorks.
- **YQCA**- Youth Quality Care Assurance Program must be completed by **June 10th 2019**. It can be completed by going to www.yqca.org (If exhibitors have shown at another fair or show that requires this program and have completed the program this year the certification number will also work for the CMSF requirement.)
- Exhibitors must take the **San Luis Obispo Water Quality Assurance Survey** by **June 10th 2019**. The survey can be found at: <https://www.surveymonkey.com/r/CMSF1>
- **Biosecurity**- New this Year, exhibitors will be required to read and sign our Biosecurity Protocols. This is provided to assist all exhibitors in creating an environment for the health and welfare of all livestock, exhibitors and guests. This will be available June 1, 2019.
- **Leader meeting** will be **Monday July 15th**
 - New this year! Load in schedule will be distributed via email on **July 11th** to community leaders and advisors only, so they may plan accordingly. The mandatory leader meeting will be held on July 15th at 6:00PM.

- Management will again be enforcing our strict animal bedding policy and ask exhibitors to NOT use saw dust. Exhibitors may use wood shavings, bagged pelleted wood bedding products and straw (only in cattle and open sheep barns)
- **Entry limits** have been modified from 2018. Exhibitor will only be permitted to show and sell the following combinations for large animals;
 - 1 Market Sheep, 1 Replacement Heifer or;
 - 1 Market Hog, 1 Replacement Heifer or;
 - 1 Market Goat, 1 Replacement Heifer or;
 - 1 Market Steer, 1 Replacement Heifer
 - Any Exhibit with an above combination of large animals may also show and sell 2 Meat Rabbit Pens
- **Adelaide Parking-** The dirt parking lot located next door to the Adelaide Hotel and accessible from Riverside Ave will be available to 4-H and FFA leaders again in 2019. Season parking passes for this lot are only available in advance and can only be purchased on a first-come, first-serve basis. These season parking passes are only valid for this lot and can be used for any vehicle and are transferable. Season passes for this lot are \$140.00. Passes may be reserved with full payment starting May 20, 2019 and reservations are due no later than **June 14, 2019 or until spaces are no longer available**. Reservation Forms are available online at www.midstatefair.com. Adelaide parking permit will be provided to purchasers at the fair office starting July 6, 2019.
- **Season Carnival Wristband** -\$125 to exhibitors, these wristbands are good for all 12 days of the fair! (Must be purchased between June 1st and June 21st) Forms can be found at: https://storage.googleapis.com/midstatefair-com/uploads/19-Carnival_Wristband.pdf
- **New All swine will arrive Sunday, July 21. (Please see schedule for more details)**
- **New Herdsman Award:** Exhibitors need not to enter. All clubs and chapters will automatically be entered for this award. Management will assign judges and oversee the competition as well as scoring and results. Exhibitors will be evaluated on pen or stall cleanliness, club or chapter display effectiveness and design, as well as club or chapter sportsmanship as a whole. Award winners will be announced during the awards ceremony on Sunday July 28th 2019. A complete score card and more information can be found in the Livestock Competition Handbook.
- **New Rules for Displays-** This years' theme is "Let's Have S'more Fun"
 - 1 . All 4-H club and FFA chapter displays must be made of breathable materials, meaning no solid wood or metal structures, solid canvas material or other materials that will inhibit airflow will be allowed.
 - a . Approved materials include but are not limited to lattice, vinyl, and shade cloth.
 - 2 . Displays may not be more than 4 feet in height above the club or chapters designated pens or stalls.
 - 3 . Each Pen or stall must clearly be marked with exhibitor name, and animal tag ID number (fair issued tag).
- **Open Sheep Show** will return and take place on July 17th and 19th
- **CJLA Wether Dam Ewe** and **Wether Dam Doe Shows** will return on July 19th
- **Stock Show Mom and Dad Showmanship** will return on July 28th

CALIFORNIA MID-STATE FAIR YOUTH LEGACY PROJECT

The California Mid-State Fair and the James W. Brabeck Youth Legacy Fund, a fund of the Community Foundation San Luis Obispo County, announce the inaugural Youth Legacy Project.

All contributions will be focused in three specific areas.

SCHOLARSHIPS

Scholarships will be awarded to deserving and qualified youth exhibiting at the California Mid-State Fair.

- A Scholarship will be awarded to eligible recipients in four single-year increments totaling up to as much as \$20,000.
- A blind application process will be conducted online with consistency to secondary education requirements.

High school-age youth eligible to apply are those planning and eligible to participate in the California Mid-State Fair Junior Livestock Show, Industrial Education, Agriculture /Floriculture /Ornamental Horticulture or Tractor Restoration Project.

The Scholarship Recipient will:

- Act as an ambassador for the California Mid-State Fair and the Youth Legacy Project
- Follow all the Legacy Project guidelines required for project production, exhibition, management, care and husbandry.
- After selection, students must maintain full-time enrollment status with 2.5 GPA or higher and be under no disciplinary actions.

Any student on academic probation or below required GPA will be given requisite time to correct.

CAPITAL FUNDING

Contributions will also support youth-related program capital projects or activities at the California Mid-State Fair that adhere to the Mission Statement of the California Mid-State Fair and the Mission Statement of the California Mid-State Fair Heritage Foundation.

EXHIBITOR HARDSHIP CASES

Creates a fund in which exhibitors may apply for a pre-defined hardship as a result of participation as an exhibitor at the California Mid-State Fair.

The inaugural fundraising event will held on Saturday, July 27, 2019
at the California Mid-State Fair.

2019 California Mid-State Fair Swine Influenza Vaccination Program

Below are a series of questions, answers and requirements for this important Animal Health Program. These requirements are part of our Bio Security Protocol Program as well as our Livestock Show Competition Handbook requirements.

Thank you in advance for your cooperation and participation in this critical program.

What disease or diseases are we vaccinating for?

Swine Influenza A and the associated virus strains of H1N1, H1N2 and H3N2.

Swine Influenza is a respiratory disease of swine caused by Type A influenza viruses. Vaccination, when done properly and according to label instructions can prevent the disease in individual swine. This prevention is particularly important when swine that originate from a wide variety of farms are eventually housed together in one location like a fair.

Why are we being required to vaccinate for Swine Influenza?

The health and welfare of your project animal should be your first concern. The Fair wants you to have a positive livestock experience. Since you have accepted the responsibility as a livestock owner, you must provide for the animal's well-being. With that responsibility also comes important health husbandry practices you must address. While this is not the only health concern for your project animal, this particular influenza has been recognized as a respiratory disease across the country that can compromise the health of both swine and humans. While a rare occurrence, the virus is transmissible from swine to humans and humans to swine. Because it is such an aggressive virus, because swine (or any animal) are stressed when brought to the Fair and away from their home farm, and finally because they are exposed to other animals that may carry the virus which make them more susceptible to sickness, it is critical that we take a proactive approach to their health. Vaccination is one proactive method that has proven effective. Proper care, good environment, appropriate diet, exercise and plenty of fresh water also protect your hog or any animal from sickness.

What is the first date I can vaccinate and what is the last day to vaccinate?

You may begin the vaccination process any time prior to June 14, 2019. It is a two-part vaccination process and it is absolutely critical that you provide the first of two vaccinations no later than June 14, 2019. *Remember you may begin earlier.* The vaccination process requires two steps taken 21 days apart.

Background: Typically, the two-part vaccination process is started by the breeder with the first vaccination given to the pig between ages 1 and 3 weeks. This early vaccination is only effective from 4-6 months for H1N1 and H1N2 and only 10 weeks for H3N2. Due to the short duration of the first vaccination's effectiveness, your hog could be susceptible as early as May

20 (approximate date). Additionally, not all breeders vaccinate their hogs for Swine Influenza and your project animal could already be at risk.

The first thing to remember is that **NO Influenza Vaccination shall be given to hogs after July 5** because of the 21-day withdrawal period requirement. It is essential that your animal's second vaccination happens no later than July 5. Any hogs who have received the second vaccination after July 5 will be disqualified and NOT allowed to be shown or sold at the Fair Auction. We have established this date based upon counting back 21 days from the Junior Auction set for July 27, 2019.

Vaccination Calendar: You may begin the vaccination process any time between May 15, 2019 and June 14, 2019. This is when you give the "first dose" of the injectable vaccine. This is followed up 21 days later by a second dose. Please do not wait until June 14 to begin this process.

Example: First dose is given June 1, 2019 and the second dose is given 21 days later on June 22, 2019 and your hog is now vaccinated for Fair.

What if I already vaccinated for my hog prior to May 15, 2019?

If you have vaccinated your hog based upon vaccination label instructions after your hog was four months old and you can provide evidence of purchasing and administering the approved vaccine or veterinary proof of vaccination to your leader or advisor then you have met the vaccination requirements. Remember it is a two-part vaccination process so you must prove that both vaccinations were given 21 days apart.

I don't know how to give a shot. Can someone do this for me?

Yes! Please make arrangements with your leader, instructor, veterinarian, breeder or other experienced person to give your hog the vaccine. You must provide proof of doing so with a proof of vaccine purchase or veterinary verification to your leader or advisor to qualify for entry to the Fair.

Is there a central location in the County that I may bring my show pig to by trailer to be vaccinated by a veterinarian or breeder?

Yes! Mr. Chris Slater of Salinas River Genetics, our Swine Superintendent, will be holding a vaccination clinic at **Premier Ag in Paso Robles on May 25, 2019** from 8:30 am-2:30 pm and will personally provide the first of the two vaccinations on that day. A small fee of \$1.50 per shot will be charged and you will receive a written verification of the first vaccination. This written verification must be provided to your leader/instructor to meet the entry requirements for the Fair. The required RSVP for a time slot can be requested by contacting Chris via email or phone (805) 550-7431. Exhibitors are responsible for transporting their animal to and from the clinic.

Don't forget: A second vaccination is required 21 days later or you are not qualified to enter the Fair. Chris will provide a follow-up clinic for exhibitors to receive the second vaccination on June 15, 2019 at Premier Ag from 8:30 pm-2:30 pm. Reservations are also required for this second clinic.

What if I can provide proof that my breeder provided the first vaccination for my Hog?

That makes your process easier because if you provide that proof in writing to your Leader/Advisor then you are only required to vaccinate one time between May 15, 2019 and July 4, 2019. The first shot must have been given prior to March 15, 2019 by your breeder. This second shot is known as a booster shot. Do not wait until July 4 since this is a holiday and it will

be difficult to provide verification to your Leader/Advisor during the holiday week. **Please plan ahead.**

What are the approved vaccines available for purchase?

The following vaccine products are available:

1. FluSure XP Vaccine (killed virus manufactured by Zoetis): Requires two injectable doses (2 ml each) and 21 days apart. Intramuscular shot.
2. FluSure XP/RespiSure-ONE Swine Vaccine (manufactured by Zoetis): Requires two injectable doses (2 ml each) and 21 days apart. Intramuscular shot.
3. Other option - Ingelvac Provenza MLV (Nasal) manufactured by Boehringer Ingelheim: 1 ml dose is given through the nasal cavity. Because of the difficulty in administering this product it is only recommended if given by a Veterinarian or highly experienced swine specialist.

Costs for these vaccines vary from \$48.00 per bottle to \$80.00 per bottle. Bottles come in 50 doses up to 250 doses per bottle. It is recommended that your club or chapter purchase the bottle so that the cost to individual members is greatly reduced.

These vaccines are not always available in stock so plan early and do not wait until the last minute.

Note: All these vaccines must be mixed with the sterile diluent provided in the box of vaccine. After mixing you only have two hours to administer the product so plan accordingly. You will need to purchase syringes and needles separately. ALWAYS FOLLOW AND READ LABEL INSTRUCTIONS.

Where are the vaccines available for purchase?

Note: Allow at least one week to 10 days for delivery. Plan ahead to save!

What are the vaccination verification requirements to qualify my hog to come to the Fair?

For Exhibitors: Your 4-H Leader or FFA Advisor MUST verify in writing to the Fair that you, your breeder or your representative have vaccinated your hog according to Fair requirements and vaccine label instructions. Your Leader/Advisor must provide your name, the hog's ear notches and DNA Fair tag number as required by the Fair along with the name of the vaccine. Work directly with your leader/advisor to provide such proof. Your Leader/Advisor will compile a single list for the Fair of all exhibitors with hogs from your club/chapter. Upon arriving at the Fair with your hog, such proof (provided to you as a list from your Leader/Advisor) is required to be presented to swine officials on arrival day and before unloading your hog. Your name must appear on that list. You must provide that proof of vaccination no later than July 5, 2019 to your

Leader /Advisor or you are not eligible to bring your hog to the Fair. Independent Youth must have their Parent or Legal Guardian provide this proof to the Fair in writing with proof of purchase and vaccination of the approved vaccine.

For 4-H Leaders/FFA Advisors: A single comprehensive list of each club/chapter of swine exhibitors which provides proof of purchase of approved vaccines and that they were administered appropriately and timely for each exhibitor must be provided to the Fair. This list must be signed by the Leader/Advisor and must include exhibitor's name, vaccine used, official DNA Ear tag number and ear notch for each exhibitor. **This signed list is due to the Livestock Department no later than 5:00 pm on Monday, July 15, 2019.** An official form will be provided to Leaders/Advisors by Fair officials.

Finally, provide this list to each of your exhibitors for them to bring to the Fair in order to unload their animal. It is recommended that you have plenty of extra copies on arrival day.
