
MODIFIED NOTICE OF FINAL JUDGMENT

This notice is addressed to the people who are members of the class action instituted by Rudy Caufriez and Matteo Marasco against the Festival Métropolitain pour la Musique Urbaine (**«Festival»**) in the case **500-06-000980-199** at the Superior Court in the district of Montreal:

All individuals who purchased a ticket through the website metrometro.electrostub.com for the Festival Metro Metro held on May 18th and 19th, 2019 and who had to obligatorily pay an additional amount for service and delivery fees.

Class

All Québec consumers who purchased a ticket (*Weekend Pass – General Admission or Gold VIP*) through the website metrometro.electrostub.com for the Festival Metro Metro to be held on May 18th and 19th, 2019;

« Additional fees » Subclass

All Québec consumers who purchased a ticket (*Weekend Pass – General Admission or Gold VIP*) through the website metrometro.electrostub.com for the Festival Metro Metro to be held on May 18th and 19th, 2019 and who were obligated to pay an additional amount for service and delivery fees;

« Increased price » Subclass

All Québec consumers who purchased a ticket (*Weekend Pass – General Admission or Gold VIP*) through the website metrometro.electrostub.com for the Festival Metro Metro to be held on May 18th and 19th, 2019 and who paid a price higher than the initial advertised price of \$ 170;

PLEASE NOTE that on January 15, 2020, the Superior Court approved the Transaction that the parties concluded in order to settle the class action.

PLEASE NOTE that on March 31st 2020, the Superior Court approved the Festival's request to modify the method of payment for reimbursements.

SUMMARY OF THE SETTLEMENT

The settlement provides for the payment, without admission of liability, of an amount of amount of **\$ 20** per Week-end Pass purchased at the advertised price of \$ 170 and an amount of **\$ 35** per VIP Pass purchased at the advertised price of \$ 300.

REFUND

If you are a class member and purchased a Week-end pass at the advertised price of \$ 170 or a VIP Pass at the advertised price of \$ 300, you will automatically receive the payment indicated above. **You do not have any further steps to take.**

The Defendant will proceed to refund the class members group [...] within a period of three (3) weeks from the end of the state of emergency decreed by the government of Quebec by sending a check sent to the postal address that you provided during the purchase of your tickets.
