

Terms of Service

Effective Date: 6 Sep 2024

1. Introduction Welcome to Mindflow Mate (“we,” “us,” or “our”). These Terms of Service (“Terms”) govern your use of our mobile application and its related services (“App”). By downloading, installing, or using the App, you agree to be bound by these Terms. If you do not agree to these Terms, do not use the App.

2. Acknowledgment

You acknowledge that this End User License Agreement (EULA) is concluded between you and Mindflow Mate, not Apple. Mindflow Mate, as the developer and owner of the app, is solely responsible for the App and its content. Apple is not responsible for any failures of the App, nor for providing any maintenance, support, or warranty services. In the event of any issues with the App, you should contact Mindflow Mate directly. Apple will not be liable for any claims, losses, or damages arising from the use of the App, except as specified in Apple’s refund policy.

3. Eligibility By using the App, you affirm that you are at least 13 years old or have the consent of a parent or legal guardian. If you are under the legal age, you may only use the App under the supervision of a parent or legal guardian who agrees to these Terms.

4. Subscriptions and Payments Some features of the App may require a subscription. If you choose to subscribe, you agree to pay the applicable subscription fees. Subscriptions are billed on a monthly/quarterly basis and automatically renew unless canceled. You may cancel your subscription at any time by following default Apple subscriptions management process, but no refunds will be given for any unused portion of the subscription period.

5. License We grant you a limited, non-exclusive, non-transferable, revocable license to use the App for personal, non-commercial purposes in accordance with these Terms. You agree not to:

- Modify, distribute, or reproduce the App.
- Reverse engineer, decompile, or disassemble the App.
- Use the App for any illegal purpose or in violation of any applicable law.

6. User Conduct You agree not to use the App to:

- Post or transmit any content that is unlawful, harmful, threatening, abusive, harassing, defamatory, or otherwise objectionable.
- Engage in any activity that interferes with or disrupts the App or its services.
- Attempt to gain unauthorized access to any portion of the App, other users’ accounts, or related systems.

7. Intellectual Property All content, trademarks, logos, and other intellectual property available on the App are owned by Mindflow Mate or its licensors. You may not use any intellectual property for commercial purposes without express written permission.

8. Third-Party Services The App may integrate with or link to third-party services, websites, or applications. We are not responsible for the content or services provided by third-party services and recommend that you review their terms and privacy policies.

11. Termination We may suspend or terminate your access to the App at any time without notice for any reason, including if you breach these Terms. Upon termination, all rights and licenses granted to you will immediately cease.

12. Changes to the Terms We reserve the right to modify these Terms at any time. If we make significant changes, we will notify you by posting the updated Terms within the App. Your continued use of the App after the changes take effect constitutes your acceptance of the updated Terms.

13. Governing Law These Terms are governed by and construed in accordance with the laws of Ukraine. Any disputes arising from these Terms will be resolved in the courts of Ukraine. You represent and warrant that you are not located in a country that is subject to a U.S. Government embargo or that has been designated by the U.S. Government as a “terrorist supporting” country, and you are not listed on any U.S. Government list of prohibited or restricted parties.

All actions you take based on the content are solely your responsibility.
