

TERMS OF SERVICE

1. GENERAL

In terms of Information Technology statutes, this document is an electronic record. Being generated by a computer system it does not require any physical or digital signatures.

This document is published in accordance with the provisions of Information Technology regulations that require publishing the rules and regulations, privacy policy and Terms of Use for access or usage of:

- (a) You must read, agree with and accept all of the terms and conditions contained in this Agreement in order to use our Website located at www.EventsHigh.com (the "Website") and related software and services (collectively with the Site, the "EventsHigh Platform")
- (b) The Website www.EventsHigh.com (hereinafter referred to as "EventsHigh "), owned by **Njuta Technologies Private Limited** where such expression shall, unless repugnant to the context thereof, be deemed to include its respective legal heirs, representatives, administrators, permitted successors and assigns;
- (c) By using the Website, You accept and agree to be bound by this Agreement, the Privacy Policy, as well as rules, guidelines, policies, terms and conditions applicable to any service that is provided by this Website, that shall be deemed to be incorporated into this Terms of Use and shall be considered as part and parcel of this Terms of Use.

Your use of this Website is evidence that You have read and agreed to be contractually bound by these Terms of Service and our Privacy Policy. Please read both carefully. The use of this Website by You is governed by this policy and any policy so mentioned by terms of reference. If you do not agree with any of these terms, please discontinue using the Website.

- (d) We hold the sole right to modify the Terms of Service without prior permission from You or providing notice to You. The relationship creates on You a duty to periodically check the Terms of Service and stay updated on its requirements. If You continue to use the Website or avail any of its services without registration following such change, this is deemed as consent by You to the so amended policies. Your continued use of the Website is conditioned upon your compliance with the Terms of

Service, including but not limited to compliance with the Terms of Service even after alterations, if any.

2 DEFINITIONS

- a. **"We", "Us", "Our", "EventsHigh Platform"** shall mean EventsHigh the Website/the portal or the Company .
- b. **"Agreement"** shall mean and refer to this Terms of Service, including any amendments that may be incorporated into it.
- c. **"You" or "User"** shall mean any natural or legal person who has agreed to become a user of the EventsHigh Platform by signing up to the Website. The EventsHigh Platform also provides certain services without registration/acceptance, and such provision of services does not absolve You of this contractual relationship. This shall also include Organisers.
- d. **"Customer"** shall mean any User who shall utilize the EventsHigh Platform to request for Services to be performed by any Organiser. From time to time, EventsHigh may act as a Customer, and the terms and conditions of this Agreement applicable to Customers will apply to EventsHigh when acting in this way.
- e. **"Organiser"** means any enterprise or individual User utilizing the EventsHigh Platform to offer Services to Customers.
- f. **"Contract"** means a particular project or set of ongoing tasks for which a Customer has requested Services to be offered by a Organiser and the Organiser has offered on the EventsHigh Platform.
- g. **"Third Party"** shall mean and refer to any individual(s), enterprise or entity apart from the Users and **EventsHigh**.
- h. **"Services"** shall mean and refer to the services offered on the site including but not limited to recreational, sporting and leisure activities and communications related services.
- i. **"Organiser Fees"** means a fixed fee which will be set by the Organiser for which the customer can avail the services offered and this fee will be non-negotiable.
- j. The terms **"Party" & "Parties"** shall respectively be used to refer to the User and the Company individually and collectively, as the context so requires.

The headings of each section in this Agreement are only for the purpose of organising the various provisions under this Agreement in an orderly manner. These headings shall not be used by either party to interpret the provisions contained under them in any manner. Further, the headings have no legal or contractual value.

3 ONLINE WEBSITE PLATFORM

EventsHigh is an online platform where users can find services, which shall include, but are not limited to setting out their preferences in relation to the activities they wish to partake in and Customers can book these services or learn about these Services. The Website works on the model of listing of Organisers and enabling them to showcase their profile. The Website also has a provision for the Users to provide their ratings and reviews on the quality of services. EventsHigh is a portal where the Organisers, both agencies and freelancers will claim their own work. The Website shall take the amount as per the invoice of the event and after deducting a certain amount as commission shall give the remaining amount to the Organiser. The portal only brings together the Organisers and Customers.

The Users of the Website are also allowed to post questions or queries regarding certain events on the Platform and these questions shall be visible to the Users of the Website in general and the responses to such questions/queries shall also be public.

4 ELIGIBILITY

The User represents and warrants that he/she is competent and eligible to enter into legally binding agreements and that he/she has the requisite authority to bind himself/herself to these Terms, as determined solely by the provisions of the Indian Contract Act, 1872. The User may not use the EventsHigh Platform if he/she is not competent to contract under the Indian Contract Act, 1872, or is disqualified from doing so by any other applicable law, rule or regulation currently in force.

5 CONTENT

All information provided by Users are self-declared and not verified by EventsHigh. Any and all information posted by any User including but not limited to their photographs, videos, company name, EventsHigh has the right to use this Content for promotions or marketing purposes.

EventsHigh allows users to contribute different kinds of Content, including reviews, photos and videos. You alone are responsible for Your Content posted on the Website. The User's contributions to the Website should be unbiased and objective. EventsHigh does not and cannot review all communications or Content uploaded to the Site and is not responsible for the Content, quality, or consequences of your uploading such communications or Content. Notwithstanding the foregoing, EventsHigh shall delete/ remove/ modify/ block the content/ reviews if, the reviewer attempts to use any improper/ indecent/ abusive language or tries to defame any Organiser for private/ personal/ professional reasons.

A User shall not use the Website in any way that causes, or may be likely to cause damage or impairment to the Website or in any manner harms the Company or any other person or entity (as determined by the Company in its sole discretion) or interrupt free access to it in any way. A User

shall not use the Website to host, display, upload, post, submit, distribute, modify, publish, transmit, update or share any Content that:

- (a) belongs to another person and to which you do not have any right;
- (b) is grossly harmful, harassing, blasphemous defamatory obscene, pornographic, pedophilic, libelous, invasive of another's privacy, hateful, or racially, ethnically objectionable, disparaging, relating or encouraging money laundering or gambling, or otherwise unlawful in any manner whatever;
- (c) harms minors in any way;
- (d) infringes any patent, trademark, copyright or other proprietary rights;
- (e) violates any law for the time being in force;
- (f) deceives or misleads the addressee about the origin of such messages or communicates any information which is grossly offensive or menacing in nature;
- (g) impersonates another person;
- (h) contains software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of the Website and/or the Services or any connected network or any computer resource, or otherwise interferes with any entity's use or enjoyment of the Website and/or the Services; and
- (i) threatens the unity, integrity, defence, security or sovereignty of India, friendly relations with foreign states, or public order or causes incitement to the commission of any cognizable offence or prevents investigation of any offence or is insults any other nation;
- (j) is posted for any fraudulent purpose.

The User acknowledges and agrees that EventsHigh may use, reproduce, modify, adapt, publish, translate, create derivative works from, distribute, perform and display any or all photographs, audio, video and text of Customer obtained through the Platform(s) to create marketing materials (collectively, "Content"), in whole or in part, in any manner or media as EventsHigh sees fit. Content related to business photos and videos should be broadly relevant to the business and reflect the typical consumer experience (e.g., what the business looks like, what the business offers, etc.). If You post a photo or video that showcases a more unique personal experience with a business, We may remove it from the photo gallery for the business, but it still may appear alongside Your review if you write one about the business.

Guidelines for uploading photos and videos:

- All User photos and videos should be broadly relevant to the Service and reflect the typical consumer experience (e.g, what the Service looks like, what the User offers, etc.).
- If You post a photo or video that showcases a more unique personal experience with a business (e.g., your smiling group of friends at the bar, the fly in your soup), We may remove it from the photo gallery for the business, but it still may appear alongside Your review if You write one about the business.
- Photos, Videos and depicting of imagery showing violence, drug use, nudity, near nudity, or suggestive acts shall not be uploaded. The Website shall delete any such Content.
- Users shall not use their videos to disparage other businesses. Also Users shall not request or solicit reviews from other Users or respond to User reviews.

EventsHigh reserves the right to delete, remove, modify refuse to accept or edit any communication or Content that it may determine, in its sole discretion, violates or may violate this Agreement, the intellectual or proprietary rights of others, any of its policies or is otherwise unacceptable in its discretion, and you hereby agree to forfeit any fees payable in respect of such Content to EventsHigh or as it may direct.

6 REGISTRATION

To fully avail the services of the Website and use it, registration is required. Users can register on the Website either as Customers or as Organisers and can also register themselves using their Facebook account. The Organisers shall upload their team, work and Customer profile after registration. EventsHigh shall approve the Users detailed profile after basic scrutiny of the Content and pictures. The Website, however, does not guarantee the authenticity of the claim of the work. The professionals seeking to provide reviews and ratings can do so only after their registration. One can register themselves on the Website by providing their username, email, password, first name and last name or may register using their social account.

Notwithstanding the aforesaid, an individual can visit the Website however to avail such service proper registration is required.

Membership of this Website is available only to those above the age of 18 years. barring those “Incompetent to Contract” which *inter alia* include insolvents. If You are a minor and wish to use the Website, You may do so through Your legal guardian and EventsHigh reserves the right to terminate Your account on knowledge of You being a minor and having registered on the Website or availing any of its services.

All information provided by the User, Customers and Organiser must be true, accurate and complete. EventsHigh reserves the right (but has no obligation) to verify any and all information provided on a

User's profile. By registering on the EventsHigh Platform, the User is attesting that he/she/it has the skills and ability to perform the requested Services by the deadline stated in the job posting or agreed upon.

The User is solely responsible for ensuring and maintaining the secrecy and security of his/her EventsHigh account password. The User agrees not to disclose this password to any third party and shall be solely responsible for any use of or action taken through the use of such password on EventsHigh.

7 TERM

These Terms shall continue to form a valid and binding contract between the Parties, and shall continue to be in full force and effect until the User continues to access and use the EventsHigh Platform. The Parties agree that certain portions of these Terms (“**Sections**”), such as **Sections 15, 16, 17, 18, 19& 23, 24, 27** shall continue to remain in full force and effect indefinitely.

8 TERMINATION

EventsHigh reserves the right, in its sole discretion, to unilaterally terminate the User’s access to the products and services offered on the EventsHigh Platform , or any portion thereof, at any time, without notice or cause. The User shall continue to be bound by these Terms, and it is expressly agreed to by the Parties that the User shall not have the right to terminate these Terms till the expiry of the same, as described in the Clause hereinabove.

Either party may terminate the Agreement at any time, with or without cause, effective immediately upon written notice to the other party (or by terminating or suspending User’s account), provided, that any such termination for convenience shall not affect the validity of any agreements that have been executed prior to termination and this Agreement with Organisers shall continue to apply with respect to such agreements.

9 COMMUNICATIONS

By using the EventsHigh Platform, it is deemed that You have consented to receiving telephonic calls, SMSs and/or emails from EventsHigh at any time it deems fit. We, at EventsHigh, shall reach out to communicate with you and enhance your experience while using the platform. We shall also inform you about the new services offered by us. Such communications shall be sent to You on the telephone number and/or email id provided by You for the use of the EventsHigh Platform which are subject to our Privacy Policy. These communications include, but are not limited to contacting you through information received from Third Parties. Such communications by Us is for purposes that *inter alia* include clarification calls, marketing calls and promotional calls.

You may also be contacted by Organisers with whom we have entered into a contract in furtherance of our rights, duties and obligations under this document and other policies followed by Us and with whom you have become acquaintances with from the EventsHigh Platform. Such contact shall be made only in pursuance of such objectives and services and no other calls shall be made. In addition, You may also be contacted by Third Parties who may have access to the information disclosed by You or to whom We may have disclosed Your information for purposes such as, but not limited to statistical compilations.

The sharing of the information provided by You shall be governed by our Privacy Policy.

10 PAYMENT TERMS AND CHARGES

Each User understands and agrees that:

- EventsHigh shall charge commission. Moreover, EventsHigh is not a party to the fee being finalised between Organisers and their Customers.
- EventsHigh can earn revenues from Customers and Organisers through sponsorship and advertisements.
- In the event of any dispute regarding the amounts held by EventsHigh, We shall have the right (in addition to all other rights it may have) to deposit all funds held pursuant to this Agreement in the courts of Bangalore, Karnataka
- All Fees paid to EventsHigh are refundable for the services rendered which shall be governed by the refund policy at [https://www.eventshigh.com/assets/files/Cancellation_and_Refund - _Eventshigh3.docx.pdf](https://www.eventshigh.com/assets/files/Cancellation_and_Refund_-_Eventshigh3.docx.pdf).
- We reserve the right to amend the fee policy and charge for all the services which the EventsHigh Platform offers. In the event of such change in policy, Users shall be intimated of the same via email/telephone and such change shall be effective as soon as Users have been intimated. Subsequent to such change, it is the choice of the User whether or not to continue with the services offered by Us.

11 SECURITY

Transactions on the EventsHigh Platform are secure and protected. Any information entered by the User when transacting on the EventsHigh Platform is encrypted to protect the User against unintentional disclosure to third parties. The User's credit and debit card information is not received, stored by or retained by the Platform in any manner. This information is supplied by the User directly to the relevant payment gateway which is authorized to handle the information provided, and is compliant with the regulations and requirements of various banks and institutions and payment franchisees that it is associated with.

12 TAXES

The User takes full responsibility for payment of all taxes and fees that are levied or arise in the course of use of the Platform.

13 USER'S OBLIGATIONS

The User undertakes to fulfil the following obligations. Failure to satisfy any of these obligations gives Us the right to permanently suspend Your account and/or claim damages for any losses that accrue to Us or additional costs that may be imposed on us.

- You hereby certify that you are at least 18 years of age.
- You hereby agree to provide genuine credentials during the process of registration for the Platform. You shall not use a fictitious identity to register.
- You agree that any Content posted by shall be unbiased and objective. You must also ensure that your contributions to the Website are relevant and appropriate to the Website. You alone are responsible for Your Content.
- You agree not to publicize other User's private information without their consent. Such private information shall include but not be limited to close-up photos or videos, other User's full names and address.
- You agree to ensure the email address and mobile number provided in your account registration is valid at all times and shall keep your contact information accurate and up-to-date.
- You agree that you are solely responsible for maintaining the confidentiality of your account password. You agree to notify us immediately of any unauthorized use of your account. We reserve the right to close your account at any time for any or no reason.
- You agree to comply with all local laws and regulations governing the downloading, installation and/or use of the the EventsHigh Platform, including, without limitation to, any usage rules set forth in this Agreement.
- You agree that all Service Contracts between any Customer and Organiser shall name EventsHigh as an express third party beneficiary under the Service Contract (but not as a party to that agreement).
- You agree to make no representations or warranties or enter into any contracts on behalf of EventsHigh. Customer and Organiser may agree to additional terms in their Service Contract materially different than the standard terms; however, nothing in such Service Contract will in any way limit or modify EventsHigh's rights.

- You recognize, acknowledge and agree that You are not an employee of EventsHigh and that EventsHigh does not, in any way, supervise, direct, or control Your work or Services. However the employees of EventsHigh can also be Users;
- You undertake not to:
 - Cut, copy, distribute, modify, recreate, reverse engineer, distribute, disseminate, post, publish or create derivative works from, transfer, or sell any information or software obtained from the EventsHigh Platform. For the removal of doubt, it is clarified that unlimited or wholesale reproduction, copying of the Content for commercial or non-commercial purposes and unwarranted modification of data and information within the Content of the Website is not permitted. Should You want to engage in one or more such actions, prior permission from EventsHigh must be obtained;
 - Access (or attempt to access) the EventsHigh Platform and/or the materials or Services by any means other than through the interface that is provided by the EventsHigh Platform. The use of deep-link, robot, spider or other automatic device, program, algorithm or methodology, or any similar or equivalent manual process, to access, acquire, copy or monitor any portion of the EventsHigh Platform or Content, or in any way reproduce or circumvent the navigational structure or presentation of the EventsHigh Platform, materials or any Content, to obtain or attempt to obtain any materials, documents or information through any means not specifically made available through the EventsHigh Platform is prohibited. You acknowledge and agree that by accessing or using the Platform, You may be exposed to Content from other Users or Third Parties that You may consider offensive, indecent or otherwise objectionable. We disclaim all liabilities arising in relation to such offensive Content on the Platform. Further, You may report such offensive Content;
 - Use the EventsHigh Platform in any manner that may impair, overburden, damage, disable or otherwise compromise (i) Company's services; (ii) any other party's use and enjoyment of the Company's services; or (iii) the services and products of any Third Party (including, without limitation to, the Authorized Device);
 - use the Services or Materials for any unlawful purposes or to conduct any unlawful activity, including, but not limited to, fraud, embezzlement, money laundering or identity theft;
 - abuse, harass, threaten, defame, disillusion, erode, abrogate, demean or otherwise violate the legal rights of others;
 - engage in any activity that interferes with or disrupts access to the EventsHigh Platform or the Services (or the servers and networks which are connected to the Website);

- upload or distribute files that contain viruses, corrupted files, or any other similar software or programs that may damage the operation of the EventsHigh Platform;
 - Download any file posted in the EventsHigh Platform that you know, or reasonably should know, cannot be legally distributed in such manner;
 - Probe, scan or test the vulnerability of the EventsHigh Platform or any network, devices and software solutions to the EventsHigh Platform, nor breach the security or authentication measures on the EventsHigh Platform or any network, devices and software solutions connected to the EventsHigh Platform. You may not reverse look-up, trace or seek to trace any information on any other user, of or visitor to, the EventsHigh Platform, or exploit the EventsHigh Platform or Service or information made available or offered by or through the EventsHigh Platform, in any way whether or not the purpose is to reveal any information, including but not limited to personal identification information, other than Your own information, as provided for by the EventsHigh Platform;
 - Disrupt or interfere with the security of, or otherwise cause harm to, the EventsHigh Platform, systems resources, servers, software solutions or networks connected to or accessible through the EventsHigh Platform or any affiliated or linked Websites;
 - Use the EventsHigh Platform or any material or Content for any purpose that is unlawful or prohibited by these Terms of Use, or to solicit the performance of any illegal activity or other activity which infringes the rights of this Website or other Third Parties;
 - Violate any applicable laws or regulations for the time being in force within or outside your home country;
 - Violate any code of conduct or other guidelines, which may be applicable for or to any particular Service;
 - Threaten the unity, integrity, defence, security or sovereignty of your home country, friendly relations with foreign states, or public order or causes incitement to the commission of any cognizable offence or prevents investigation of any offence or is insulting any other nation;
 - disseminate information through the EventsHigh platform that is false, inaccurate or misleading or violate any applicable laws or regulations for the time being in force in or outside your home country.
- Customers agree to respond promptly to communications with and requests for information from the Organiser.
 - The Organiser is responsible for providing all tools and resources necessary to complete the Contract, unless explicitly stated in advance by the Customer. Organisers agree to respond to

all Customer communications and requests for information within one business day. If the Organiser will be unable to meet this requirement due to an absence, he is expected to notify the Customer at least 2 weeks prior. After the completion of a Contract, the Organiser can provide timely, honest and objective feedback on the Customer.

14 CONFIDENTIAL INFORMATION

Confidential Information shall mean any information disclosed by the Customer on the Platform, related to the project. However, Confidential Information shall not include information that: (a) is now or subsequently becomes publicly known through no wrongful act or omission of the Organisers or anyone to whom it discloses such information; (b) the Organisers can demonstrate by its written records to have had rightfully in the Customers possession, free of restriction, prior to the date of this Agreement; (c) the Organisers can demonstrate by its written records to have obtained on or after the date of this Agreement, rightfully and free of restriction, from a third party who has the right to transfer or disclose it, provided that it was not acquired, directly or indirectly, from the Customer; (d) the Organisers can demonstrate by its written records to have been independently developed.

All Organisers using the EventsHigh Platform acknowledge that certain information disclosed by Customer may be confidential and, if so, must be protected. All Confidential Information and its embodiments and derivatives shall remain the sole and exclusive property of the Customer and no license or other right with respect to Confidential Information is granted or implied hereby.

15 REPRESENTATIONS AND DISCLAIMER OF WARRANTIES

- a) Except as otherwise expressly stated on the Website, all Services offered on the Website are offered on an "as is" basis without any warranty whatsoever, either express or implied.
- b) All commercial/contractual terms are offered by and agreed to between User and Organisers alone. EventsHigh disclaims all liability to either the Customer or the Organiser or any person claiming for any breach of the terms of the Agreement based on the ratings, reviews or the work profile of Organisers mentioned on EventsHigh portal.
- c) The Company/Website makes no representations as to the reliability, capability, or qualifications of any Organiser or the quality, security or legality of any Services and EventsHigh disclaims any and all liability relating thereto. The Company/Website does not implicitly or explicitly support or endorse the procurement of any Service on the Website.
- d) The User agrees and undertakes that he/she is accessing the Website and transacting at his/her sole risk and that he/she is using his/her best and prudent judgment before availing any Services listed on the Website, or accessing/using any information displayed thereon.

- e) The Website and the Company accepts no liability for any errors or omissions, whether on behalf of itself, any Organisers or third parties, or for any damage caused to the User, the User's belongings, or any third party, resulting from the use or misuse of any Product purchased or service availed of by the User from the Website.
- f) The Company/Website does not guarantee that the functions and services contained in the Website will be uninterrupted or error-free, or that the Website or its server will be free of viruses or other harmful components, and the User hereby expressly accepts any and all associated risks involved with the User's use of the Website.
- g) It is further agreed to by the Parties that the Contents of this Section shall survive even after the termination or expiry of the Terms and/or Policy.

16 LIMITATION OF LIABILITY

EventsHigh accepts no liability for any errors or omissions, whether on behalf of itself or third parties, or for any damage caused to the User, the User's belongings, or any third party, resulting from the use or misuse of any product purchased or service availed of by the User from the EventsHigh Platform.

Users may be held legally responsible for damages suffered by other Users, EventsHigh or any third party as a result of legally actionable or defamatory comments, remarks, or other information or Content posted to the EventsHigh Platform. All Customers and Organisers are to comply with all laws applicable to them or to their activities, and with all posted EventsHigh Policies, which are hereby incorporated into this Agreement by reference. 17 INTELLECTUAL PROPERTY RIGHTS

- (a) All information, Content, services and software displayed on, transmitted through, or used in connection with the EventsHigh Platform, including for example news articles, reviews, directories, guides, text, photographs, images, illustrations, audio clips, video, html, source and object code, trademarks, logos, and the like (collectively and hereinafter referred to as the

You may not distribute any Content to others, whether or not for payment or other consideration, and you may not modify, copy, frame, cache, reproduce, sell, publish, transmit, display or otherwise use any portion of the Content. You may not scrape or otherwise copy our Content without permission. You agree not to decompile, reverse engineer or disassemble any software or other products or processes accessible through the EventsHigh Platform, not to insert any code or product or manipulate the Content of the EventsHigh Platform in any way that affects the user's experience, and not to use any data mining, data gathering or extraction method.

18 INTELLECTUAL PROPERTY COMPLAINTS

- (a) We respect the intellectual property of others. If You believe Your work has been copied in a way that constitutes infringement or are aware of any infringing material on the EventsHigh Platform, please email us at support@eventshigh.com
- (b) By providing information to, communicating with, and/or placing material on, the EventsHigh Platform, including for example but not limited to, communication during any registration and communication on the bulletin board, message or chat area, You represent and warrant:
- You own or otherwise have all necessary rights to the Content you provide and the rights to use it as provided in this Terms of Service;
 - all information You provide is true, accurate, current and complete, and does not violate these Terms of Service; and,
 - the information and Content shall not cause injury to any person or entity. Using a name other than your own legal name is prohibited (except in those specific areas of the EventsHigh Platform that specifically ask for unique, fictitious names such as, *inter alia* certain message boards and chat rooms).

14.1 Stage 1: Mediation. In case of a dispute, the matter will first be attempted to be resolved by a sole mediator who is a neutral third party and will be selected at the mutual acceptance of a proposed mediator by both parties. Both parties may raise a name for the sole mediator and in the case both parties accept the proposed name, the said person shall be appointed as sole mediator. In case the parties are not able to reach a consensus within two proposed mediators, the sole proprietorship reserves the right to decide who the final mediator is. The decision of the mediator is not binding on both parties.

14.2 Stage 2: Arbitration. If the dispute is not settled by mediation, it shall be referred to and finally resolved by arbitration, which shall be governed by the law, rules and regulations of

Bangalore, India. The Arbitral award is binding on both parties. The Arbitration Board shall comprise three members – one appointed by each party and the third member to be nominated by the two appointed members by mutual consent. Arbitration shall be held at Bangalore. The proceedings of arbitration shall be in the English language. The arbitrator's award shall be final and binding on the Parties. The exclusive jurisdiction and venue for actions and disputes mentioned above shall be the courts located in Bengaluru, Karnataka, India and You hereby submit to the personal jurisdiction of such courts.
