#### MINUTES

Present Members: Justino Cruz, Rafael Ortega, Roberto Reyna, Hilda Sanchez-Henke, and Fr. Ray Monsour.

Meeting with Bishop Richard Ham, Vicar for Hispanics and Peter D'Heilly, Director of the Outreach Division.

\*\*One of the purposes of this meeting was to discuss what issues and tensions have surfaced during this year of transition for the Hispanic Ministry Office and the Board from the previous to the current administration of the office.

Some of the issues that were raised by the members were:

- Not having enough members in the board and that last year because of that reason many meetings were called and cancelled since a quorum of 6 members was needed in order to make decisions.
- Present members went thru the process of calling competant people to join the board and are still waiting for the Archbishop's approval in order to do follow up and get going.
- Frustration was expressed for the time that the office was without a director, "while waiting for replacement."

Some of the tensions that developed during this year of transition were:

- After Lupe Serrano's resignation as Hispanic Ministry Director, a number of board members also resigned from the board.
- Selection of the Nomination Committee for the new director seemed exclusive
- The board members not being informed of what procedure or the selection of the director
- Transition of director and board members happened when the III Encuentro was in process. However, the Diocesan Promotional Team from the III Encuentro Process asked that something be done about a new director
- $\boldsymbol{\mathsf{-}}$  This 7 months of transition has been a learning process for the two new people in the office

\*\*What is the relationship between RENEW, the Hispanic Community and the III Encuentro Process?

- The Hispanic Community is just awakening to the III Encuentro now they have to learn Renew and intergrate it into the Encuentro Process
- The follow-up to Encuentro Process calls for building Ecclesial Base Communities. Renew will be a vehicle for this.

#### Report on Retreat

The members shared their contentment about the retreat 9/20/86. They felt that the facilitation of Sr. Elisa Rodriguez was excellent. The first draft of the Plan of Action that came out during the retreat was used by the Goals and Objectives committee during their meeting when they planned the goals for 1987/88 fiscal year.

#### Update on Goals and Objectives

The Goals and Objectives committee met with Sr. Consuelo Monday, November 10, 1986 They reviewed the job description with the changes that the Search Committee made as it was prioritized for the Personnel Department. The 1987/88 program objectives were worked and pulled out of the Plan of Action that the Board Members worked in their retreat 9/20/86. Some questions and suggestions were made by the members. Changes will be made before is presented to Peter D'Heilly and the Allocation Committee.

#### Update on Search Committee

The process has moved slowly, since a more concrete job description and Plan of Action were requested by Fr. Michael O'Connell and Peter D'Heilly before the Search Committe could continue the process.

One of the members will contact Mert Lassonde, Special Assistance to the Archbishop and Bishop Ham and try to get some time aside for the interviews with the candidates that will be recomended by the Search Committee Members.

Sr. Consuelo who worked as Co-director with Virginia Rodriguez and is presently the Acting Director, will not be applying for the job as director. She offered the Board Members that she could be facilitator/advisor in the search for a new director. A motion was made by Carl Valdez that Sr. Consuelo be able to participate as advisor to the Search Committee, not decision maker. The motion was seconded by Tom Sanchez, motion was carried unanimously. Steps in the Search are as follows:

- 1. The job notice will be sent out.
- 2. The Search committee will meet to review the applications.
- 3. They will make a selection of 3 top candidates.
- 4. The 3 candidates will be interview by the Search Committe members.
- 5. The Search Committee members will make a decision of two candidates that will be referred to Bishop Richard Ham and Archbishop John Roach for an interview and final decision.

#### By-Laws Committee

Some changes and additions were reported by Elsa Vega-Perez. The new amended by-laws will be presented to the members on their next meeting 12/4/86. If is approved by the members, a original copy with corrections will be signed by the Ex. Director and the elected Chair-person. (see old and new copy with changes enclosed)

- a plan of action for the Office of Hispanic Ministry
- the needs of constituencies within the Hispanic community as these are communicated to the Board or as these are forwarded to the Board by means of direct solicitation
- periodic evaluation of the performance of the personnel of the Office of Hispanic Ministry
- in the event of a vacany and following an approved search process, the Board will recommend to the Archbishop the names of no more than three qualified candidates for the position of director of the Office of Hispanic Ministry.

The Board also serves in an advisory capacity to the Office of Hispanic Ministry as regards the following:

- the goals and objectives of the office
- the priorities, plans and work of the office
- the sentiments of members of the Hispanic community regarding the goals, objectives, plans and performance of the office
- the conduct of Hispanic ministry by the personnel of the office and their performance of their duties as specified in appropriate documents.

While advisory to the Office of the Archbishop, the Board operates through the established archdiocesan structure, including:

- the Director of the Office of Hispanic Ministry
- the Director of the Division of Outreach
- the Moderator of the Curia
- the Episcopal Vicar for Hispanics





#### Renew Report - Irene Gomez-Bethke

The Minneapolis community met as a large group at the Ascension Club House and elected Irene Gomez-Bethke and Hugo Artola as Co-coordinators. Chairpersons were appointed for large group, small group, special events, telephone, home visitation, and publicity. A calendar of meetings to occur on the 1st Saturday

of the month at the Ascension Club was developed and implemented.

Outreach was done thru a variety of strategies telephone, mailings, and home visits as well as recruiting at Sunday Masses.

Mass attendance at Ascension has had a steady growth and masses were expanded to include Holy Rosary on the South side. An evaluation was held on the Renew process and a list of strength and weaknesses were identified and is on file at the Hispanic Ministry Office. The same calendar will be initiated for 1987. The Hispanic Ministry Office is to send out the calendar with meeting place, dates and times to 1987 participants.

## Renew St. Paul - Eustolio Benavidez

There are 16 groups meeting at Our Lady of Guadalupe Church. Eight are in English and 8 in Spanish

## Pastoral Plan - Elsa Vega-Perez

The Ad Hoc Committee consists of Elsa, Eustolio Benavidez, Francisco Trejo, Sister Consuelo (Jose Carrera to be in place of Sister Consuelo). The committee met and reviewed a series of documents that are the basis for the Pastoral Plan, they include the recommendations from this Archdiocese, the regional and National Encuentros, as well as the 1st State Encuentro. They have drafted or will draft an outline of the plan of their next meeting.

#### Immigration report - Carlos Mariani

Was tabled, however, there was a fact sheet in Spanish, included in the board packet. Discussion surfaced on: 1. The immigration bill and some of the impact on Hispanics 2. The "English Only Bill". There is a national trend to push this bill, and there has emerged. A Minnesota Senator that will author/carry this bill in the legislature. Could be retrenchment on all bills passed to help bilingual education, voter rights, etc. Irene moved that the Hispanic Ministry Advisory Board go on record as being opposed to the English only bill and that by March 6th a letter be drafted and sent to the proper agents attesting to our position. Seconded by Elsa Vega-Perez. Motion passed. Elsa suggested to the director to get in contact with the SSAC for help. They have fact sheets, names, etc.

#### Prison Ministy - Justino Cruz

Everything at this time seems to be going well, but could be better. The old chaplain was a strong supporter of our efforts; however, the new one appears to be not as enthusiastic. Probably due to being new. There are definite parameters for us and the wardens are strict in enforcing them. They are clear on that. They only want one on one counseling, and that is to be done by a professional. Various groups have come together to form a coalition. They meet monthly around issues of service to Hispanic inmates and their families. Goal: to have a coordinated effort to address the spiritual, emotional and economical

needs of the Hispanic inmates, both men/women and their families. Barbara McGurran is offering volunteer services as coordinator. Motion by Elsa Vega-Perez, seconded by Irene Gomez-Bethke, to send a letter of thanks to the wardens and for their continuing support of the efforts of the Prison Ministry and the Coalition. Motion carried.

## Budget - Fr. Ray Monsour

Fr. Ray, Phil Nache and Sister Consuelo presented the budget to the Archdiocesan Central Corporation. The goals and objectives of the Office were presented, followed by questions and answers. Our request was a 2.5% increase from last year - budgets for Fiscal year 85/86 86/87 and 87/88 are included in your board packet.

School of Ministry - Jose Carrera

Jose did an update on the School of Ministry and he will be meeting with the researcher and other key people to discuss the concept, development and implementation of this project.

Radio Program - Francisco Trejo

#### Immigration report - Carlos Mariani

There is a national trend to push this bill, and there has emerged. A Minnesota Senator that will author/carry this bill in the legislature. Bishop Ham spoke with Jose Carrera and informed him that such an issue was interesting, however, very difficult to achieve due to various barriers within church structure. Jose Carrera believes that this subject matter will be silent for a while but we should be prepared to deal with it any time.

Mr. Benavides presented the following serious concerns:

- a. The lack of courtesy from church hierarchy to include Hispanic Ministry on the communications with the SSAC re: Hispanic Pastoral Proposal.
- b. The lack of inclusivity with Hispanic Ministry to meet with church hierarchy to discuss the issue.
- c. The lack of community working together on this issue is the reason for

lack of support for the proposal. Jose Carrera explained that he has a meeting set with Bishop Richard Ham on May 9th to discuss and share his concerns. Eustolio moved: that we send a letter to the archbishop and a copy to Bishop Ham and to Jose Carrera expressing our displeasure with this situation and the lack of clarity of our role within the archdiocesan structure. Elsa seconded. Motion carried. 5. Pastoral Center Proposal (SSAC): No current action, Elsa will follow up with Jose Trejo. Patricia Santos Mrs. Perez was concerned that a nominee had been over-looked and asked that the board submit the name of: Ms. Yira Chicaco to be sent to the archbishop for consideration. Carl will call Ms. Chichaco immediately. Phil Nache will follow-up with nomination status by talking to Bishop Ham. 8. Executive Director Report: Jose's report was submitted in writing. Dear Archbishop Roach;

Our Lady of Guadalupe Church, a predominantly Hispanic parish within your archdiocese, was founded in the early 1930's and to our knowledge, since its founding, it has not had a priest of Mexican or Hispanic heritage assigned. As you know, the Mexican-American and Hispanic communities are predominantly Catholic and the culture, heritage and religion are closely interwoven. Unfortunately, the Archdiocese has failed to recognize the importance that this culture and traditions play in our religious lives. We sincerely believe that this concern needs to be positively addressed by the Archdiocese.

As a group of concerned citizens, we request a meeting with you in the near future to discuss the possible assignment of a Mexican or Hispanic priest in this parish. Presently, we have identified a pastor from Guadalajara, Mexico, who is willing to come to Our Lady of Guadalupe Church. Therefore, we believe it would be important to discuss the possibilities of having a Mexican or Hispanic priest assigned to this parish and we pledge our support and cooperation in this effort.

The Spanish Speaking Affairs Council is providing technical assistance in this effort. However, at this time, the Council has not taken an official position. The Council advices the governor and the legislature on the issues and concerns affecting Minnesota's Hispanic community and serves as a liaison between this community and private and public institutions.

#### ESTABLISH A

## HISPANIC CATHOLIC PASTORAL CARE IN MINNESOTA

#### BACKGROUND INFORMATION

Since the 1880's Hispanics have been an integral part of the state of Minnesota. By the 1930's, the Hispanic Community, which was predominantely Mexican-American at the time, established Our Lady of Guadalupe Church in Saint Paul's West Side. Our Lady of Guadalupe has become a religious focal point for the Hispanic Catholic community. However, to date a priest of Hispanic heritage has not been assigned to this parish.

During the Un Primer Encuentro, resolutions were introduced to have Hispanic priests assigned to the Hispanic community. This idea has been discussed for many years, but to date, it has not been implemented.

This proposal calls for the establishment of a statewide Hispanic/Catholic Pastoral Care in Minnesota. A Hispanic priest would be headquartered at Our Lady of Guadalupe and assigned to provide pastoral care and evangelism to <a href="the various Hispanic communities in Minnesota">the various Hispanic communities in Minnesota</a>. The Hispanic priest would visit the various cities throughout the state on a rotating basis and provide:

- ---Worship services
- ---Serve as a bilingual/bicultural counselor
- ---Establish liaison between the various Hispanic religious communities
- ---Visit the non-English speaking homebound and elderly and perform any other pastoral care, which could best be performed in Spanish.

#### PROGRAM STRUCTURE

The Hispanic priest will not replace any presently assigned priests in the state. The purpose of this proposal is to supplement the present pastoral care being provided to Hispanics, particularly the non-English speakers, the homebound and the elderly on a statewide basis. It is very important for individuals to understand that this proposal in no way is critical of the pastor or staff at Our Lady of Guadalupe Church, but instead is meant to provide additional resources, which are not presently available.

## **FUNDING**

In order to facilitate the implementation of this proposal, it is advisable to establish a cooperative fund-raising effort, in which the Hispanic community would be actively involved. This fundraising effort will not be successful, without the active endorsement and support of the Archbishop. The Archbishop could initiate a special appeal to fund this effort and appoint a special fundraising committee to prepare an annual budget, identify appropriate funding sources and conduct a fundraising campaign.

## DESIRED RESULTS

The individuals that would benefit the most as a result of this effort will be the non-English speakers, the homebound and the elderly. In addition, Minnesota's Catholic churches, particularly Our Lady of Guadalupe Church and churches in communities where there is a large concentration of Hispanics, will have a valuable added resource. Greater outreach would take place and the Hispanic community would be better served.

A cooperative, statewide effort, with the active involvement of the Archbishop, the Church hierarchy and staff, local priests, parishioners and interested citizens could turn this long-held dream of the Hispanic community into reality.

Mr. Trejo described a similar structure with the Winona diocese and the Albert Lea area.




