I am writing this letter to express my concern that the HRA owned building at 1800 Olson Highway be awarded to the Chicano Cultural Chicano group. The Minneapolis Chicano/Latino community desperately needs a cultural center fir its social activities, and to house agencies like Centro Cultural Chicano that provide much needed services to the community. The Chicano/Latino community is the only major ethnic group in Minneapolis that does not have a community center. It is even more significant to note that while the relatively small Vietnamese population has a community center, the largest ethnic minority in the state (Chicano/Latinos) do not have a center in Minneapolis. This is clearly a deplorable situation.

I strongly urge the HRA Board of Commissioners to award the building at 1800 Olson Highway to the Centro Cultural Chicano group. It would be a much needed "first" for the community and would indicate that the city government acknowledges the needs and concerns of Chicano/Latinos.



Dear Al:

We are writing two letters: (1) to recap today's conversation as regards the Insight Hispanic Heritage Series publication Vol. 2, No. 4 and (2) a letter of intent which may be shown to the advertisers.

Concerning the issue, we have note's concerning the following:

- (1). Centro will co-publish, with all rights of selection, editing and proofreading contributor's articles or items to be considered for publication. We will also see the galleys before they go to press.
- (2). Centro will solicit contributors and will pay these people, should there contributions be published. Centro will have around \$400.00 for these expenditures, depending on the type and length of articles of photos sumitted for publication.
- (3). Centro will be included as the co-copyrighter of this publication. For this reason, we would like additional copies to be deposited at Centro for distribution.
- (4). We hope that enough ads are solicited to pay for the publication. In the event a sizable profit is made, we hope that we could have a better cover for this issue. The cover will be in color. Also, if the advertisers want to publish in bilingual style, translators can be obtained at Centro. Ask for Willie Dominguez. Since <u>Insight</u> is subsidized, and if additional money of space is used in our edition, we would be happy to write a letter of support for your funding to HRA.
- (5). We would like to have a reporter and other staff to be on <u>Insight's</u> staff so we can have perpetual visibility and continuity in the community newspaper. Carmen Robles from Centro has expressed a desire to train for the special typist (typesetter) position.



- (6). Content material would run not less than 40% of the magazine. Willie informs us that <u>Insight</u> pays a 30% commission of ads obtained for <u>Insight</u>. In the event you have an advertiser that is interested in advertising solely for the benefit of the Hispanic community, or if ads are obtained from our sources, we would like that commission money to be used on the issue in the form of a better cover or more copies. Although the commission was not discussed, you can respond in your Letter of Agreement.
- (7). Articles may be in English, Spanish or bilingual style. The deadline date to deliver to you is August 29th.
- (8). The Publisher's note will be written by Centro.
- (9). We will expect a letter of agreement from you shortly. Irene, Marcela, Willie, and Carmen Robles are now working to solidify all aspects of the magazine. If the above differs in your recollection, please respond. Letter #2 is included and is the letter of intent that you may show to advertisers.

The dance company is presently under the direction of Juanita Meza, the General Director, Jack Bethke, the Artistic Director; Irene Gomez-Bethke, the Costume Director; and Jesse Bethke, the Choreographer and Dance Director.

El Ballets purpose is the promotion of artistic endeavor mainly in the filld of dance, oriented to the folklore of Mexico Spain, and the Southwest. The troupe expresses this purpose in set stage productions.

organization by the name of Chicano Chicano. In November of 1975, the troupe was a dance committee of Centro, the director of the dance committee was Jesse Bethke. The dance committee through Centro Cultural Chicano, obtained practice space at Coffman Hall, at the University of Minnesota. The dance committee had been practicing for two months, when a friend, Armando Estrella, invited Ted Martinez, a former member of Ballet Folklorico de Alluquerque, to join the committee.

Because of the desperate needs for social services, Centro Cultural Chinano changed its area of focus from cultural to social services. The dance committee decided that because of the complexities in presenting folkloric dances, that there was a need to become a separate entity.

In January of 1976, the committee formed into El Ballet Folklorico de Minnesota. Ted Martinez and Jesse Bethke were co-dance directors, Juanita Meza, the General Director, Jack Bethke, the artistic director and Irene Gomez-Bethke the costume director.

Also in 1976, Liz Gorrola, a bilingual music teacher, introduced the dance troupe to Associacion Nacional de Grupos Folkloricos. "A.N.G.F." is a non-profit corporation that preserves and promotes the folklore of Mexico, Spain and the Southwest through annual conferences in which leading maestros of folklore teach students of dance. El Ballet joined the membership of "A.N.G.F.", and attended the 1976 conference in Pueblo Colorado. Since then, El Ballet has had represented in Pueblo Colorado.

Besides performances in the Twin Cities area, El Ballet Champagne has performed in such places as; San Antonio Texas, Champainge Illinois, Ladysmith Wisconsin. Recently Asides participated in the 1980 Festival of Nations' Performance in Saint Paul, El Ballet was honored to perform at the President's White House Conference on Families, at the IDS tower in Minneapolis.

Dear Jesse:

I am in receipt of an article which was written by you for the 1980 Hispanic Week Issue for Insight. In objective journalism reporting, whenever an article is submitted, investigation should reveal both sides of an issue. In this instance, the editor for the Hispanic Issue of Insight requested my review of the contents of your article, and, I have, therefore, submitted the facts historically as I know them and as they have, infact, occurred.

Jesse, may I remind you that at El Ballet Folklorico de Minnesota's initial meeting on April 29, 1976--you were there, I was there--the following structure and duties for the officers were outlined and voted upon by the group as a whole:

GENERAL DIRECTOR

- -all coordinating
- -would receive, make appointments
- -authorize spending of money
- -general overall public relations
- -leader and spokesperson for the group

ARTISTIC DIRECTOR

- -in charge of costumes
 - taking care of costumes
 - making sure costumes are at each performance
- -make sure we have available necessary props for
 - dances and things like that
- -poster designing
- -would include storage of props and costumes
- -in charge of recording music
- -making tapes

DANCE DIRECTOR

- -dance instructor
- -choreographer
- -consultant
- -making programs for performances
- -as far as dancing, is going to have the word

I was nominated and elected unanimously General Director; Jack Bethke was nominated and elected unanimously Artistic Director. Ted Martinez was nominated for General Director but declined and nominated me and he continued to be Dance Director as he was obviously the dance director and the only one who was qualified for that position. If you recall, because of his committment towards his career, you were nominated and elected unanimously Assistant Artistic Director and Assistant Dance Director; you are to be commended for the work, time, and talents you have displayed in that capacity.

The purpose of this letter is to register my disapproval of the article being submitted without my consent and approval as General Director of El Ballet Folklorico de Minnesota.

Having read the article, I am concerned about the accuracy of the information contained therein. It strikes me that much of the information is inconsistent with what has actually transpired since the implementation of our organization.

I am further distressed that you did not allow me the courtesies of collaborating in the preparation of the article, especially so, since it was brought to my attention by the Editor for the Hispanic Week Issue.

Referring to the last statement in your article regarding classes starting soon under the auspices of Instituto de Arte y Cultura, I am shocked to learn that you sought to determine the group's future without any guidance or advice from those people that are involved and have worked so hard and are deserving to have a voice in the destiny of their and our organization. We are an organization in our own right, and if it is your desire to have us swallowed up by some other organization, I would expect you to bring that issue up before the entire membership of the organization.

It disturbs me to have to come to you in this manner, but these are serious concerns that merit a more reasoned approach and, above all, the input of the entire organization.

This letter is being written to you in reference to a short conversation we had on Tuesday. May 13th, cutside the Minneapolis School Board Assembly Room wherein you indicated to me a clear lack of initiative to support our Parents Advisory Board according to an agreement entered into by and between Centro Cultural Chicano and our Parents Scard (see copy of proposal enclosed herewith).

I'm referring specifically to the comment you made with regard to my presence at a meeting of the Hispanic Advisory Board to the Mayor which was beld yesterday. May that. Upon communicating to you my inability to be present at said meeting, you suggested I send a representative of our Parents' Board. I responded that I would try, but that it was very difficult requesting parents to come to our own loard meetings, at which point you suggested I ask Manuel Gusman. I told you I thought he had a meeting to attend on the day in question, but I would ask him nevertheless.

You also told me to be sure to tell as many people as I would about the scheduled meeting of the Addisory Board to the Mayor, to which I responded that you ask Willis Dominguez to take care of that matter since he had been designated as the Centro Cultural limiton to our Parents Board and as such, was charged with the responsibility of cordinating such activities. You replied that Willie was not supposed to take care of such matters — that he was responsible for seeing to matters that had to do only with meetings of our Parents Board held at Centro.

I ask you to please refer to the enclosed copy of our proposal, under Service, last item; "Coordination of planning and outreach with the Advisory." I would also refer you to the minutes of our March 24th meeting (see copy enclosed) wherein you request and received, a clarification of certain items included in our proposal (refer to page two, paragraph 3).

I feel we are once again experiencing a breakdown in our communications with Gentro, and if we can't expect the Contro Cultural staff to be responsive to our Board's needs, then we fill have no alternative but to go before Centro's Board with problems of this newere in the future.

Guzman) along with an application for membership in MINNESABE, and asked her if she would handle filling out the application and mailing it with the membership fee. Mrs. Cervantes agreed.

Mr. Guzmán askud Mr. Donn Vargas for a response to his proposal of March 13, 1980. Mr. Vargas asked for a clarification of several things such as, record-keeping, a specific date for meetings, and coordination of planning and outreach with the Advisory Board, and also asked that the Chairperson be required to work closely with the Centro staff person assigned to assist the Board; that he wanted to formalize the proposed agreement and have it signed by the Chairperson, and he also asked if it would not be better to have a member of the Board or one of the parents take minutes and type same, as Centro would make available a typewriter for the Board's use. He also asked if there would be a permanent chairperson, as he would like to have the agreement eigned by a permanent chairperson by the next meeting.

Mr. Guzmán responded to Mr. Vargas' questions by stating that "record-keeping" took into account any and all activities this Board engaged in: that the Board wanted Jentre Cuitural's active support in assisting with any administrative duties as well as with the organizational development of this Board's activities as they are related to the Hilingual Education Program, and he insisted that Centro Cultural provide the staff person to take and transcribe minutes of the Board meetings, send out notices pertinent to Board activities, and said he could sign the proposed agreement Mr. Vargas was concerned with as the Temporary Chair.

At that point Mr. Guzmán asked for a vote on the date the Board should meet and how often. It was unanimously agreed that the Board meetings should be held on the first Tuesday of each month. It was also moved and seconded that the next meeting be held on Tuesday, April 3th at 7:00 p.m. due to an interruption in the school session for "Spring-break."

Mr. Vargas requested any files be brought to entro Cultural within the next few days to which Mr. Guzman agreed.

The next item on the agenda was the discussion of the second draft of the B.lingual Program's Constitution. After some discussion, it was agreed that the official name of this Board be "HISPANIC PARENTS ADVISORY BOARD TO BILINGUAL EDG. MION PROGRAMS FOR THE MINNEAPOLIS PUBLIC SCHOOL DISTRICT #1." Penny Cervanted made a motion that the name be adopted as such, and it was seconded by Mr. Zaragoza.

Mr. Guzmán brought up the matter of the public nearing at the Mpls. School Board scheduled for Tuesday, March 25th and asked Mr. Gonzalez to explain what the meeting would be about. Mrs. Baumann asked what number of Hispanics were enrolled in the school district and Mr. Gonzalez replied there were about 600. Mr. Guzmán
