#### EXECUTIVE DIRECTOR'S REPORT

July 3, 1979

First of all, I would like to address myself to the Board of Directors questioning the obtaining of Centro's applicants' references. The following is a summary of my findings.

- I did not contact Mrs. Penny Cervantes' personal references in Texas, however, I did interview her prior to the Screening Committee's personal interview with her. Mr. Jose Gaitan provided a supportive letter as well, and Mrs. Lolly Smith offered her observations and recommended her highly upon reviewing her resume and speaking with her personally before her arrival in Minneapolis.
- Mr. Keyes was Donn J. Vargas' personal reference and he stated that Donn had superb credentials and work experience.
- Lee Bowman's reference was Mr. Pedro Roybal who had encouraged Lee to apply for the position of Program Counselor. He felt Lee was capable of handling the job, if given the opportunity.

If you have any questions regarding the above, please do not hesitate to contact me.

Secondly, the firm of Bailey & Calof, CPA's, have examined the balance sheet and records of Centro for 1978. In their opinion, the financial statements present fairly the financial position of Centro Cultural Chicano as of December 31, 1978 (a clean bill of health, in other words). The Chairman has reviewed this report and a copy will be given to the rest of the board members at a later date.

Thirdly, in March, 1979, I had previously informed the Board of Directors that I was in the process of organizing a statewide presentation in behalf of Centro to which a segment of the business community would be invited. That program took place on June 27, 1979, however, I was unable to present my report concerning this presentation to the Board at our June 14, 1979 meeting due to my father's death. Notices were sent to all Board Members informing them of the presentation in the hope that some of you would be able to attend. I would like Sr. Ed Villalon and Sr. Tony Arellano to give a summary of that presentation.

I have requested written responses from the foundations' representatives concerning the program.

Fourth, the United Way of Minneapolis Board of Directors approved funding for the Centro at its June 26, 1979 board meeting (article attached). The amount granted is sixty thousand (\$60,000.00) dollars and includes a one-year grant of five thousand (\$5,000.00) dollars to purchase overall management assistance from Catholic Charities.

Informal staff conversations have been held with Monsignor Boxleitner, Executive Director, Catholic Charities, Ms. Betty Davidson, a staff member of United Way and myself, to determine the possibility of their agency providing management assistance to the Centro.

There are plans for more formal discussion of ways in which Catholic Charities could become more involved with the Chicano/Latino community and more specifically, with the Centro.

Msgr. Boxleitner has been most gracious and cooperative in discussions about ways in which Catholic Charities can give overall support to the Centro, through such services as board development and training; personnel policy development; program development; training of volunteers and any other assistance needed to provide guidance and direction to our agency.

The management expertise of Catholic Charities is well-documented. I have indicated pleasure at the possibility of receiving help from them.

Fifth, Mr. Beech, Executive Director, Minneapolis Foundation, has asked me to select, one person to attend the 1979 "Itasca Seminar" as a guest of the Minneapolis Foundation.

I have attended the 1978 Itasca Seminar and I found it to be very interesting. Presently, I would like a Board Member to attend for 1979. I do not object to going again, however, I would like to give another person the opportunity.

Please note that the seminar begins with the departure by bus from Minneapolis at 8:30 a.m., Monday, September 24, 1979 and concludes with the return to Minneapolis at 4:00 p.m., Friday, September 28th. It is important that participants commit themselves to attending the entire seminar.

Attached is some information for your use in contacting the person you wish to select.

Six, concerning the three at-large positions on the Centro Cultural Chicano Board of Directors, it is my hope the Board will allow two of those positions to be filled by members of the business community.

After discussions with board member Eduardo Villalon, we'd like to submit the name of Mr. Jon Pekel, Director of Corporate Responsibility, Green Giant Company, for one of the at-large positions.

Centro Cultural Chicano Executive Directors Report March 8, 1978

1. We made the deadline for the United Way proposal. They had problems with our budget.

Inside Information on this subject:

United Way's Campaign for Funds last year got \$ 100,000. dollars. They received over a million dollars in requests from both new and existing agencies, yet were able only to allocate \$50,000. for the funding of new/expanded programming. In short, they felt the \$82,428. we requested was too high an amount, and our priorities (individual and organizational advocacy) were not ranked in their two (2) top priority groups, we fell under their fourth (4) ranking which means we will not get high consideration. In view of this, I adjusted the budget to \$23,996., so we at least can out foot in the door.

- 2. Reviewing of Personnel Policies and Practices has been completed with all our staff.
- 3. We have been made aware of the availability of funds for Non-Profit Organizations to provide transportation to the elderly and handicapped. \$382.000 has been allocated to the State of Minnesota for this purpose. The deadline for this proposal will be March 31, 1978. My question! What shall Centro request, one or two vans, cars, etc.
- 4. We have contacted (by mail) nine (9) people, and asked them to serve on the Search and Screening Committee for the new jobs. We are awaiting their response.
- 5. We have received nine(9) resumes for the Research Associate Position, and four (4) applications for the Community Advocate position.
- 6. The proposal for second year funding for the Seniors Program has been submitted to the Metropolitan Council.
- 7. I am still working on proposals to other foundations.

# CENTRO CULTURAL CHICANO EXECUTIVE DIRECTORS REPORT 11-11-80

- 1. SALVADOR VALDOVINOS WILL BE PROSENTING THE LAST SEGMENT OF THE STAFF TRAINING PROGRAM ON DECEMBER 1, 1980. THE TOPICS THAT HAVE BEEN PRESENTED THUS FAR ARE STAFF RESPONSIBILITIES AS OPPOSSED TO BOARD RESPONSIBILITIES, STAFF COMMUNICATION USED A A CROSS REFERENCE TOOL, STAFF AND BOARD INTERACTION, AND STAFF AND CLIENT PROCESS AND PROCEDURE. THE LAST SESSION WILL BE TO REVIEW ALL TRAINING SESSIONS AND EVALUATE TRAINING FORMAT. IN MY OPINION, STAFF DEVELOPMENT TRAINING SHOULD BE AN ANNUAL EVENT FOR ALL STAFF AND INCLUDED INTO ANNUAL BUDGET.
- 2. THE UNITED WAY WILL BE NOTIFYING ALL PARTICIPATION AGENCY DIRECTORS ABOUT THE AMOUNT OF MANEY THAT HAS BEEN ALLOCATED TO EACH AGENCY BY THE END OF NOVEMBER.
- 3. THE UNITED WAY SHOULD ALSO INFORM ME ABOUT THE TARGET POPULATION PROPOSAL AT THE SAME TIME THE OTHER NOTIFICATION IS SENT.
- 4. HENNEPIN COUNTY HAS SENT ME A PRELIMINARY CONTRACT FOR MY REVIEW. I AM TO READ IT, MAKE COMMENTS OR CORRECTIONS IF NECESSARY AND SEND IT BACK. I HAVE YET TO MEET WITH HENNEPIN COUNTY C.D. PROGRAM STAFF BUT I EXPECT IT WILL BE VERY SHORTLY.
- THE COMMUNITY DEVELOPMENT BLOCK GRANT (C.D.B.G.) PROPOSAL FOR (223,000.00) TWO HUNDRED AND TWENTYTHREE DOLLARS HAS A GOOD CHANCE OF BEING APPROVED. I AM CURRENTLY IN THE PROCESS OF LOBBYING FOR IT'S APPROVAL. I WILL BE SENDING LETTERS TO THE ALDERPEOPLE AND I INTEND TO MEET WITH MARK KAPLAN, THE CHAIR OF THE C.D.B.G. ALLOCATIONS COMMITTEE IN LATE NOVEMBER.
