## The Hispanic Community and Census 2000

I currently work for the US Department of Commerce, Census Bureau, as a Community Partnership Specialist. The purpose of the Partnership program is to create awareness, reduce barriers, and encourage participation in the Census, especially, those communities that were undercounted in the past. The program serves to support Census operations conducted through the local Census offices.

I strongly believe that the Census is so important to our State and our community. As a Community Partnership Specialist, I work with community-based organizations, religious groups and local businesses in areas with highly diverse populations. I help them to identify area challenges for enumeration. The Hispanic community has specific concerns such as employment, confidentiality and language accessibility.

Time and again, members of the Hispanic community have shared their concerns about the activities of Immigration and Naturalization Service. The rounding up of people peacefully playing in a park, the raids that have occurred here in Minnesota and the fear those actions have generated are daunting barriers. The immediate action is to talk to them about Title 13 and how this law protects the confidentiality of their response. The Census Bureau cannot share their answers with the IRS, FBI, Welfare, Immigration or any other

government body! Not even the president of the United States can access their responses! All of us who work for the Census are sworn to confidentiality. We face a fine of \$5,000 and a five-year prison term if we give out any information.

The mistrust of government, fear of reprisal, lack of English skills, prosecution and deportation are some of the reasons Hispanics shy away from answering questions. Another factor, is the lack of knowledge about the federal funds that could benefit their community programs and services as a result of being counted.

The Partnership program uses speeches, presentations and exhibits to let communities know that the Census is safe. Its confidentiality is protected by title 13. I have been meeting with various persons and organizations to form partnerships. We discussed the need to develop an action plan organizing the Hispanic community and to identify individuals that would serve on

complete count committees.

I am very happy to say that several community-based organizations and also the State of Minnesota, Chicano Latino Affairs Council, have become partners with the Census 2000. They agreed to the following activities:

- Create awareness of the Census through their newsletters, distribution of posters, promotional Materials, and use of other media.

- Create and organize a complete count committee by identifying and recruiting individuals willing to serve on this important committee.

- They are donating space for meetings, for office space, for testing and training.

- They are providing liaison staff to work with the Census 2000.

- They are willing to invite groups, religious, business, civic and others to gather and work towards an accurate count and to be counted 100%.

- They are planning community events in the near future to create awareness of the Census, to reduce barriers, and to do recruitment of volunteers to help implement the strategic plans.

These actions are part of the activities the complete count committees engage in to meet our mutual goal, to be counted 100%. This effort is really building community. We need you to ensure that our communities are counted. Working together we can do it! Muchas Gracias, thank you.

## RESPONSE TO PEOPLE WHO INDICATE THAT THEY HAVE RECEIVED MORE THAN ONE CENSUS QUESTIONNAIRE

Q. Why am I receiving two or more duplicate questionnaires from the Census Bureau?

▼ In preparing our address list for mailing Census questionnaires, we tried to be as inclusive as possible. We started with our 1990 address list and added address information from the U.S. Postal Service, and local and tribal governments as well as field checks by census workers to build a comprehensive address list. However, this inclusive process sometimes results in duplicate addresses and, thus, multiple questionnaires. Before we eliminate any address from our list, we have a number of census operations which review and verify these addresses. These review procedures are designed to resolve duplicate addresses and will continue through spring and summer of this year.

Q. What should I do when I receive duplicate forms?

▼ We understand we may have delivered more than one census questionnaire to your residence. We are asking you:

- \* to select the addressed form that best represents your current, correct address.

- \*Please ignore the other questionnaires and return your selected form in the postage-paid return envelope that has your current, correct address.

- \*We ask that you do not use or mail back the other questionnaires.

You may be visited by a Census taker, even if you mail back your questionnaire. We will be continuing to verify census information.

Q. Why are you wasting the taxpayers' money?

▼ This is not a waste of the taxpayers' money. Our process is designed to produce the most complete count of the Nation's population. Only a small proportion of households in the United States will receive multiple questionnaires. We would appreciate your help in doing what you can to mail back the questionnaire with the correct address information.

**RESPONSE TO PEOPLE WHO INDICATE THAT THEY HAVE NOT YET RECEIVED  
THEIR QUESTIONNAIRES**

Q. I have heard from (my neighbors/friends/relatives, the media, etc.) that I already should have received a census questionnaire. Why haven't I?

▼ **The majority of people will receive their questionnaires between now and March 22<sup>nd</sup>. It is important to wait until that date before you take any other measure to obtain a questionnaire.** Do not be concerned that you have not as yet received your questionnaire. We have a number of different methods for delivering questionnaires to residences. Most questionnaires are delivered by the United States Postal Service while others are delivered by Census takers.

▼ If by March 22<sup>nd</sup> you still have not received a questionnaire, please call our Telephone Questionnaire Assistance number, which is 1-800-471-9424. The staff answering those calls will be happy to mail out a form to you at that time.

▼ We thank you for your patience and understanding that the United States Postal Service and our own census takers are still delivering the forms through most of March. We urge you to complete the form when you receive it.



## WHERE TO COUNT BOARDING SCHOOL STUDENTS IN CENSUS 2000

**Rule:** According to Census 2000 Residence Rule #7, students attending school away from home below the college level, such as at a boarding school or a Bureau of Indian Affairs boarding school, are to be counted at their parental home.

**History and Rationale:** It has been the practice since the first U.S. census in 1790 to count boarding school students at the parental home. The reasons for this are the young ages of the students, their dependency on their parents, and the likelihood that they would return to their parents' residences after completing school. Equally important is the fact that the risk of double counting these students would be much greater if they were enumerated at the school, because their parents would likely report them as living at home, regardless of the procedures.

This rule has been upheld in the courts. For example, in the Court's opinion in *Borough of Bethel Park v Stans* (449 F 2d 575 [3d Cir.1971], this practice was found to be acceptable.

**Application of Rule #7:** The rule must be applied uniformly to all boarding school students, regardless of their parents' residence.

Guidance Memorandum on the use of  
United States Postal Service Temporary Mailboxes

We have received a number of inquiries regarding the use of temporary mailboxes during Census 2000.

The U.S. Census Bureau supports all measures that will foster greater participation in Census 2000. Our advertising and promotional strategy encourages everyone to fill out their form and mail it back as soon as they receive the form.

United States Postal Service Temporary Mailboxes may offer additional outlets and greater convenience for respondents, therefore leading to increased participation in Census 2000.

Temporary Mailboxes must not be used in any circumstance that could lead to the delay of any person mailing back his or her census form, or instances where the forms would be held. Examples include events that suggest entrance or prizes based on providing a completed census form.

Any organization or entity interested in Temporary Mailboxes should work directly with the United States Postal Service.

## SEVERAL MILLION CENSUS FORMS TO BE HAND DELIVERED

*The (Local Census Office) Will Distribute (number) Forms*

A large percent of the approximately 120 million housing unit addresses that have been identified by the Census Bureau will have their Census 2000 forms hand-delivered.

Beginning March 3, census workers will fan out into rural areas of the country to deliver Census 2000 forms to residents with rural and rural post office box addresses. They'll request residents to fill out their forms and mail them in on April 1. When census workers find no one home, they'll leave the census forms at the door.

Census 2000 workers may be identified by their red, white, and blue badges, which say, "Census Enumerator." The white plastic badges have the U. S. Flag on the upper left corner and have the seal of the "United States Department of Commerce-Bureau of the Census" printed in the middle of the badge. Their badges are displayed prominently and have the worker's name on the front side.

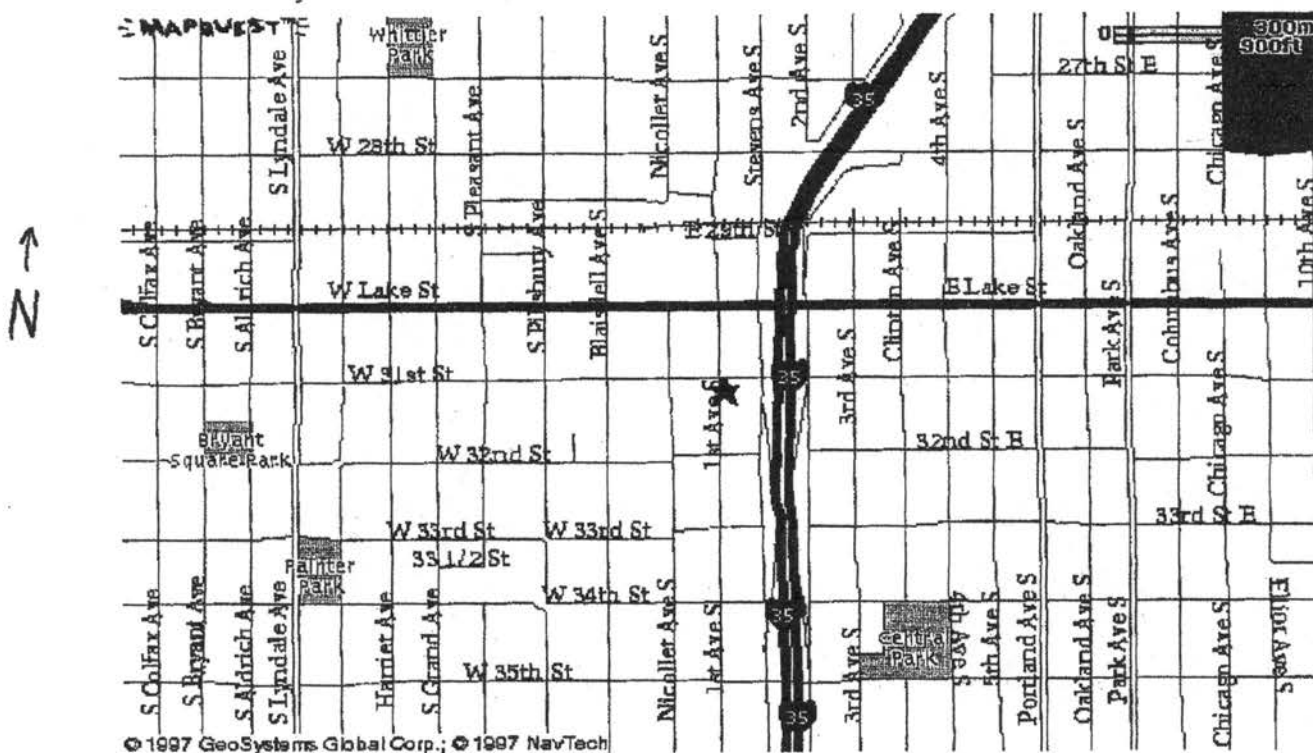

**Harriet Tubman Center (HTC)** is a 3-story, beige and tan, prairie-style stucco building. Please park and enter the building from the south side (off of First Avenue, near the playground equipment). Overflow parking is located southeast ("kitty corner") from the main lot, adjacent to Redeemer Missionary Baptist Church. You may also park on First Avenue, on the left (west) side of the street. Please do not park in the Minnesota Teen Challenge lot.

### Driving Directions

From the North: South on 35W. Take 35th/36th Street exit. Take *immediate* right (west) on 35th Street (a one-way street). Take a right (north) on 1st Avenue (a one-way street). HTC is 4 blocks north, on the right.

From the East: West on 94, take exit to 35W South. Take 35th/36th Street exit (*Note:* This exit comes up quickly - merge right as soon as you can). Take *immediate* right (west) on 35th Street (a one-way street). Take a right (north) on 1st Avenue (a one-way street). HTC is 4 blocks north, on the right.

From the South: North on 35W. Take 35th/36th Street exit. Take a left (west) on 35th Street (a one-way street). Take a right (north) on 1st Avenue (a one-way street). HTC is 4 blocks north, on the right.

From the West: East on 394. Access 94 East near the Basilica. Get onto 35W South. Take 35th/36th Street exit. Take *immediate* right (west) on 35th Street (a one-way street). Take a right (north) on 1st Avenue (a one-way street). HTC is 4 blocks north, on the right.
