### SUMMARY OF PROPOSED CHARTER AMENDMENT OR CITY ORDINANCE

To remedy the rental housing shortage and unjustifiable rent increases in Minneapolis, creation of rent and condominium controls is proposed by charter amendment or city ordinance providing:

#### A. 1. Board

1. A. City rent adjustment Board consisting of \_\_\_ appointed members and the Mayor or his representative is created to administer rent control.

#### 2. Base Rent.

Rent can increase only by a set percentage over rent charged three months prior to adoption of this Amendment/ordinance.

#### 3. Allowable rent increase

The board sets allowable rent increases annually based upon city landlords' average cost increases (including utility costs, property taxes, maintenance costs) plus a fair profit.

## 4. Petitions for exceptions

Landlords can petition the Board for rent increases in excess of the allowable rent increases if their costs have increased above the average or an extraordinary circumstance arises. Tenants can petition for decreased rents if the landlords' costs, or maintenance or service have decreased.

# 5. Exemption of new construction and small owner occupied structures

Newly constructed buildings (for five years) and owner-occupied building of four or fewer units are not controlled.

## 6. Increase Prior to Full Implementation

Between adoption of the amendment/ordinance and July 1981, rent increases are limited to four percent.

#### 7. Administration costs

Board operations would be funded by the city for the first year and by annual fees paid by landlords thereafter.

- B. Conversion of existing residential apartments to condominiums is prohibited. Present state law limits conversion controls to eighteen months. Newly constructed condominiums and those in process of conversion upon adoption of this Amendment are not prohibited. Conversion of rental apartments to cooperatives is prohibited, unless two-thirds of the tenants approve the conversion and most building units are reserved for low and moderate income households, and owners' return is limited to original investment plus a set rate of return.
- C. Persons violating these provisions are subject to criminal penalties and civil damages.

#### DRAFT RESOLUTION

#### Affirmative Action

In the past, the City of Minneapolis has stated its commitment to affirmative action. An affirmative action plan was develop for the city with the assistance of the Minneapolis minority community. However, since that time little has changed.

The City Council has never formally adopted the Affirmative Action Plan. City departments, like the police and fire departments, remain virtually all white. Restructuring of the City Affirmative Action Policy proceeds without minority community input. The one major change in the Civil Service system which could possibly help to open up the system to minority people, the Rule of Three, was initiated and instituted almost entirely through the efforts of the minority community.

Given the present lack of effort by the City to address the issue of affirmative action on its own, the Urban Coalition of Minneapolis Board of Directors recommend that:

- a) The Mayor and the City Coordinator make every effort to include a representative of the minority community on the Affirmative Action Policy Committee.
  - b) The Mayor make affirmative action in the hiring of people of color a top priority and that he employ every device at his disposal to improve city hiring relative to this group.
    - c) Primary attention be paid to the Rule of Three, ensuring that it will be used in the most effective way to promote affirmative action.



#### CIVIL SERVICE BUDGET CUTBACKS

Whereas, cutbacks in the Civil Service budget should be analyzed in terms of there adverse impact upon the general morale among city employees; thereby fueling sentiments of genuine pursuit resistance of affirmative action goals, etc., and

Whereas, employees without seniority are likely to be laid off. And as senior employees retire, the positions they vacate are not rehired; and

Whereas, this attrition pattern acts as a two edged sword, attacking and slashing the already limited potential for American Indians, Blacks and Chicano/Latinos to retain Civil Service employment already secured or obtain employment that becomes available;

Therefore, be it resolved that the Urban Coalition of Minneapolis wishes to be on record to the City Council of Minneapolis in opposition to utilization of attrition as a means of offsetting the Civil Service budget deficit because of its particularly adverse affect on minorities; and

Be it further resolved that the City Council take action to exempt minority "recruiter" positions (i.e., American Indian, Latino/Chicano and Black) from lay off or no hire measures aimed at reducing the aforementioned deficit.
