The minutes of the June meeting were read and approved.

Bills payable as of July 1 were read amounting to \$1007.58.

Mrs. Denny reported also for the Immigration Committee that a great many bills on immigration and naturalization were introduced into Congress, seven of which passed Congress.

Mrs. O'Neil reported for the THIRD DISTRICT that she has secured Mrs. Charles Kolars of Le Center to serve as county chairman for Le Sueur County.

Mrs. Beard reported for the FIFTH DISTRICT that the Minneapolis League maintained an information headquarters ten days preceding the primary. She felt that there was a definite indication of increasing interest on the part of the voters in cardidates. The questionnaire replies received from candidates for Congress were studied intensely. The Minneapolis League will continue its study groups.

State Convention

Letters were read from John E. Regan and Earle Brown in response to the League's invitation to speak at the state convention.

The meeting adjourned at 12:45 P.M.

In the absence of the secretary, Mrs. Pearce was appointed secretary pro tem. The minutes of the July meeting were then read and approved.

Treasurer's Report

In the absence of Mrs. Cant, Mrs. Pearce read the treasurer's report.

The balance July 1 was \$752.27. Receipts during July amounted to \$82.02, of which \$2.50 was received in quota payments. Disbursements during July totaled \$425.41, leaving a balance August 1 of \$408.88. Bills payable as of August 1 amounting to \$939.24 were read. It was WOTED on motion of Mrs. McGuire, second of Mrs. Musser, to accept the report and authorize the payment of bills.

Communications from the National League

The "Platform for the Times" prepared by the Emergency Advisory Committee appointed at the time of the National League Convention in Detroit was distributed

to board members for their information.

Mrs. McGuire reported on the plan, described in a letter from the National
League of July 26, for a series of round tables to keep sentiment for peace
eleven member organizations of the
aroused. The plan is sponsored by the/National Committee on the Cause and Cure
of War, of which the League is one. Mrs. McGuire said that no action by the
state League is asked for at this time.

Receipt of a press release reporting kangum activities at the national in behalf of the League planks party conventions/was reported and of a mimeographed summary "The National League of Women Voters Planks and the Party Platforms." It was VOTED on motion of Mrs. McGuire, second of Mrs. Pearce, to have a few copies of this summary at the State Fair to distribute to those interested. Miss Child commented on the fact that the League plank on public welfare was the only one adopted from the floor at the Democratic convention.

Reported were made for their departments on the final action by the Congress on League measures by Mrs. McGuire, Miss Kercher, Mrs. Richards, Mrs. Musser, Mrs. Dobson and Mrs. Denny. Miss Child read the replies received from Congressmen Andresen, Maas, Nolan, Knutson and Pittenger to the letter from the state League in behalf of S. 4860, a bill for unemployment relief. Miss Mitchell's letter of June 21 was sent in response to a telegram from the National League.

A letter from Governor Olson was read, accepting the invitation to speak at the candidates' meeting on October 20.

It was VOTED on motion of Mrs. McGuire, second of Mrs. Swain, to have the same registration fee (50%) for convention visitors and delegates as last year.

It was WOTED on motion of Miss Kercher, second of Mrs. Dobson, to designate the executive committee as the program committee and to authorize it to ask others to serve with it for this purpose.

It was VOTED on motion of Miss Kercher, second of Mrs. McGuire, that the distribution of delegates credentials be according to the plan followed in other years. (See September 1931 minutes.)

Miss Child outlined a plan for beginning the convention on Tuesday, with the pre-convention board meeting and fireside supper, having two days (Wednesday and Thurday) for convention sessions and ending with the candidates' meeting Thursday evening instead of with a gala luncheon as in previous years.

Board members liked the plan of adjourning the convention before the candidates' meeting. It was therefore VOTED on motion of Miss Kercher, second of Mrs. McGuire, to move the dates ahead to October 18, 19, 20.

State Fair Exhibit

Miss Child outlined a tentative plan for the exhibit to stress the coming election. She suggested using the steps, which have previously been used as steps toward peace, as "steep steps to good government". Mrs. McGuire suggested having the "Platform for the Times" reproduced on the screen as the background for the exhibit. Discussion followed as to features that might be used to attract people to the booth such as writing catchy phrases or slogans on a blackboard. It was suggested that an attempt should be made, by writing the National League, to secure copies of the party platforms for distribution.

Discussion of Recommendations for Proposed Program of Work

Department chairmen reported their tentative recommendations for study and support items on the Proposed Program for 1932-33 as a result of the discussion at the conference the previous day as follows.

Efficiency in Government - Mrs. Richards said that "ratification of the Lame Duck Amendment" will necessarily be on the program for support. Other items which should probably be on the program are the study of the tax system--the county assessor instead of the local assessor;; and the reorganization of governmental units. There is also the question of what item should be included on the income tax

amendment.

Women in Industry - Miss Kercher recommended for support the amendment to the minimum wage law which has been on previous programs. She thought, also, it would do no harm to place an item "support of legislation limiting hours of work for women in industry" on the program and to introduce such a bill even though the test case on the 1923 hour law will be heard before the Supreme Court sometime during the legislative session. She recommended changing the wording of the study item to "methods of improving employment opportunities." She then called on Miss Child, as a member of the Board of the Minnesota Committee on Social Legislation, to tell about the work being done by its Sub-Committee on State Relief Legislation to ascertain relief needs and after a study of legislation in other states, to draft a bill to meet the needs. Miss Kercher recommended placing an item on the program which would enable the League to support proper relief legislation which might result from the work of this sub-committee. Possible wording suggested the state at seed a seed a seed a was "A system of state and local unemployment relief." It was thought, also, that a separate item on "Support of adequate machinery for the distribution of federal funds" might be necessary to enable the League to be active in safeguarding the distribution of federal aid for relief if and when a request is made by Governor Langtonia with matter were to be and bloom a demonstration Olson.

Legal Status of Women - Mrs. Dobson commented briefly on possible measures for support in her department:

Universal registration of marriages

Marriage evasion law - Miss Child called attention to the fact that the Russell Sage Foundation, in its study, found such laws ineffective and questioned whether we wished to support a law which was unenforceable and only cluttered up the statutes.

She recommended also the item, opposition to discriminations against women For study, she suggested that all members should be informed on discrimina-

the times gainet nomes. She thought absorbed to the nationality of legitimate, illegitimate, adopted children, and foundlings" in the National program would be an interesting study item but felt that study of "participation in party management" was probably more important.

Living Costs - Mrs. Musser recommended two support items:

Study of poor in relation to living costs
the tariff

Education - Mrs. Pearce recommended continuing on the study program the item "Study of county unit and other larger units". She recommended adding to the program "Opposition to any measure to weaken the Teacher Tenure Law." After Exercise There was discussion as to the desirability of making the item on larger units of school administration a support item. This would not commit the League to introducing such a bill, but would commit it to continuing its education and would enable it to support such a bill if introduced.

International Cooperation to Prevent War - Mrs. McGuire called attention to the fact that two support items will automatically be on the program for her department:

Adherence of the United States to the World Court and Support of treaties resulting from the Disarmament Conference.

The foreign policy of the United States toward European countries, the U.S.S.R., Latin American countries, the Philippines, China and Japan, with special emphasis on the U.S.S.R. and the new recognition policy enunciated by Secretary Stimson.

Expenditures for military purposes in the federal and state government

Questionnaire to Candidates

Miss Child reported that 18 of the 27 candidates for Congress returned the questionnaire before the primary—an unusually high return. An effort will be made, however, to secure an even higher return by sending another questionnaire to those who did not reply.

She asked for an expression on the best method of distributing the questionnaires to candidates for the state legislature. It was suggested that local Leagues be asked to be responsible for getting the questionnaire to their legislators-by having a delegation take it to them personally, by inviting the candidates to
a small luncheon or by sending it to them.

The minutes were read by the Secretary and approved.

Treasurer's Report

Mrs. Colby reported discussion in the executive committee of a proposal

nially, alternating with the holding of the National League Convention. A Council meeting might be planned, as in the National League, for the alternate year. The purpose of the change would be so that a state program of work might be adopted following the National League convention and preceding the adoption of programs by local Leagues in the state. These should be based upon the state program and should he known in thime so that work can start in the local Leagues early in September. Mrs. Cant asked whether the legislative program should not be adopted by the convention instead of the Council and pointed out that this would mean adopting a program a full year and a half before the meeting of the legislature. Miss Mitchell explained that since next spring would be the time for a state convention under the proposal discussed, she suggests postponing the decision to the 1933 convention to avoid two conventions so close together and to permit long consideration of the advantages and disadvantages involved. The Board by consent agreed to postpone further conto a suture

sideration of the proposal at this time.

Pre-election Work

A recent letter was read from Miss Wells as Chairman of Legislation in the National League requesting work by the state League in support of federal measures through interviewing congressional candidates before Dongress convenes and preferably before election. IT WAS VOTED upon motion of Mrs. Grannis second of Mrs. Pearce that the executive committee make a detailed plan for carrying out this request.

The desirability of \$\ \text{local League information headquarters before the election was discussed. It was thought that the printing of sample state ballots by the state League is worth while and that most of the cost should be covered by their sale individually of in quantity.

State Convention Plans

Miss Child reported the recommendations of the executive committee for the personnel of convention committees. IT WAS VOTED on motion of Mrs. Beard second of Mrs. Denny to name Mrs. William Pearce as chairman of the Nominating Committee, with representatives from the other congressional districts as recommended. IT WAS VOTED on motion of Mrs. Cant, second of Mrs. Swain to name Mrs. Colby as chairman of the Budget Committee within the state finance chairman and treasurer; the finance chairman of the Leagues in Minneapolis, St. Paul, St. Cloud and Winona; Mrs. Burquist of Duluth, Mrs. King of Willmar, and Mrs. Yetter of Stephen. IT WAS VOTED on motion of Mrs. Hawkinson, second of Mrs. Dobson to name Miss Nell Merrill as chairman for the sale of printed material. IT WAS VOTED on motion of Mrs. McGuire, second of Mrs. Grannis to appoint Mrs. Swain and Mrs. Morrison of Winona as the committee on revision of the By-Laws. IT WAS VOTED on motion of Mrs. Beard, second of Mrs. Pearce that the executive committee be empowered to make other appointments that may be necessary in connection with convention arrangements.

The plan of holding organization and department conferences on Detober 18 the opening day of the convention, was discussed. The recommendation of the

expending consider

executive committee was reported that arrangements for these conferences and the sending of infitations to local League chairmen be the responsibility of each state chairman. Miss Child will supply each chairman with the list of her department members. The established policy of not permitting the use of these lists without special board of executive committee action was mentioned.

Proposed Program of Work

The department chairmen submitted recommendation for the Proposed Program as shown in the attached statement, except in the case of the department of Efficiency in Government. Mrs. Richards requested that the final wording of her department items might be grawn up after further conferences with those she wishes to consult, subject to approval by the executive committee. The question of support of the income tax amendment was discussed at length and IT WAS VOTED on motion of Mrs. Colby, second of Mrs. Swain that Mrs. Richard's recommendation for the cinclusion of this item in the proposed program be adopted. The question of inclusion of measures designated by the National League for active support in 1932-33 was mentioned. IT WAS VOTED upon motion of Mrs. Swain, second of Mrs. Pearce, that such measures be included with the exception of the item on a federal department of education which was also omitted, after correspondence with National League officers, from the questionnaire to Congressional candidates. IT WAS THEN VOTED on motion of Mrs. Colby second of Mrs. Cant that the program as presented by department chairmen be approved for submission to local Leagues in advance of the state convention.

The section of the program on Fre-election Activities included in the 1931 Program of Work was considered. Certain omissions were discussed as desirable and IT WAS VOTED upon motion of Mrs. Cant, second of Mrs. Hawkinson that this section should read as follows:

Candidates' Meetings, information headquarters, etc.

Encouraging participation by qualified voters in every step

by which public officials are nominated adm elected.

The statement of "Recommended Policy" as adopted by the 1930 Convention was then read by the secretary. IT WAS VOTED upon motion of Mrs. Colby second of Mrs. Richards, that the Board submit the same statement to the 1932 convention for adoption.

Other Business

Miss Kercher reported to the Board upon the progress of the case brought to test the constitutionality of the 1923 hour law for women.

Letters from the National League describing the plan for the Survey of the Voter's Mind were read by the secretary. IT WAS VOTED upon motion of Mrs. Colby, second of Mrs. Denny that a special committee be named by the Executive Committee to assume charge of the work necessary in connection with the filling out of 1000 blanks allotted to the Minnesota League by the National League.

The possibility of the plan for the Candidates' Meeting in connection with the state convention failing to be carried out was reported by the chain. In reply to a question, Miss Child state that the policy has been followed since 1922 of not permitting a candidate to represented by a substitute. It was agreed by consent that any problem arising in connection with this convention event be left to the executive committee.

The meeting adjourned at 4:00 p.m.

IT WAS VOTED upon motion of Mrs. Colby, second of Mrs. McGuire to accept the mandadxpxpxxxxxxxxxxx recommendation.

Questionnaire to State Legislators

Miss Kercher also suggested the addition of the word "state" before "employment exchanges" in the third item. This was approved by consent.

Mrs. Cant reported that receipts during the month of November amounted \$980.03 of which \$332.80 was received in quotas. Disbursements amounted to \$618.89, leaving a balance December 1 of \$605.21. Mrs. Richards reported upon a meeting of her special Efficiency in Government committee. The advice of an advisory group of men is to be sought in regard to income tax legislation to be recommended for League support under the item in the adopted program. Mrs. Richards told of the threat in Stearns County to abolish the County Child Welfare Board and the additional action of the local League in coopering with the Parent-Teacher Association to arouse public opinion against such "destructive economy" and against the attempt to replace the experienced worker employed by the Board with a political appointee. Mrs. Richards recommended the advertigation of the local League so that they will learn and report the facts about the local situation in their county. She will prepare such a questionnaire. IT WAS VOTED upon Mrs. Richards, second of Mrs. Cant that Mrs. S. M. Searle of Kenyon be named a member of her committee.

Child Welfare Department - Dr. Boynton read a letter from the Mational League chairman in regard to the desirability of securing improved child labor legislation during this period when conditions are perhaps especially favorable for it. She reported that a recent meeting of the Legislative Council was devoted to a discussion of the operation of laws me regulating the employment of children in Minnesota. was made there by The recommendation the the supervisor of enforcement of the Street Trades law for the Minneapolis Public Schools, supported also by state and other enforcement officials in touch with the operation of the law, that the law be amended to provide a penalty for violation of the law by an employer or parents. Each organiza tion represented in the Council was asked to make official action on supporting such an amendment to be reported back as the basis for forming a Joint Committee by the state League for its support. The facts as to the support of the law/in its passage hyxxks were reported as well as were reported the further fact that improvement of the law by such an amendment has been urged by public officials in touch with its operation, from 1923 on. TT WAS VOTED on motion of Dr. Boynton, second of Mrs. Pearce that the Board authorize support of the amendment to improve a law enacted with the support of the insofar as support can be given without the success of the program as adopted by the convention.

The attention of Board members was called to the mimeographed statement on Public Relief in Minnesota prepared by Miss Child in support of the item in the Women in Industry program.

In the absence of Mrs. Pearce, Miss Child reported upon the conference called at state League headquarters on amendments to weaken the Teacher Tenure law. Representatives of the state A.A.U.W. and of the Minnesota Education Association, as well as of the Ramsey County and Mi neapolis Leagues and Mis Bauman of the Minneapolis Board of Education were present. IT WAS AGREED by the Board that all proposed amendments summitted by those hostile to the law be opposed under the item in the state program of work. This was the recommendation of the conference to interested organizations. The meeting adjourned for luncheon at 12:30 p.m. and reconvened at 1*30 p.m.

Dr. Boynton reported upon the legislation in the Child /Welfare program.

Miss Mitchell called attention to the passage of the Lame Duck Amendment resolution by the legislature on January 16. She also reported upon the dinner conference on Income tax legislation held by Mrs. Richards' special committee with a group of men qualified to advise the League on this subject/

This is the second meeting of the group. The letter sent Governor Olson upon the advice of this group, and approved by the executive committee, a urging/qualified appointee to succeed Mr. Armson on the Tax Commission was read by the secretary.

The bill to abolish the "Big Three" was discussed. Miss Child reported upon an interview with Mr. Hitchcock, author of the bill, and with others at the Capitol, indicating that there is little danger of the bill's passage. It is one of many introduced to militate against the creation of new departments or offices in the state government.

Mrs. Underwood of Lake City has the material for the President's Handbook well lined up but not all of the brief history reports of department chairmen are in. Please have them in by June 1.

Department chairmen Reports

Mrs. Pearce, chairman of Education recommended further study, in the state, of the County Unit System.

Mrs. McGuire, chairman of International Cooperation, urged a study of the Arms Embargo, and read extracts from a letter of Miss Morgan calling attention to congressional bill H.F. Res. 93. Particular emphasis for sutdy is given to the following: 1) International agreements for the control of manufacture and shipment of arms; 2) Revision of war debts.

The National League will send agendas on the Economic Conference so that local League may follow the Conference. She recommended study of Economic Causes of War. Mrs. McGuire will prepare material on Russia for study.

Mrs. Musser, chairman of Living Costs, gave a full report on Muscle
Shoals outlining the Norris resolution and sketching some of the high lights
in the message of President Roosevelt ot Congress in regard to Muscle Shoals.
On April 25, the Hill Bill passed the House by a vote of 306-91; on May 3,
the Norris Bill passed the Senate 63-20 and was sent to the House where a
substitute Bill had been passed. Both bills in hands of Conference Committee.

Miss Mitchell announced that a complete history of Muscle Shoals has been prepared by Mrs. Musser which will be mimeographed and on sale for League use. Mrs. McGuire and Miss Horr were appointed by the Board as the reading committee to pass on this material.

The report of the Colligge Commission to investigate Muscle Shoals was recommended for those wishing further information as to bovernment ownership of Muscle Shoals.

In the absence of Dr. Boymton, chairman of Child Weefare, Miss Mitchell gave a brief report for the department and strongly urged a follow up of the Street Trades law. She recommended copies of the Rix law to be sent to local Leagues and that the Leagues acquaint the proper officials with the law. With the approval of the Board Miss James will be asked to make copies of the law.

Miss Mitchell further reported that Michigan has ratified the Child

Labor Amendment.

General Council Meeting Report

Mrs. Cant delegate from Minnesota reported upon some of the high lights of the council meeting. Some topics touched upon were the need of the merit sustem in government. Thirty-eight states have none; ten states do have it; about 3000 counties, cities government departments etc. do and have made progress. Pennsylvania has material available for study.

Under Education was the question shall shools be financed by the federal government. Chicago and Georgia thought it should be up to the communities otherwise they would become dependent upon the government.

Mrs. Baldwin was called before the House appropriations committee.

She was asked to have her talk mimeographed and it was then circulated about the House.

A financial picture of the League showing how it spent its money was shown by graphs. Types of budgets used in states and local groups were shown.

Miss Mitchell requested that both St. Paul and Minneapolis consider entertaining the state convention.

Department Chairmen Reports contd.

In the absence of Mrs. Richards, chairman of Efficiency in Government, Miss Mitchell read the recommendations made by Mrs. Richards for League study under her department. 1) Methods of assessment with an idea to improvements. 2) Reorganization of local government with particular reference to County and Township. 3) Expenditure and control by the various units of government. 4) The Sales tax.

It was recommended by the Board that should Muscle Shoals go through that the department of LivingCosts should take up the study of the Tariff and of the U.S. Bureau of Home Economics.

Mrs. Cant suggested a study of the Audits of County Poor Funds.

STATE BOARD MEETING August 18, 1933

The regular meeting of the state Board of the Minnesota League of Women Voters was held on August 18, 1933 at the Y. W. C. A. in Minneapolis. The meeting was called to order at 10:00 a.m., Miss Mitchell presiding.

Present: Miss Mitchell, Mrs. Underwood, Mrs. Stakeman, Miss Clark, Mrs. Cant, Dr. Boynton, Mrs. Denny, Mrs. Grannis, Mrs. Hampton, Mrs. Richards, Mrs. Swain, and Miss Horr. Mrs. Cobb of Minneapolis and Mrs. Morrison of Winona were also pesent.

IT WAS VOTED upon motion of Mrs. Cant, second of Mrs. Underwood to omit reading of the minutes of the June meeting.

Treasurer's report

Mrs. Cant reported that receipts during the month of July amounted to \$1125.55 of which \$317.33 was received in quotas. Disbursements amounted to \$974.77, leaving a balance on August 1 of \$246.33. Bills payable on August 1 amounted to \$447.25. Balance at the beginning of July was \$95.55. IT WAS VOTED upon motion of Mrs. Hampton, second of Mrs.nUnderwood that the report he approved and placed on file.

Organization

Mrs. Colby's resignation was accepted upon motion of Mrs. Cant, second of Mrs. Denny. A committee of three, with Mrs. Underwood as chairman, Mrs. Grannis and Mrs. Cant were asked to draw up a letter to Mrs. Colby expressing the regret of the Board.

Field Report

Miss Horr reported on her meetings in Duluth and outlined her plans for the fall.

Office report: The secretary read a report by Miss James on the progress of work in the office during the summer months., as follows:

"There have been two large mimeographing jobs done this summer -- the material for the County Survey and the President's Handbook. These two things together with a new supply of Report and Order Blanks make 4000 sheets of mimeographing done. To accomplish this, nearly 75 new stencils were cut.

Another good sized job begin in the early summer and complete later, was a complete inventory of the educational material shelves and of the supplies in the storeroom. The shelves were carefully re-arranged and labeled

and the inventory of the material for each deartment sent to the respective chairmen.

The VOTER files, both card and stencil were completely checked and all subscription to date taken care of.

The large files were completely gone through, new folders added where needed, old folders replaced or repaired, and all permanent material filed to date. The temporary files were also gone through and clerad out and all temporary material filed to date."

Convention: IT WAS VOTED upon motion of Mrs. Grannis, second of Miss Clark that the invitation of St. Paul to hold the annual convention in that city be accepted. After some discussion of dates due to the fact that the National Council of Catholic women is holding their convention St. Paul (October 7-12), it was decided to hold the convention sometime between the 11 and 21 of October depending upon the acceptance of Frances Perkins. In case Miss Perkins cannot come, the convention would be held during the third week of October. Mrs. Stakeman suggested the week of October 16. It was decided to leave the convention dates open and also decided that Wednesday, Thursday, and Friday are the best days for convention.

Letters were read from Frances Perkins, Arthur Morgan and the Wisconsin League in regard to convention plans. IT WAS VOTED upon motion of Mrs. Cant, second of Mrs. Stakeman that Miss Mitchell write Professor Merriam and Professor Sharp for tentative engagements.

IT WAS VOTED upon motion of Mrs. Cant, second of Mrs. Underwood, that Mrs. Swain be chairman of the Nominating Committee; Mrs. Crary of the Budget and Mrs. Carpenter of Moorhead give the response to the welcome.

Suggested Changes in the By-Laws:

There was discussion over raising the membership fee to two dollars.

Mrs. Cant expressed the opinion that this is not the year to increase.

Miss Mitchell brought up the point of whether the convention should be in the spring or in the fall and concensus of opinion seemed to be to leave it as it is.

Communications

Various letters from the National League were read concerning the need for further work on the Child Labor Amendment; on Education, giving a list of new pamphlets on school budgets; on the Nationality Law concerning children and the request that if possible it be studied this year under the department of Legal Status of Women.

IT WAS VOTED upon motion of Mrs. Cant, second of Mrs. Grannis, that a committee be appointed to study the nationality of children and draw up an outline for study under Mrs. Luwe's direction.

A letter from Mrs. Baldwin was read regarding the requested cooperation of the League in obtaining retail food prices in certain Minneapolis and St. Paul stores in connection with the N. R. A. It was the desire of Miss Sherwin that the League cooperate in gathering these prices.

Discussion was held upon the type of cooperation to be given by the local Leagues to the N. R. A. and it was generally agreed that a local League would realize that the same policy in regard to cooperation would hold true in this situation as in others. While the Leagues would do all in their power to help educate themselves and the public on the N. R. A. , that their active support of it would be only in so far as it definitely related to the adopted program of work.

Discussion was also held on the round tables being held under the Cause and Cure of War. It was the general opinion that the League would not push or sponsor these round tables.

State Fair: Mrs. Cobb of Minneapolis as chairman of the booth, asked for suggestions for the exhibit. Mrs. Cant suggested statistics of public relief in Minnesota, use of tax money, education and the library.

Mrs. Grannis offered to put on the puppet show if plans could be made for carrying out brief, snappy conversation regarding previous points.

Proposed Program of Work was discussed and voted upon as per copies to be mailed later.

Miss Mitchell announced that all the present state department chairmen are willing to serve again with the exception of Mrs. McGuire and Mrs. Colby who resigned the Social Hygiene chairmanship sometime ago. Considering the pending realignment of the National Program of Work, the Board formerly expressed a desire not to appoint a chairman to this Department. The recommendation of the Executive Committee that Mrs. Erwin Hertz of St. Cloud be appointed to the chairmanship of the Department of International Cooperation to Prevent War was reported. It was VOTED on motion of Mrs. Pearce, seconded by Mrs. Musser, that this appointment be made. It was VOTED on motion of Mrs. Swain, second of Mrs. Denny, that all the other present chairmen be reappointed.

Mrs. Denny asked to be relieved from the chairmanship of the special committee on Immigration Problems. It was VOTED on motion of Mrs. Cant, second of Mrs. Pearce, that the other special committee chairmen be reappointed.

Miss Mitchell explained that the Executive Committee of seven members has, by action of the Board, included the president, the presidents of the Minneapolis and St. Paul Leagues, the state treasurer and three others. It was VOTED on motion of Mrs. Pearce, second of Mrs. Botsford, that Mrs. McGuire be appointed to the committee. It was VOTED on motion of Mrs. Denny, second of Mrs. Richards, that Dr. Boynton be appointed. It was VOTED on motion of Mrs. Pearce, second of Mrs. Botsford, that Mrs. Winter be appointed. Miss Mitchell announced that Executive Committee meetings are hereafter to be on the fourth Thursday of each month beginning at 11 o'clock and continuing through luncheon. Mrs. Cant suggested that state department chairmen be invited to attend meetings of the Executive Committee whenever possible.

State Members

Discussion of state memberships-at-large was introduced by a report by Miss Horr who asked whom we include in the term, members-at-large; does it include the members of study groups organized in communities where there is no League. She explained that the complimentary memberships given women members of the legislature, contributors, etc. are included in the number of state members. She explained also the reasons for having county chairmen in counties where there is no local League. Mrs. Wittich suggested securing a state member in each legislative district as a working basis for memberships outside of Leagues, rather than county chairmen. It was VOTED on motion of Miss Clark, as chairman of organization, seconded, that Mrs. Underwood be asked to take charge of such memberships and to work out plans using Miss Horr's and Mrs. Wittich's suggestions; also that she decide what material should be sent to state members. It was suggested that a state member be secured from a disbanded League.

It was VOTED on motion of Mrs. Cant, second of Mrs. Pearce, that state League study groups in communities where there is no local League, be hereafter called "study Leagues" to distinguish this type of organization from the study groups organized by the Leagues in the larger cities. Individual members of such groups will not hereafter be listed as members-at-large.

Report of Field Secretary

Miss Horr reported visits to Gaylord, Randolph, Northfield, Little

Falls, Excelsion and attendance at a Minneapolis membership tea. She asked that
local Leagues check on their subscriptions to the VOTER. Miss Mitchell asked if
a notice explaining that the 25 cents, sent to the state office for the VOTER
subscription should be included in each member's dues should be printed in the
VOTER and in the Local League News in preparation. This was thought advisable.

Mrs. Cant suggested that the News be enclosed with minutes mailed to Board members

Adaptation of Program of Work

Miss Mitchell introduced discussion of this subject by asking Board members what they visualized for local League work as the program was adopted.

Mrs. Richards responded that local Leagues must rally and be prepared. Miss Mitchell then asked what further aid should come from the office and state department chairman to help local Leagues. Mrs. Denny thought each department chairman should send an outline of study procedure. Mrs. Ryan suggested a mimeographed sheet with six or seven steps in procedure as being of benefit to a small League. Mrs. Pearce recommended that each local chairman be made responsible for her department, and that a letter go direct from the state chairman to the local chairman, with a copy tothe local deague freitlent.

Mrs. Tower reported that her Department is planning to send each local department chairman a letter on state and local systems of unemployment relief according to the need for improvement as shown in the surveys on relief. The following were suggested as desirable standards to work toward:

- l. A trained worker . To not the de data were all
 - 2. Clearance of all private agencies administering relief
- 3. Proper standards as to food
 - 4. Application cards

Mrs. Swain suggested word "application" in no. 4 be changed to "record" or "registration". It was VOTED on motion of Mrs. Cant, second of Mrs. Stakman, that the setandards be approved by the Board.

was It was VOTED on motion of Mrs. Musser, second of Mrs. Swain, that copies of Mrs. Luwe's convention talk be sent to every local League chairman of the Department at state League expense.

Mrs. Towker called attention to an appointment to be made by the State Board of Control to a federal position for the administration of relief to transients. It was VOTED on motion of Mrs. Towler, second of Mrs. Richards, that the Board send a letter to Mrs. LaDu urging that a qualified person be appointed to the position

Mrs. Pearce explained that the phrasing "different units" was used in her program item on units of school administration to include city units, county units, and the larger units recently stressed. She also explained that "education in its relation to the unemployed youth of Minnesota" was made a study rather than a support item because at the time of the convention there was no definite proposal which could be supported.

It was VOTED on motion of Mrs. Swain, second of Mrs. Denny, that where Departments have items for support calling for a definite activity of the League, letters be sent by state Department chairmen to local Leagues.

Child Labor Amendment .

Miss Mitchell reported on a conference which Dr. Boynton and she had wix with the Governor with regard to the possibility of a resolution to ratify the Child Labor Amendment coming before the special session of the Legislature. At that time, the Governor was not sure such a session would be called. Since one has been called, it was VOTED on motion of Mrs. Cant, second of Mrs. Botsford, that Dr. Boynton be informed of the feeling of the Board that this is a crucial time to push ratification of the Amendment, and be asked to take steps to bring it before the legislature, the procedure to be left to her discretion. After continued discussion, it was VOTED on motion of Mrs. Cant, seconded, to reconsider the vote. Mrs. Cant then moved that "we support at this special session of the legislature the Child Labor Amendment", which motion was seconded by Mrs. Pearce and carried.

The meeting adjourned for luncheon at 12:45. Informal discussion of suggestions for future conventions was carried on during luncheon.

The meeting re-convened at 1:35 for a discussion, led by Miss Wells, on the realignment of the National Program of Work.

The meeting adjourned at 3:00 p.m.

STATE BOARD MEETING December 1933

Bills payable December 1 amounted to \$676.65. It was VOTED on motion of Mrs.

Richards, second of Mrs. Underwood, that the report be accepted and placed on file.

Interviews with Congressmen

Plans were made for special interviews with Minnesota Congressmen as to their position in relation to measures in which the League is interested.

Reports by Department Chairmen

Mrs. Towler called attention to the five lessons on the N.R.A. pre-

pared by the National League for study. Fifteen copies are in the state office. She also reported upon Mrs. LaDu's C.W.A. talk in St. Paul. She read a News Release from the National League in regard to its protest of hours, wages, etc. in the Restaurant and Laundry Codes. A caution was given by Mrs. Towler, who urged us to watch local conditions. Mrs. Swain, Mrs. Richards, Mrs. O'Neil and Mrs. Scholpp asked that copies be sent them.

Mrs. Richards called attention to the Governor's message to the legislature and directed attention to the sections relating to taxes and taxdelinquency. Mrs. Richards also asked League members to listen in to Mrs. Thorp's resume of the day in the legislature each evening at 6 p.m. over station WCCO.

Miss Mitchell introduced Mrs. Hertz, new chairman of International Cooperation, who gave excerpts from a Disarmament News Letter and asked that we stress the Arms Embargo Act in our interviews with Congressmen.

Mrs. Luwe called attention to the possible disenfranchisement of German women, and to the enfranchisement for women in the Philippines. She reported having written personal letters to leading packing plants regarding discriminations against married women. She has received no reply. Following Mrs. Luwe's report, a general discussion of methods of selecting juries, and service thereon, found ready debaters among Board members.

Delegates to Cause and Cure of War Conference

The President asked the Board for names of those who might be delegates to this Conference. Mrs. Lester Rees, Mrs. Guy S. Ford, and Mrs. Brin were suggested.

Child Labor Amendment

A report on the progress of the Child Labor Amendment in the State
Legislature was given by Miss Mitchell, and the results of interviews by League
members with Senators were reported.

Reports from Office and Local Leagues

Miss Horr reported that the Monticello League is not active and recommended that it be dropped. Upon motion of Mrs. Towler, second of Mrs. Stakman, it was unanimously VOTED to drop the Monticello League from our list.

Mrs. Fairchild reported that the Willmar League is working on the County Survey. There is a junior League in Willmar of 15 members. Mrs. Scholpp reported that the new evening group of teachers and mothers in Hutchinson is studying the economic causes of war.

An office report, prepared by Miss James, was read by Miss Mitchell.

It was decided that the January Board meeting should be devoted to the question of organization.

Upon motion of Mrs. O'Weil, second of Mrs. Luwe, the meeting adjourned at 12:30 p.m.

STATE BOARD MEETING January 1934

The regular meeting of the State Board of the League of Women Voters was held on Friday, January 12 at 10:30 a.m. at the Y. W. C. A. in Mpls. Miss Mitchell presiding.

Mrs. Swain, secretary pro tem, read the minutes of the December meeting which were approved as read.

IT WAS VOTED upon motion of Mrs. Swain, second of Dr. Boynton that the Treasurer's report beplaced on file. The report as read by Mrs. Cant was as follows: Balance, December 1, 1933, \$133.72. Receipts during December \$508.04 of which \$373.33 was received in quotas. Disbursements during December \$482.85 leaving a balance January 1 of \$155.66. Bills payable January 1 amounted to \$838.87.

The Office Report was read by the secretary.

The Field Report was given by Miss Horr and included a recommendation that State Members be dropped or else given more work. It is advisable to develop more contact with them.

Mrs. Can't moved that at present no further work be done to change the present system of developing State Members.

Miss Wells suggested we write to Miss Constance Roach, organization secretary for the National League, and ask what other states have done to make a success of State Members. Mrs. Cant withdrew her motion and Miss Wells then made her suggestion a motion which was seconded by Mrs. Denny and carried.

Miss Wells recommended further study of our "contact" with State
Members as: 1. Getting members; 2. Supplying material of League;

3. VOTER

The Finance report was read by Mrs. Cant. Letters have been sent to all Leagues with a statement as to quotas paid. Selective Leagues have been names and Miss Wells has offered to match the funds raised.

To the question, "Would it be advisable to have League billed each month in regard to quotas" the Treasurer reported that three or four notices

are sent out each year. It was therefore felt sufficient notice was given.

In a discussion on increasing membership and qualifications for membership the following points were presented:

Mrs. Beard - 1. What per cent of members come in and stick as result of membership drives as against those who come in by application?

Mrs. Stakman - 2. Better programs, more interest.

Miss Horr - 3. Limited study groups form a basis of Leagues.

Open League programs with fees for non members.

Analysis --- Membership decreased in relation to dues. Limited membership problem local, difference in rural district and cities. Meeting place a real problem of rural Leagues. Standards.

IT WAS VOTED upon motion of Mrs. Cant, second of Mrs. Stakman that Standards be left to a committee to be appointed to draw up Standards. The following points were suggested for consideration by the committee:

- 1. At least 10 members, eight meetings, some assimption of quota first year, and at least every member VOTER subscriber.
- Mrs. Swain 2. Lesser number of meetings, 6 general meetings; a minimum requirement.

Miss Wells 3. Must have Board meetings.

Miss Horr 4. Except for towns of over 1000, - \$1.00 dues.

Miss Wells 5. Failure to maintain standards permits the dropping of Leagues by State Board. Recommending that no group shall remain a Study group after period of one year.

RECESSED FOR LUNCHEON

Immediately following luncheon Mrs. Silas Bryan, radio chairman, presented the outline for a series of radio programs which are to be given by the League of Women Voters every Tuesday at 4 O'clock, station WCCO for 14 weeks. The approval of the Board was unanimous to the program as outlined.

Authorization was given for the printing of leaflets listing the radio programs to be sent out to the Leagues.

Miss Mitchell was also authorized to appoint a committee of three to analyze the VOTER. One of the three to be Mrs. Blakey. IT WAS SO VOTED upon motion of Mrs. Swain, second of Mrs. Beard.

Miss Wells explained the Copeland Bill. She also suggested a survey project as to tax delinquency which are due to special assessments.

Announcement was made that Miss Child has accepted a position as executive secretary of the New York City League of Women Voters.

IT WAS VOTED upon motion of Miss Wells, second of Mrs. Beard, that the meeting be adjourned at 2:30 p.m.

Methods of increasing the State League income wxx generally discussed.

Mrs. Underwood said, "Should make local Leagues feel it is a pleasant duty to meet their quota." IT WAS VOTED upon motion of Mrs. Musser, second of Mrs. Townley that the Board make every effort to contact local Leagues to find a way for them to make extra money to turn over to the State League.

It was also recommended that an analysis of the expenditure of the quota be made available for local Leagues.

Department Chairmen reports:

Mrs. Musser read a letter from Miss Sherwin announcing the support of the National League to Senate File 2000, which is the Copeland-Tugwell Bill, a great gain over the Food and Drugs Act of 1906. The Food and Drug Bill does not cover radio and magazine advertisement. Local Leagues are urged to write congressmen for copies of Bill, also to work for appropriations for the Bureau of Home Economics. Read appropriation for this Bureau for several years and note increasing cuts.

Mrs. Pearce obtained from the State Department of Education a summary report on the activities on # Education of the Unemployed Youth in Minn.

IT WAS VOTED upon motion of Mrs. Pearce, second of Mrs. Musser that the report be mimeographed. Mrs. Underwood volunteered to mimeograph such a letter as Mrs. Pearce might prepare, to be available from the office on request.

Dr. Boynton called the attention to the new publication "Children in Industry" by Mrs. Mangold. The question was raised "what is the child labor problem in Minnesota. Where do children work?" Answer: "Several seasonal canning factories, beet fields. A medium of legal evasion-the apprentice."

Letters: The Secretary read a letter from Cordell Hull to Mrs. Hertz; also a letter from Miss Sherwin acknowledging Miss Mitchell's letter of inquiry as to the attitude of the National League toward the Vinson Bill. The letter from Miss Sherwin was also read which urged that letters be sent to congressmen urging the restoration of \$2,110,000 to the appropriations for the Federal-State Employment Offices.

Field Report: Miss Horr reported four new Leagues--Red Wing, Robbinsdale, Rochester, Sauk Centre. Upon the recommendation of Miss Horr, Miss Wells moved that the Kasson League, at their own request, be dropped from the list of active Leagues. This motion was seconded by Mrs. Underwood and carried.

The minutes of the April Board meeting were read and approved.

Finance:

The treasurer's report was read by Mrs. Cant and upon motion of Mrs. Hampton, second of Dr. Boynton, was accepted and ordered placed on file, all bills to be paid where possible.

A convention report on Finance was given by Miss Mitchell who announced that the proposed national membership dues of \$1.00 was voted down, and there is a new set up of a department of finance with national, state, and local chairmen the same as all departments of the league.

Organization

Miss Horr reported ten local leagues have paid full quotas and sixteen have paid what they assumed. Three leagues have held more than 15 meetings, six leagues have less than ten VOTER subscriptions. In the absence of Mrs. Winter, Mrs. Towler was appointed secretary pro tem. The minutes of the May meeting of the Board were read and approved.

Finance - The treasurer's report was read by Mrs. Cant and upon motion of Mrs. Swain, second of Dr. Boynton, was accepted and ordered placed on file, all bills to be paid where possible.

Mrs. Cant explained the new national set-up for finances providing for a state finance committee to be set up and a sopy of the budget sent to the National League. Four letters per year will come from National. It was decided that the set-up for the state will include a

Finance Committee of chairmen from local leagues and also a state executive committee of about five appointed by the Board. This organization
was postponed until fall.

Upon motion of Mrs. Cant, second of Dr. Boynton, it was voted to drop the Detroit Lakes League.

Miss Horr reported on the group meetings held during May. More than 600 women were contacted in seven meetings. Last year 812 people were contacted in twelve towns. MissHorr feels that several speakers are better than one. Mrs. Swain reported the Winona meeting as very successful in arousing interest. Miss Horr recommended that district chairmen have

chafge another year and Mrs. Cant recommended that discussion of local problems be encouraged.

A letter of resignation from the State Board was read by the secretary from Mrs.Scholpp, chairman of the Second District. It was moved by Mrs. Botsford and seconded by Mrs. Denny that it be accepted with regret.

There was some discussion of a possible successor to Mrs.

Scholpp, and it was decided to leave the choice until the August meeting.

Miss Mitchell reported that the executive committee recommended to the Board the discontinuation of the booth at the State Fair.

Mrs. Swain moved, seconded by Dr. Boynton, that the recommendation be adopted.

Mrs. Cant moved a state-wide campaign for a week of literature-selling by means of booths in stores, etc. be tried in the fall before elections, which was seconded by Mrs. Denny.

State Convention

The executive committee recommended that the State Convention be held in Minneapolis the last week in September or the first week in October. Communitations

Dr. Boynton presented to the Board the problem of Public Health nurses in the state being replaced by relief workers who are not trained for public health work, and suggested approach to Mr. Youngdahl and a letter to local leagues asking them to be on guard against this situation.

Mrs. Cant moved that such a letter be sent, seconded by Mrs. Stakman.

Dr. Boynton reported a letter sent to Governor Olson asking appointment of a qualified person as Head of the Red Wing Training School for Boys. Mrs. Stakman reported that due to outside pressure, an appointment has been made, apparently suitable. STATE BOARD MINUTES August 10, 1934

The regular meeting of the State Board of the Minnesota League of .
Women Voters was held at the home of Mrs. Harold G. Cant on Friday, August 10th, 1934. It was called to order at 10:30 a.m., Miss Mitchell presiding.

Members present: Miss Mitchell, Mrs. Cant, Mrs. Richards, Mrs. Stakman, Mrs. Huntley, Mrs. Musser, Mrs. Pearce, Mrs. Denny, Mrs. Beard, Mrs. Hertz, Mrs. Underwood, Miss Horr, and Miss Lamson. Miss Emily Child came for luncheon.

In the absence of the secretary, Mrs. Hertz was appointed secretary pro tem. The minutes of the June meeting of the Board were read and approved.

Finance

The treasurer's report was read by Mrs. Cant. The balance July 1st
was \$172.36. Receipts during July amounted to \$134.41, of which \$26.00
was received from quotas. Disbursements totaled \$273.66, leaving a balance
August 1st of \$33.11. It was moved by Mrs. Stakman, seconded by Mrs. Richards,
that the report be accepted and ordered placed on file, all bills to be paid
where possible.

Mrs. Cant read the Quarterly Finance Report of the National League.

Mrs. Cant read a letter from the Maine League of Women Voters describing and requesting the coingular device for carrying yarn which it is selling and requesting the cooperation of the Minnesota League. It was moved by Mrs. Cant, seconded by
Mrs. Musser, that the state league order ten of the devices to be used as
samples to acquaint the women of the state with them. If local leagues
wish to sell them they may order more direct from the Maine League.

Miss Mitchell reported a letter from the Cleveland League concerning the sale of their calendars in Minnesota at Christmas time. Mrs. Underwood reported on a calendar which she and Miss Horr have been working on to show election activities in Minnesota for the following year. Suggestions were made by various Board members as to size, arrangement, etc. of the calendar. It was the feeling of the Board that Mrs. Underwood should progress further with her work and report to the next meeting on the probably cost.

Organization

Miss Mitchell reported that the executive committee recommends Mrs. B. W. Musser of Wells as chairman of the Second District to fill the vacancy left by the resignation of Mrs. Scholpp. It was moved by Mrs. Cant, seconded by Mrs. Stakman that the recommendation be accepted.

The secretary read a letter from Mrs. D. L. Fairchild of Willmar, resigning her office as chairman of the Seventh District. It was moved by Mrs. Pearce, seconded by Mrs. Denny, that the resignation be accepted with regret. Since this office is one of those to be filled by the convention this year, the executive committee will make no recommendation for an appointment at this time.

Miss Mitchell reported on correspondence with the national office concerning the possible use of Miss Katherine Frederic in Minnesota in the fall. Since Miss Frederic will be in Iowa in October for a meeting of the national league, and can do some work in Wisconsin in the fall, the expense will not be a very large item. After discussion on the kind of work that she would do and a conference between Miss Horr and Ars. Cant on financing such a trip, Mrs. Can't moved and Mrs. Musser seconded that Miss Frederic be asked to come to Minnesota, the plans as to the time of her coming, and the kinds of meetings to be planned for her, to be left to the executive committee.

Proposed Program of Work

MissrMitchell circulated copies of the tentative program which had been compiled from the suggestions submitted by the department chairmen. Mrs. Richards spoke on the item on a commission for tax revision. The Commission should be appointed by the governor and should consist of representatives of all the various tax groups. It would thus unify all the groups working for tax revision and would make suggestions for legislation which all groups could support. The League's tax support items would be decided after the commission had reported. Such a commission should be appointed soon so that

it would have proposals ready to submit to the legislature this winter.

Mrs. Pearce spoke on the item on revision of state aid for schools. She reported a conference with former Commissioner of Education Phillips who said that Mr. Utne, a member of the department, is now making a study of state aid and that the department will probably submit a bill to the legislature. Because of changes of personnel on the State Board of Education, Mrs. Pearce feels that the department requires very careful watching.

There was a general discussion of the item on unemployment relief.

Mrs. Pearce urged that League members be watchful of the attempt of counties to replace their permanent child welfare worker with a relief worker paid from federal funds. This is the same situation as that Dr. Boynton reported to the last Board meeting with reference to public health nurses.

Mrs. Denny and Mrs. Stakman reported that discrimination against married women in public office must be watched next year even more closely than before. Mrs. Richards reported that the County Surveys show that jury service for women has not been neglected locally but that maternity and infancy and child welfare work has.

Discussion of the new form of the program was very favorable.

Miss Mitchell reported that Dr. Boynton and Miss Burton feel the need of a bill prohibiting children from appearing in night clubs. This item would come under continued support of measures already enacted with League support, i.e., child labor laws. Dr. Boynton's recommendation for support of an appropriation for venereal diseases was rejected for the present because of the absence of Dr. Boynton and because of the general feeling that other groups were working for it and that it might hurt the League's work for the maternity and infancy appropriation.

Mrs. Towler had suggested items on old age pensions and minimum wage, both of which were rejected for the present.

It was the feeling of the Board that the items for special federal support should be included in the state program of work. Items for special study such as the arms embargo, World Court, and the Consumer should be starred for special study by local Leagues.

Mrs. Can't mentioned the possibility of a different arrangement of the program to conform more nearly to the National form.

It was moved by Mrs. Cant, seconded by Mrs. Beard that the Proposed Program of Work be approved by the State Board and sent to the local Leagues. Convention

After luncheon Miss Mitchell reported that the executive committee had found it necessary to change the dates for the convention set by the last Board meeting from October 3 - 5th to October 2 - 4th, because of a conflict with the state convention of the Federation of Women's Clubs.

Mrs. Cant rescinded her motion made at the last meeting, seconded by Mrs. Underwood. Mrs. Cant then moved, seconded by Mrs. Underwood that the convention dates be October 2 - 4th. Mrs. Richards moved and Mrs. Stakman seconded that the state board accept the invitation of the Minneapolis

League to hold the convention in Minneapolis. Miss Mitchell announced that Miss Mary Warren has been appointed general chairman of the convention.

Miss Mitchell reported that the executive committee recommends that Mrs. D. E. Crary of St. Cloud be appointed chairman of the budget committee Mrs. B. W. Musser of Wells chairman of the nominating committee, and Mrs. W. E. Morris of St. Paul, chairman of printed material. It was moved by Mrs. Stakman, seconded by Mrs. Underwood that the recommendations be accepted.

It was moved by Mrs. Richards, seconded by Mrs. Musser that the executive committee act as the program committee, as has been the procedure in former years.

Miss Mitchell asked for recommendations for the membership of the nominating committee. Those suggested were:

It was moved by Mrs. Stakman, seconded by Mrs. Cant, that those proposed be asked to serve on the committee.

It was moved by Mrs. Musser, seconded by Mrs. Underwood that Mrs. Frost of Wabasha be asked to give the response ot the welcome.

There was discussion on holding the Fireside Supper the last night of the convention and of charging for it. Miss Mitchell reported that she had asked Mrs. Huntley to have charge of the stunt for it. Miss Warren has suggested that the Fireside supper be held in the Lounge of the Women's club instead of in a private home.

There was discussion of the necessity of having an outside speaker.

It was felt that it was necessary as a drawing card for local Leagues.

It was suggested that the committee try to secure a speaker on the merit system.

Mrs. Underwood gave the report of the committee composed of herself,
Mrs. Swain, and Mrs. Botsford to study the possibility of limiting the
number of delegates from local Leagues and the possibility of holding
a state convention in alternate years. The report recommends limiting
the number according to quota paid in the previous year, one delegate per
\$10.00. This would not apply to the city leagues. Miss Horr suggested
another plan, combining membership and quota as the basis for the number
of delegates, namely, one delegate for the first ten members, one for the
next ten members, one for the next ten and thereafter one for each additional fifty members. An extra delegate would be allowed to all Leagues
which had paid their quotas in full and an additional delegate for paying

more than quota. All delegates would be in addition to the state

Board members and the local League presidents. Board members were

asked to study these plans and action will be taken at the September

meeting.

The committee recommends that the convention be held in alternate years and in the off year a Council meeting be held. This would relieve the two city Leagues of the responsibility of holding a convention every other year and would permit the holding of Council meetings in the smaller towns. No action was taken, but it was laid over until the September meeting.

Mrs. Richards spoke on an amendment which will be before the voters in the fall election to abolish the personal property tax and the tax on farm machinery. This is advisable because of the difficulty of administering it and its repeal might aid the county assessor plan. The does not support constitutional amendments but conducts educational work on them.

Miss Mitchell mentioned the radio talks in the "You and Your Government" series sponsored by the National Municipal League which are carried over KSTP at 5:30 Tuesday afternoons.

Miss Mitchell recommended the appointment of a reading committee for Mrs. Towler's new mimeograph on Unemployment Insurance, consisting of Miss Alice Kercher, Mrs. Luwe, and Mrs. Hertz. It was moved by Mrs. Musser, seconded by Mrs. Beard that the recommendation be accepted.

A vote of thanks to Mrs. Cant for entertaining the Board was moved by Mrs. Beard, seconded by Mrs. Musser.

Disbursements totaled \$145.42, leaving a balance September 1st of \$182.91. Bills payable September 1st amounted to \$865.69. Finance

Mrs. Cant read the treasurer's report, in the absence of Mrs.

Jennings. Mrs. Swain moved, seconded by Mrs. O'Neil that the report be accepted and ordered placed on file, all bills to be paid where possible.

Organization

Miss Horr reported that the Robbinsdale and Redwood Falls Leagues had held meetings and voted to disband and recommended that they be dropped from the list of local Leagues in the state. Dr. Boynton thereupon moved, seconded by Mrs. O'Neil, that the Robbinsdale League be dropped. Carried. Mrs. Swain moved, seconded by Mrs. Beard, that the Redwood Falls League be dropped.

Miss Horr reported that the Marshall League has organized an evening group of teachers.

A speakers' list to be sent to local Leagues, prepared by Mrs.

Towler, was read by the secretary, and suggestions for additions were made
by the Board. It was decided that local Leagues should be responsible for
the expenses of speakers. After discussion as to what constitutes expenses,
Mrs. Pearce moved, seconded by Dr. Boynton, that expenses be a mileage maximum of 4¢ a mile or bus or train fare.

New material on Arguments for and Against the Feasibility of Blanket and
Tax Limitation laws, the present state income tax law was reported. Miss Horr called attention to a correction in the explanation of the department of Government and Economic Welfare.

Miss Mitchell reported that the executive committee had decided to hold the open February Board meeting and luncheon at the St. Paul Hotel. After discussion, Mrs. D'Něil moved, seconded by Mrs. Wright, that an attempt be made to secure a speaker or speakers on Reliefffor the luncheon meeting.

Direction of Legislative Drive

Mrs. Pearce reported that she had received copies of some of the

bills to be proposed by the Department of Education. Although the Board of

Education has not yet passed upon the Larger Units Bill, probably the same

bill that was introduced two years ago will be introduced. This is a permissive bill only.

Several bills leading to a revision of state aid for schools will be intriduced, probably by Mr. Wahlstrand. One will state that state aid will be apportioned according to the number of pupils of school age in public schools and another that no state aid will be given unless the tax levy for school purposes amounts to 5 mills.

Mrs. Richards asked what stand the League should take, if any, in regard to the proposed abolition of the Commission of Administration and Finance. It was suggested that mere personalities should be distinguished from the principle of having such a Department, and it was decided that if the matter came up in the legislature the League should oppose abolition by speaking at hearings, etc.

Mrs. Richards reported an interview with Mr. Quinlivan who said that this seemed to be a favorable year for the County Assessor Bill, but recommended waiting until the tax committee and the committee on towns and counties are appointed, then, if the personnel is favorable, try to get the committees to sponsor such a bill.

Miss Mitchell reported a request from Mr. Schulz of the M. E. A. asking permission to reprint the League's County Assessor poster in the February issue of thier Journal. The Board gave such permission.

It was suggested that the speaker of the House be contacted as to appointment of a Commission for Tax Reviwion, or else that the tax committee of the House be asked to recommend appointment of such a Commission.

It was suggested that the Governor's message might be analyzed for the VOTER, and that a letter be written him recalling the answers to his questionnaire and analyzing his message.

Dr. Boynton reported that \$56,000 for the biennium was appropriated for maternity and infancy work by the 1933 legislature, and that the Division of Child Hygiene this year asked for an appropriation of \$67,000, which was cut by the budget commissioner to \$64,000. At present the Division is able to fill only about 50% of the requests for literature which it receives, due to lack of funds for printing, and mailing.

Mrs. Wright reported briefly on her department. Miss Mitchell reported a letter authorized by the executive committee to the Governor in regard to the vacancy in the position formerly held by Mr. Murray who has gone to Washington.

Woman Voter

Mrs. Blakey asked about articles for the VOTER. Mrs. Richards was asked to prepare something on maintenance of the Commission of Administration and Finance, Mrs. Pearce on Larger Units, and Dr. Boynton on Child Welfare.

Dr. Boynton reported on the Legislative Council, its organization and the organizations represented.

I Mrs. Winter reported briefly on her examination and compilation of the replies of legislators to questionnaires and also to interviews conducted by local Leagues.

International Cooperation

Miss Mitchell reported a Regional Cause and Cure of War Conference to be held in Chicago, February 1 and 2. If any local League members can go, they should report to the state office or to Mrs. Hertz.

Miss Mitchell reported a letter from the national League asking support of an appropriation of \$100,000 to continue the Nye munitions investigation. Letters have been written Senators Shipstead and Schall.

Members Present: Miss Mitchell, Mrs. Cant, Mrs. Denny, Dr. Boynton, Mrs. Beard, Mrs. Richards, Mrs. Jennings, Mrs. Swain, Miss Rowell, Mrs. Blakey, Mrs. Stakman, Mrs. O'Malley, Mrs. Luwe, Mrs. Pearce, Mrs. Keyes, Mrs. Grannis, Miss Hill, Mrs. Towler, Mrs. Hertz, Dr. Monahan, and Mrs. Winter.

The following 24 Leagues were represented: Bemidji, Glenwood, Litchfield, Willmar, Marshall, Winona, Wabasha, Northfield, South St. Paul, Chaska, Shakopee, New Prague, Minneapolis, St. Paul, Duluth, Columbia Heights, St. Cloud, Mankato, Farmington, Benson, Faribault, Red Wing, Norseland, Kenyon.

Mrs. Cant moved, seconded by Mrs. Denny, that the minutes of the January Board meeting be omitted, since copies had been mailed to all the Board members. Carried.

Finance

The treasurer's report was read by Mrs. Jennings. Mrs. Swain moved, seconded by Mrs. Cant that the report be accepted and ordered placed on file, all bills to be paid where possible.

Mrs. Cant spoke on finance and emphasized the importance of securing contributions to finance the work of the League.

Department Chairmen Reports

Mrs. Hertz reported on the activities of the department of Government and International Cooperation. She spoke of the defeat of the World Court and quoted Miss Well's statement that fear was the cause of the defeat. She told of the work of the National League in securing telegrams from local Leagues to doubtful senators and sending letters of congratulation to our senators who had voted for the Court. Suggested sending letters to our senators expressing disapproval of vote.

A new pamphlet published by the National League, Control of the Munitions Traffic, was announced. Mrs. Hertz urged local Leagues to form study groups to study this subject and report their findings as to the best method of control to the national League by April first so that the National Board will be better able to judge which type of control it will support.

Since Mrs. Luwe was not present, Miss Mitchell announced that Mrs. Luwe's recent radio talk opposing the Equal Rights amendment to the Constitution had been mimeographed and is for sale at the state office. Miss Horr sketched the background of the Five Day Waiting Period Law and asked local Leagues to be on guard against its repeal. Local Leagues were asked to find out in how many cases licenses had been refused and why, since the law was passed, and how many waivers have been granted and for what reasons.

Dr. Boynton reported on the activities of the department of Government and Child Welfare. The amount allowed in the budget submitted to the legislature for the Division of Child Hygiene for maternity and infancy work is \$64,000 for the next biennium which is not adequate but is a slight increase over the last two years.

Dr. Boynton reported that the national League is supporting Title VII sections 701 and 704 of the Economic Security bill which provide for federal aid for maternal and child welfare, \$20,000 to be distributed to each state annually with an additional amount to be distributed dollar for dollar as it is matched by the states. She urged local Leagues to write to their representatives urging support of these provisions of the bill.

Dr. Boynton explained the changes in the administration of the Mothers' Aid law proposed by the Committee on Services to Children of the State Conference of Social Work, and after discussion moved that the Board, upon the recommendation of the executive committee, support these changes. The motion was seconded by Mrs. Grannis and carried.

A visiting local League member asked about supporting an appropriation for the Institute of Child Welfare. Dr. Boynton explained that this item is not on our support program and therefore cannot be supported as a League measure, but that individuals might support it personally if they wished. In Mrs. Wright's absence, Mrs. Towler reported that the National League is supporting the unemployment insurance provisions of the Economic Security Bill which provide for a federal tax of 3 per cent on payrolls. The national League is also supporting Senate File No. 5, the Copeland Food and Drug Bill.

bill introduced amending the minimum wage law to define the term "minor" to mean either a male or female under 21 years of age, for the purposes of this law. The bill is now in committee. She reported that a bill has also been introduced to amend the 54 hour bill to provide for a 48-hour week and a 9 hour daily limitation. Miss Mitchell reported that the executive committee recommended that the Board authorize the committee to support these two bills by having someone speak for the League's stand in the past at the committee hearings. Dr. Boynton thereupon moved, seconded by Mrs. Swain that the League be represented at the hearing on the amendment to the minimum wage law. Carried. Dr. Boynton thereupon moved, seconded by Mrs. Jennings that the League be represented at the committee hearing on the hour limitation law. Carried.

Mrs. Richards reported that so far no county assessor bill has been introduced. The Tax Commission has never introduced such a bill, although it has recommended it and if the League would prepare the bill, the Commission will see that it is introduced. Mrs. Richards called attention to the publications of the Institute of Governmental Research on tax proposals and urged study of the various tax measures before the legislature, expecially tax limitation bills.

Dr. Monahan and Miss Horr reported a hearing by the House Committee on Education of the Larger Unit bill. They explained that the bill is only permissive and leaves the establishment of the county unit for all



districts under 2500 population to the referendum of the people of the county.

Mrs. Beard, special chairman of the Civil Service, reported the opening of the National League's two-year campaign for Trained Personnel. She also spoke of the Ericsson Bills, one for an amendment to the state constitution providing for civil service regulation and the other establishing a civil service commission with regulatory powers. These bills are still in committee. She explained that an objectionable feature of the constitutional amendment is that it gives preference to all honorably discharged soldiers and sailors.

After announcements, adjournment was taken for luncheon.

The Board reconvened for a short meeting at the State Capitol after luncheon to discuss possible support of the bill for increased state aid to schools proposed by the Citizens' Committee for Public School Finance,
H. F. 382. After discussion, and with the recommendation of Mrs. Pearce,
Mrs. Denny moved, seconded by Mrs. Towler that the League support this bill under the item for Revision of State Aid to Schools. An amendment to this motion was made by Mrs. Richards, seconded by Mrs. Cant, making clear that the League in no way supports legislation by which this appropriation should raised and if this bill should become a part of a tax replacement bill, then the Board reconsiders its support.

The meeting thereupon adjourned.

The regular meeting of the State Board of the Minnesota League of Women Voters was held at the Minneapolis Y.W. C. A. On Friday, March 8, 1935. It was called to order at 10:00 a.m., Miss Mitchell presiding.

Members Present: Miss Mitchell, Mrs. Cant, Mrs. Towler, Mrs. Musser, Mrs. Swain, Mrs. Underwood, Dr. Boynton, Mrs. O'Malley, Mrs. Winter, Mrs. Wright, and Miss Lamson: Miss Margaret Beggin, former field organizer for the State League was present as a guest.

The secretary read the minutes of the February 8th meeting which were approved.

In the absence of Mrs. Jennings, Mrs. Cant read the treasurer's report. Mrs. Swain moved, seconded by Mrs. Underwood, that the report be placed on file, all bills to be paid where possible.

Mrs. Cant outlined ways and means by which Leagues may raise money, such as assigning a quota to each study group, assigning a quota to each individual, bridge parties, cake and book sales, rummage sales, etc.

Organization
Miss Horr reported meeting with the Boards of the Rochester, St.

Cloud, Northfield, and Winona Leagues. A new evening group of business
and professional women has been organized in Northfield. She also reported
meeting with various other League, including Hutchinson, Farmington,
Benson, Minnetonka, and with six study groups in Minneapolis. Two new
Leagues have been organized at Warren and Park Rapids.

Nay Meetings

It was thought that the meetings should be neighborhood meetings rather than strictly district meetings, numbering six. Northfield, Rochester and Atwater have asked to be hostesses. Miss Horr suggested that the district chairmen and local League presidents should make plans for the meetings, the correspondence to clear through the state office.

Presidents' Conference
Miss Mitchell reported that plans have been made to hold the
annual Conference of local League presidents and district chairmen at

the home of Mrs. Paul N. Myers in St. Paul, on Thursday, March 21st, at 10:30 A.m.

There was some discussion of the Board's policy of not allowing the list of local League presidents to be made public, after which Mrs.

Beard moved that the policy be modified so that lists may not be released except by special action of the executive committee. Seconded by Mrs.

Musser, carried.

Legislative Reports of Department Chairmen

Dr. Boynton reported that the state appropriation for maternity and infancy is not being acted upon, pending action by Congress on federal aid.

The bill providing for changes in the administration of Mothers'
Aid has passed the House.

Legion Child Labor committee saying that a resolution might be introduced into the Minnesota legislature for reversal of its action in ratifying the Child Labor amendment. She reported that Mr. Sherman Child had recommended speaking to the chairmen of the Public Welfare committees in the Senate and House about the matter. Mrs. Beard thereupon moved, seconded by Mrs. Underwood, that the League write a letter to the committees on Public Welfare in the Minn. legislature in protest of any such action. Carried. Dr. Boynton reported that four states have ratified the Child Labor amendment this year: Indiana, Idaho, Utah and Wyoming.

In the absence of Mrs. Richards, Mrs. Blakey reported on the County Assessor Bill. It is the feeling of experts that "County Assessor" arouses too much opposition and that a new type of bill should be introduced. Mrs. Blakey reported a conference with Professor Wm. Anderson in which he recommended a bill which would state that assessment is a state function and would call for a complete reassessment of the property of the state under the direction of supervisors appointed by

January, February, and March these assessors would work on income tax audits and the rest of the year on property assessments. If townships wanted to give up their local assessors, these district assessors would take over the entire work of property assessment. This plan would call for an appropriation of \$100,000 for the Tax Commission but this amount would probably be more equalized by additional revenue from income taxes after a proper audit. Mr. Wallace of the Tax Commission thinks this plan is very fine, and would see that such a bill is introduced if it is prepared. Mr. Anderson is now engaged in writing such a bill.

After discussion, Mrs. Beard moved that the entire matter be left to the executive committee with the advice of such additional persons as may be necessary. Seconded by Mrs. Musser. Carried.

Mrs. Wright reported on the support of national items under her department. The League is supporting S. 5, the Copeland food and drug bill. She called attention to the new kit put out by the National League on this bill. She also reported on the unemployment insurance provisions of the economic security bill and the labeling provisions of the canners code.

Miss Mitchell reported that the sum of \$200,000 for the biennium has been recommended by the Appropriations Committee for the state employment offices.

Mrs. Towler reported that she and Dr. Monahan had attended various committee meetings on the minimum wage amendment and on the 48 hour law, but as yet no action has been taken. Miss litchell asked whether local Leagues could support a 48 hour bill. Mrs. Swain thought that they could.

In the absence of Mrs. Luwe, Miss Horr reported that as yet no bill has been introduced repealing the Five-Day Waigint Period Law and

probably there is no danger now. The secretary read a letter addressed to Mrs. O'malley for the Equal Rights amendment to the federal constitution.

Mrs. Beard reported a committee hearing on the Civil Service law now before the legislature. Although a quorum was not present, Mr. Fuller, Mr. Lambie, and Professor Field were present and made recommendations to the committee in line with the League's opinions. She said that there seemed to be a willingness on the part of the committee members to cooperate with Mr. Eriksson and to listen to suggested changes.

In the absence of Mrs. Pearce, Miss Horr reported on the education measures. The Larger Unit Bill was first brought up in committee Feb.

14th, at which time Mr. Campton was present spoke for the bill and members of rural school boards spoke in opposition to the bill. On March 7th it was again discussed and a sub-committee appointed which will probably suggest amending the bill so that it will apply only to counties containing unorganized school districts, which number 16 at present. The sub-committee will probably report back to the committee on March 14th.

Senator Almen, chairman of the education committee in the senate, says that he is in favor of larger units but not the county unit, and therefor refuses to bring it up in the committee. Mrs. Swain volunteered to ask Senator Galvin who is a member of the committee to bring it up for discussion in committee.

Miss Horr reported that Mrs. Pearce recommends that the League support four bills pertaining to the revision of state aid for schools.

H.F.815 - revising special state aid to schools

H.F.816 - limitation of tax rate on agricultural land

H.F.846 - Classification and definition of public schools

H.F.862 - limits apportionment to schools maintaining 8 months school instead of 7 and according to pupils in agverage daily attendance.

Mrs. Denny reported that H.F.382 for increased state aid to schools is out of the education committee and in the appropriations committee.

Recess was taken for luncheon after which Mrs. Marcley reported informally on the Tenth Annual Cause and Cure of War Conference at which she represented the League.

On motion of Mrs. Musser, the meeting adjourned at 2:30 p.m.

The minutes of the meeting of March 8th were read by the secretary and approved.

In the absence of Mrs. Jennings and Mrs. Cant, Miss Lamson read the treasurer's report. Mrs. Richards thereupon moved, seconded by Dr. Boynton, that the treasurer's report be accepted and ordered placed on file, all bills to be paid when possible.

Mrs. Musser moved, seconded by Mrs. Beard, that the League pay \$5.00 apiece to the two girls who have been assisting this spring in the office for the experience without pay.

Department Chairmen reports on State Legislation

Dr. Boynton reported that the appropriation for state maternity and infancy work was cut by the Senate Finance Committee from the \$32,000 asked for to \$15,000 a year. Members of the House committee have been contacted and local Leagues have been asked to write to their representatives on this committee. The appropriation bill will now probably go to a conference Committee.

Dr. Boynton read a letter from Miss Clevenger of the Committee on Services to Children of the State Conference of Social Work stating that three of the four bills sponsored by the committee have passed the legislature. The fourth, calling for an appropriation to the counties for mother's aid is being held up pending Congressional action on the Economic Security bill.

Dr. Boynton reported that May 12th has been designated as Child Health Day and asked that local Leagues cooperate in stimulating interest in the promotion of Child Health.

Miss Mitchell remarked upon the fine response she has had from local Leagues about writing to their representatives on the House Appropriation Committee about the maternity and infancy appropriation.

In the absence of Mrs. Pearce, Miss Horr reported on the Education bills. Mrs. Pearce spoke at committee hearings on the County Unit bill in both the S nate and House committees. Mrs. Musser, Mrs. Swain, and Mrs. Enersen who had reps on the Senate committee were also present at the hearing. The bill was reported out of the House Committee as a committee bills and put on Special Orders where it was amended in minor matters. The Senate Committee voted to indefinitely postpone the bill. The Senate as a whole was not in favor of the bill and undoubtedly it would not have passed. Miss Horr emphasized that from her experience in lobbying for this bill, it was the education of legislators by their own constituents which counted most. All League members must be prepared to talk to legislators on League measures.

There was some discussion of the position of the League as a member of the Citizens' Committee on Public School Finance, since publicity has indicated that the Citizens' Committee is supporting the Omnibus Tax bill. It was felt that since H.F. 382 is now probably dead, the League is no longer involved.

Miss Horr reported on the bills for Revision of State Aid to Schools.

H. F. 815 revising special state aid has passed the House and is on Special Orders in the Senate. H.F. 816 relating to taxation of agricultural lands passed the House but was recalled and sent back to committee where it was amended. It was reported favorably in the Senate as a committee bill. H.F. 846 permitting 6 year high schools has passed the Senate and is on Special Orders in the House. H.F. 862 relating to apportionment of state aid is on Special Orders in the House and General Orders in the Senate.

Miss Horr also reported on the attempted repeal of the Five Day Waiting Period law. The League and other groups were represented at a hearing on the bill before the Senate Public Welfare committee which voted to indefinitely postpone the bill to repeal. It was recommended without report in the House, so there is a possibility that a hearing may be demanded there.

Mrs. Harington Beard reported on the Civil Service bill which has been reported favorably from Committee in the House but is not yet out of committee in the Senate. She stated that in its present form it is an excellent bill which should be strongly supported by the League another year, since there is little chance of its passage this session.

Miss Mitchell reported for Dr. Monahan that the bill for a 48 hour week for women has passed the Senate with the 9 hour daily limitation removed, but is still on General Orders in the House. The amendment to the minimum wage law has been on the Senate Calendar for some time, but has not yet come up for passage.

Mrs. W. B. Richards reported on the Omnibus tex bill, describing the different provisions relating to the gross earnings tax, inheritance tax, gift tax, income tax, sales tax, occupational tax, and check tax. The bill is designed to abolish the state property tax and to raise 23 million dollars. Any funds remaining after expenses of state government are paid will go to schools as additional state aid. The bill has passed the House by a vote of 68 to 53.

National League Council meeting

be held in Washington May 7 - 10. Mrs. Richards moved, seconded by Mrs. Denny, 5 that Mrs. Mary K. Swain be appointed as a delegate from the state Board. Mrs. Musser moved, seconded by Mrs. Richards, that the Executive Committee be empowered to appoint the other delegate, or both in case Mrs. Swain is unable to go.

Proposed Revision of National Program of Work

Operation "Reform of tax systems to provide adequate revenue for essential governmental services through an equitable distribution of the tax burden" by adding as standards: (a) Opposition to the principle of the sales tax, (b) Opposition to tax limitation legislation, (c) Approval of the principle of the graduated income tax."

There was some discussion of these standards item by item. The conclusion as to (a) was that it should be better worded so that the principle was defined or explained. There was general approval of the other two items.

Under the dept. of Govt. and Child Welfare it is proposed to change the last three items under Recommended for Support from "State" to "Federal, State, and Local" and to make provision for federal child labor legislation in case the amendment should be ratified by a sufficient number of states. This change was approved by the Board.

Under the dept. of Govt. and Economic Welfare it is recommended to move "Old Age Pensions from "State" to "Federal-State". There was general approval of this change.

Under the department of Govt. and International Cooperation it is proposed to clarify the item under Study "The Foreign Policy of the United States and Its Conduct" by adding "Treaty Making Powers of the Senate", "Neutrality", and "Appropriations for the State Department". Mrs. Hertz felt that these were very good changes and the Board agreed.

After luncheon Miss Horr reported on the trips she had made to local Leagues during the last month and recommended that the Montevideo League be dropped, since it has been inactive for over a year. Mrs. Musser thereupon moved that Montevideo League be dropped from the list of active Leagues in the state.

Mrs. Towler seconded the motion which carried.

Miss Horr reported plans for the annual May meetings throughout the state

It is planned to have seven meetings this year at Rochester, Northfield, Duluth,

Moorhead, Little Falls, Atwater, and Tracy.

Miss Mitchell read a letter from Miss Wells saying that Mrs. McMillan, and Mr. Mitchell, two of the members of the U.S. Civil Service Commission would be in this part of the country during July or August and suggesting that the League attempt to have a meeting for them. Mrs. Towler moved, seconded by Mrs. Beard, that the League write to Mr. Mitchell about the possibility of the League's having a meeting for him when he is in Minnesota.

Mrs. Hertz reported on the conclusions reached by study groups on the Munitions Traffic held by various Leagues in Minnesota. She also mentioned the two recent news letters dealing with international affairs.

Miss Mitchell reported a letter from Miss Wells asking for cooperation with other organizations in arousing interest in the Economic Security Bill. Mrs. Denny reported a public luncheon meeting on the bill which will be held April 17th at the Mpls. Y.W.C.A.

The meeting adjourned at 2:00 p. m.

The regular meeting of the State Board of the Minnesota League of Women Voters was held Friday, May 10, 1935, at the Minneapolis Y.W.C.A. It was called to order at 10:00 a.m., Miss Mitchell presiding.

Members present: Miss Mitchell, Mrs. Denny, Mrs. Underwood, Mrs. Beard, Dr. Monahan, Mrs. Botsford, Mrs. Towler, Mrs. Hertz, Mrs. Keyes, Miss Rowell, Mrs. Ryan, Mrs. Cant and Miss Horr and Miss Lamson.

In the absence of Mrs. Winter, Mrs. Towler was appointed secretary protem. The minutes of the last meeting were read and approved.

Finance

In the absence of Mrs. Jemnings, Mrs. Cant read the treasurer's report.

Mrs. Underwood moved, seconded by Mrs. Beard, that the report be accepted and
ordered placed on file, all bills to be paid where possible.

Mrs. Cant also gave her report as finance chairman, saying that the finances of the State League were in the best condition at this time that they have been for many years, due to the splendid cooperation of local Leagues in paying quotas, 17 having paid their full quotas and 17 having paid what they assumed, and also due to contributions secured by the finance committee and to the work of the Minneapolis study groups in holding money-raising activities. Our quota to the National League is paid up to July 1st.

Organization

Miss Horr reported that more Leagues have paid their full quotas at this time than at any other time since she had been with the League.

She reported that she had attended the annual meeting of the Litchfield League, and that two of the Legislative Clinics have already been held, at Duluth May 6th and at Tracy May 8th.

Miss Mitchell reported that Mrs. Swain had been appointed a delegate to the General Council of the National League and Mrs. Paige was an official visitor.

Miss Mitchell asked the Board's opinion of the need for a rural representative on the Board, saying that legislative work this year brought out the fact that the League should have more contact with rural women. Such a representative would hold the position of special committee chairman and as such would not be a voting member of the Board. Mrs. Beard moved, seconded by Mrs. Underwood, that Mrs. Burke of Norseland be invited to visit the June, August, and September meetings of the Board to discuss with the Board possibilities for organization work among rural women.

Mrs. Botsford, seconded by Mrs. Underwood, moved that Mrs. Denny be invited to attend Board meetings until the convention, since her services are invaluable to the Board.

Mrs. Denny gave a report of the Minneapolis League's annual meeting and candidates' luncheon.

Plans for State Convention

Miss Mitchell reported that the convention will be held in St. Paul this year. There was some discussion as to dates, after which Mrs. Botsford moved, seconded by Mrs. Beard, that the convention be held the last week in September, which was carried. Mrs. Underwood moved, seconded by Mrs. Hertz, that the convention be held September 24, 25, and 26 if agreeable to the St. Paul League.

Miss Rowell reported that the College League Conference will be held at Mankato Teachers' College October 18 and 19. She reported that many of the colleges have been holding meetings for seniors with League speakers on how

they can be effective in their communities, after they leave college.

Congressional Measures

Mrs. Beard reported a hearing on the Celler bill, removing the discrimination against married people of the National Economy Act, at which Mrs. Harris T. Baldwin, national legislative chairman, presented the League's viewpoint. She also mentioned Miss Frederic's New book, "Trained Personnel for Public Service".

Miss Mitchell reported that the state convention of the Business and

Professional Women's Clubs will be held in Virginia May 25th, and will probably take a stand either for or against the "Equal Rights" amendment to the federal constitution. Letters have been sent to all local League Legal Status chairmen asking them to get in touch with delegates from their communities and educate them on this proposed amendment.

The secretary read a letter from Miss Wells on the weakening amendments to the Copeland Food, Drugs, and Cosmetics bill, urging Leagues to arouse interest in their senator's minds in reviving the unweakened Copeland bill. Miss Rowell thereupon moved that a wire be sent to Mrs. Swain, giving her the authority to interview our Senators on this matter, according to whatever plans the national League may have. Seconded by Mrs. Cant. Carried.

Mrs. Hertz read a letter from Mrs. Quincy Wright answering Mrs. Under-wood's question as to the League's power to support national legislation on munitions. The item "Government control of manufacture and shipment of arms" would cover such legislation.

Calendar Project

Mrs. Underwood reported on the Calendar project upon which she has been working and outlined her plans for a "Trained Personnel" calendar to be sold by committee be appointed to investigate costs and to the Minnesota League. After discussion, Mrs. Beard moved that a report to the June Board meeting. Miss Rowell seconded the motion which carried. It was suggested that the committee contact Cleveland and Missouri about costs. Miss Mitchell suggested that the committee confer with the St. Paul and Minneapolis Leagues and perhaps work out some joint finance plan.

Interim Tax Commission

Miss Mitchell asked the Board's opinion of the responsibility of the League for the work of the Interim Tax Commission appointed by the legislature.

Program of Work for 1935-36

There was general discussion of the items which would be included in the program of work for next year, and as to the form of the program. Mrs. Cant suggested grouping all items under three heads, Increased Governmental Services, Reduction of Governmental Expense, Administrative Methods. The regular meeting of the State Board of the Minnesota League of Women Voters was held on Friday, August 9, 1935 at the home of Miss Marguerite M. Wells. It was called to order at 10:00 a. m., Miss Mitchell, presiding.

Members Present: Miss Mitchell, Mrs. Musser, Miss Hill, Dr. Monahan, Mrs. Swain, Mrs. Bryan, Mrs. Pearce, Mrs. Denny, Mrs. O'Malley, Mrs. Blakey, Mrs. Richards, Mrs. Towler, Mrs. Wright, Mrs. Grannis, Mrs. Cant, Mrs. Stakman, Miss Wells, and Miss Lamson and Miss Simmons. Mrs. D. E. Crary of St. Cloud was also present.

In the absence of the secretary, Mrs. Stakman was appointed secretary pro tem. Since copies of the minutes of the last meeting had been sent to all Board members, reading of the minutes was omitted.

Miss Lamson read the Treasurer's report for the months of June and July. Mrs. Swain moved that the treasurer's report be accepted and ordered placed on file.

Organization

Mrs. Pearce moved that Mrs. Beard and Mrs. Swain be appointed cochairmen of the Two Year Campaign for Trained Personnel in Public Service. It was emphasized that this is an opinion-forming campaign and does not involve specific support of civil service bills.

Proposed Program of Work

The Program submitted to the Board by the Department chairmen was discussed item by item.

- Improved Public Personnel It was the concensus of opinion that this item should be first on the support program.
- 2. Larger Units of School Administration Mrs. Pearce reported that the school survey forms used by the State Department of Education in its survey of 14 typical counties, have been turned over to the League. These surveys have been sent to the Leagues in 27 counties where the survey has not yet

been made, accompanied by a letter from Mrs. Pearce. It was the concensus of opinion that this item holds first place in importance of work.

- 3. Reorganization of Local Governmental Units. Mrs. Richards suggested as (a) under this item: Consolidation of counties, and as (b) Improved methods of finance; budgets, purchasing, accounting, fee system. Mrs. Cent moved, seconded by Mrs. Musser, that this item be placed on the study program.
- 4. Effective operation of federal-state employment service There was some objection to the use of the word "effective". "Efficient" was suggested instead.
- 5. Right of Women to paid public employment without discrimination. There was a great deal of discussion as to the wording of this item. Some felt that "opposition to" or "Removal of discriminations against women in public service" would be better.
- 6. Effective state and local public welfare organization There was some objection to the use of the word "effective" here too. Mrs. Wright suggested adding another sub-head, Care of Unemployables, to permit study of the permanent relief organization necessary to care for these people.
- 7. A coordinated system of state and local unemployment relief. It was suggested that "federal" be added before "state". After discussion, it was decided to omit this item from the support program and to include it in an item on Social Security on the study program.

- 1. Unemployment Insurance Mrs. Wright moved that a new item be substituted: Social Security as embodied in: (a) Unemployment insurance (b) Old age assistance, (c) Unemployment relief.or just relief.
- 2. Factors affecting the balance between production and consumption and governmental efforts to adjust them. - Mrs. Wright reported that at a conference with Mrs. Musser and Mrs. Towler, it had been felt that this item would demand too much new material and study and could be omitted.

- 3. Public utilities: Utilization of electrical resources from the standpoint of the public welfare It was the feeling of the committee composed of Mrs. Wright, Mrs. Musser, and Mrs. Towler, that this item too would demand too much new material and time to be put on the program this year, considering the extent of the program of the department of Government and Economic Welfare.
- 4. Nomination and election procedure with a view to constructive changes There was very little discussion of this item.
- 5. Taxes and Tax Trends in Minnesota It was decided to leave this item on the study program.
- 6. Federal and state activities which tend to protect the interests of the consumer. This item was left on the study program. Mrs. Wright suggested a mere general wording such as "Consumer Problems".

Mrs. Swain felt that support of the Two Year Campaign should be mentioned somewhere on the Program and it was suggested that a grouping of Responsibilities of all local Leagues could be made to include: (1) Support of the Two Year Campaign, (2) Support of Federal Measures, (3) School Survey, (4) Survey on Public Personnel.

Since no agreement on the final arrangement and wording of the program items could be reached Mrs. Crannis moved, seconded by Mrs. Musser that a committee consisting of Mrs. Towler, Mrs. Denny, and Mrs. Stakman meet with Miss Mitchell to draw up the final Proposed Program which should be sent to Board members one day before it is sent to Local Leagues.

Convention

Miss Mitchell reported that both Mrs. Gellhorn and Mrs. Quincy Wright have accepted invitations to speak at the state convention.

It was moved by Musser, seconded by Mrs. Towler, that Miss Janette Lidberg of Red Wing, be invited to give the response to Mrs. Stakman's welcome. Mrs. Wilbur Lycan of Bemidji, was named as alternate.

It was moved by Mrs. Cant, seconded by Mrs. Musser, that Mrs. W. E.

Morris of St. Paul be appointed chairman of printed material.

Mrs. Swain moved, seconded by Mrs. Grannis, that the treasurers of the Minneapolis, St. Paul, and Duluth Leagues be appointed to serve with Mrs. Crary on the budget committee.

Mrs. O'Malley suggested that the Fireside Evening be in the form of a dessert supper at the Town and Country Club, price 50¢. The Board felt that this would be satisfactory to local League delegates.

Carried.

Mrs. Beard moved, seconded by Mrs. Musser, that the leaflet on Social Security be sent to State Members, together with copies of the Slogan Contest rules, and a notice of material for sale on Trained Personnel. Mrs. Beard after discussion withdrew the above motion seconded by Mrs. Musser, and referred the matter to the executive committee.

SURVEY OF TRAINED PERSONNEL

Mrs. Beard reported on the proposed survey of Public Personnel in Minnesota and asked the advice of the Board on several points. She suggested that the survey be considered a project of the entire local League and be headed by the President or someone appointed by her. The survey will be sent to the President with a letter explaining it. Mrs. Beard asked if the Board felt it advisable to send a list of suggested appointive officials, or if the local League should be left to compile its own list. Dr. Boynton suggested that the local Leagues make their own lists and then send the lists in to the state office where the state chairmen will check them over. Mrs. Beard asked whether or not the survey should include elective officials or be limited only to appointive officials. After discussion, Mrs. Beard moved, seconded by Mrs. Musser, that the survey be confined to appointive

officials only. Carried.

Congressional Interviews

Miss Mitchell reported that material has come from the national League to aid in interviewing Congressmen on Trained Personnel and Food and Drugs regulation.

Miss Mitchell called the attention of the Board to the fact that the Chaska League was sending out questionnaires to the candidates for the legislature in their special election to fill a vacancy.

Communications

A letter was read from the Citizens' Committee on Public School Finance inviting the League to send a representative to a joint meeting of the executive and legislative committees to be held Monday, October 21st. After discussion, Mrs. Cant moved that the President be instructed to write to the Citizens' Committee that we are supporting other projects in the legislature requiring appropriations which might be jeopardized by too much emphasis on education and that the League cannot support public school finance if it is tied up with the tax question upon which the League has taken no stand as yet. The motion was seconded by Mrs. Swain and carried.

Reports of Department Chairmen

Mrs. McNally reported on the recent National League News Letter on the Neutrality Act. She also read a letter from Mrs. Wright with suggestions for the Proposed Program of Work for the department of Government and International Cooperation. She reported the new publications on the Foreign Policy of the United States available at the state office.

Dr. Boynton reported a letter from Mrs. Mangold containing suggestions for the Proposed Program of Work for the department of Government and Child Welfare. She announced the new material available, including a chart on the Social Security Act issued by the National League.

Miss Horr mentioned new material available underwriting the items on the State Program of Work.

The regular meeting of the State Board of the Minnesota League of Women Voters was heldeat the Minneapolis Y.W.C.A. on Friday, November 8th. It was called to order at ten o'clock, Miss Mitchell presiding.

Miss Leola Nelson, secretary of the All-College League Board, was a present as a guest.

Since copies of the minutes of the October meeting had been mailed to all Board members, Mrs. Ricker moved, seconded by Mrs. Congdon, that the reading of the minutes of the last meeting be omitted.

The Treasurer's Report was read by Mrs. Crosby. The balance October 1 was \$175.86. Receipts during October totaled \$1540.52, of which \$790.25 was received in quota payments. Disbursements during October amounted to \$1114.10, leaving a balance of \$602.28. Bills payable November 1 totaled \$509.47. Mrs. Cant then moved that the treasurer's report be accepted and ordered placed on 11 file.

Organization:

It was moved by Mrs. O'Neil, seconded by Miss Rowell, that Mrs.

Miss Lamson reported upon the office activities. Department material is now being mineographed on colored paper to correspond to the national League's department colors.

Discussion of Civil Service Bill

Mrs. Beard and Mrs. Richards conducted a quiz of the Board members on the Civil Service Bill Proposed for Minnesota. Mrs. Cant brought up the question of the meaning of the section guaranteeing equal status to women and asked if that meant equal rights. There was some question as to whether the veterans preference section meant that any veteran on the list had preference or only if he were among the highest three.

Miss Mitchell asked the Board their opinion as to whether the Board League should urge the civil service bill in the special session of the legislature. It was thought that this question could not be decided until it was decided whether or not the session would be limited as to subject matter, and therefore should be left to the executive committee. Mrs. Beard moved that a letter be written to local League presidents asking them to interview their legislators and educate them on the need for a civil service bill and ask for their support in case the League does wish to support such a bill. Mrs. O'Neil seconded the motion which was carried.

Educational Measures Endangered by Special Session

Mrs. Pearce reported that there is a move to repeal Chapter 289 passed at the last session which provided for limitation of the tax rate on agricultural lands in consolidated school districts. The law is opposed by county and town superintendents where the result has been higher taxation.

There is also a danger that the supplemental state aid revision act passed by the last legislature may be repealed in order to abolish full aid for

teacher training departments which that bill established.

In order to finance the Social Security Act, there is a danger that the proceeds from the income tax may be diverted from schools to this purpose.

Mrs. Cant mentioned a proposed change in the Teacher Tenure Law establishing an age limit of 55 years. It was suggested that Minneapolis, St. Paul, and Duluth Board members consult their superintendents on Teacher Tenure and come prepared to lead a discussion on possible improvements in the teacher tenure law.

Neutrality

Mrs. McNally called attention to the Kit on Neutrality recently issued by the national League and read a letter from the national chairman urging all local Leagues to form study groups to consider this subject. She also read to the Board the Ten Questions on Neutrality contained in the Kit.

Security for Children

Dr. Boynton reported that no changes would be necessary in the child welfare laws to enable Minnesota to comply with the provisions of the Social Security Act relating to children.

Campaign for Trained Personnel

Mrs. Swain called attention to the Handbook on the Campaign recently issued by the National League, and read excerpts from the "Personnel Flashes" issued by the national League. She read letters from a few local Leagues telling what they had done on the Campaign and a letter from the Kasson League suggesting a broadcast on Trained Personnel over the new radio station at Rochester.

Mrs. Beard asked that each League be asked to report the things they are doing on Trained Personnel so that a report of the state work can be sent to Washington. She read an outline of the Minneapolis League's activities on Trained Personnel.

Miss Horr called attention to the new material for sale.

College League Conference

Miss Rowell introduced, after luncheon, Miss "eola Nelson, secretary of the All-College League Board, reported on the College League Conference at Mankato. She told about the Skit Contest on Trained Personnel which the College Leagues are conducting.

Miss Horr's report

Miss Horr reported on her visit to the Montana League's convention and reported visits to Sherburn, Mankato, Wells, Red Wing, St. Paul, and the organization of a new League at Arlington. During Miss Horr's absence Mrs. Huntley visited Leagues at Bemidji and Park Rapids.

Mrs. Beard, on behalf of many of the "old timers" in League work presented a wrist watch to Helen Horr.

The regular meeting of the State Board of the Minnesota League of Women Voters was held at the Minneapolis Y.W.C.A. on Friday, December 13th, 1935. It was called to order at 10:00 a.m., Miss Mitchell presiding.

Members Present: Miss Mitchell, Mrs. McNally, Mrs. Botsford, Mrs. Musser, Mrs. Luwe, Mrs. Beard, Mrs. Crosby, Mrs. New, Mrs. Swain, Mrs. Ricker, Mrs. Bundy, Miss Rowell, Mrs. Jewett, Mrs. Cant, Dr. Boynton, Mrs. Stakman, Mrs. Keyes, Mrs. Richards, Mrs. Bryan, Mrs. Winter, and Miss Horr and Miss Lamson. Miss Wells was present for luncheon.

Mrs. Swain moved, seconded by Mrs. Botsford that reading of the minutes of the last meeting be omitted since copies had been mailed to all Board members.

Finance

Mrs. Crosby read the treasurer's report. The balance November 1 was \$602.28. Receipts during November totaled \$644.64, of which \$332.66 was received in quota payments. Disbursements during November totaled \$812.44, leaving a balance of \$434.48 December 1. Bills payable December 1 amounted to \$409.85. Mrs. Swain moved, seconded by Mrs. McNally, that the treasurer's report be accepted and ordered placed on file.

Mrs. Jewett reported upon contributions received during November and outlined her plans for securing new contributions.

Cause and Cure of War Conference

Miss Mitchell reported that the Call to the Eleventh Conference on the Cause and Cure of War to be held in Washington January 21 to 24 has been received from the national League. Each state League is allowed two delegates and two alternates. Delegates were suggested, but Mrs. Swain moved that the naming of delegates and alternates be left to the executive committee, which motion was seconded by Mrs. Bundy and carried.

Discussion of Food and Drugs Legislation

Mrs. Musser led a discussion of the necessity for new food and drugs legislation, bringing out that the present law does not include cosmetics, misleading advertising, and is difficult to enforce. A new law should include these and provide for proper labeling and grading of foods. Three bills

have been introduced, but the League is supporting Senate File 5 introduced by Senator Copeland as the best bill which stands a chance of passage. Mrs. Musser called attention to a new flier just issued by the national League, "Needed: New Food and Drugs Legislation". Miss Horr called attention to the pamphlet. "What's in a Can?"

Miss Mitchell read a letter from the national League outlining a Congressional Project in support of Food and Drugs Legislation to be carried out by local Leagues during January and February. It was the opinion of the Board that a letter should be sent to local League presidents immediately outlining the plan so that they will be ready to start the project the first part of January.

Legal Status of Women

Mrs. Luwe reported a very excellent letter written by the Ramsey
County League chairman of Government and the Legal Status of Women to the
legislative chairman of the State Federation of Business and Professional
Women, calling her attention to the League's stand in opposition to the Equal
Rights amendment and urging her to study this question.

Government and Its Operation

Mrs. Richards reported that she had looked through her files to ascertain just what the League's stand had been in supporting a state income tax, and had found that the League supported the principle of a graduated income tax but had never expressed itself as to how the funds should be allocated. Therefore, the League cannot oppose the transfer of the income tax funds from schools to some other agency. Such a stand would require convention or Board action, but is worthy of consideration in case the matter should arise again in the future. Mrs. Stakman reported that in St. Paul the funds received from the income tax are being used for maintenance instead of to pay off bonds.

Mrs. Richards also called attention to the proposed national program for her department.

Miss Mitchell reported that Mr. Eriksson is planning to introduce the Civil Service bill today or Monday.

Miss Mitchell asked of the League should present copies of the Social Security chart to members of the committees considering the old age pensions and unemployment compensation bills. Mrs. Cant moved that local Leagues be asked to send a copy to their own legislators on these committees, seconded by Mrs. Musser.

Mrs. Beard reported that she thought there would be no attempt made to change the teacher tenure law at the special session.

Library Project

Mrs. Cant reported on correspondence which Miss Mitchell has had with Miss Clara Baldwin of the library division of the State Department of Education relative to a library survey which local Leagues might make in their communities. Miss Baldwin indicated certain towns as places where such a survey would be helpful. Mrs. Musser told of the efforts of the Wells League to get a library for Wells by calling a meeting of representatives of all local organizations at which Miss Baldwin and Miss Wood of the State Department spoke. After discussion, Mrs. Stakman moved, seconded by Mrs. Cant that Mrs. Pearce write to local Leagues the first of the year and suggest a library survey as a possible local League project.

Trained Personnel Campaign

Mrs. Swain outlined Campaign activities for January and called attention to the green Christmas Greeting containing suggestions for local League promotion of the Campaign to be mailed to all local Leagues immediately. She also announced the winning slogan, "Lot the Man for the Job, not the Job for the Man". Two new fliers will be issued by the national League during January. Word from the national League says that the winner of the prize for selling the most of Miss Frederic's pamphlets has been decided but will not be announced until January.

Miss Mitchell reported that a class of Minneapolis and St. Paul women has been organized under the direction of Mrs. Haglin to prepare talks on Trained Personnel to be given during January.

Organization

Miss Horr reported on her trips to local Leagues during the last month. She organized a new group in Duluth and she and Miss Mitchell attended a Board meeting and large League meeting in Austin at which Miss Mitchell spoke on Trained Personnel. Miss Horr reported that the Excelsior League was not active this year and recommended that it be dropped from the list of active Leagues. Mrs. Richards thereupon moved, seconded by Dr. Boynton that the Excelsior League be dropped from the list of active Leagues.

Mrs. McNally reported that she had spoken on neutrality at a meeting of the Wayzata League and at the Christmas luncheon of the Duluth League.

Miss Mitchell reported that Dr. Boynton has appointed Mrs. I. M.

Nelson of Gaylord to act as her vice-chairman and that Mrs. Nelson has accepted. Mrs. Pearce has appointed Mrs. Cross of Faribault to be vice-chairman of the department of Government and Education. Mrs. Hertz of St.

Cloud, former chairman of the department of Government and International Cooperation, is acting as vice-chairman of that department. The vice-chairmen are not members of the Board but may be invited to attend special meetings and do special projects within the department.

Radio

Mrs. Bryan reported that some of the College League skits were very good. She outlined plans for the radio programs for this year. All the broadcasts during January will be devoted to Trained Personnel.

After luncheon Miss Wells led a discussion on League membership.

Mrs. Musser moved adjournment at 2:30 p. m.
