Dear Mrs. Young:

Since receiving your tempting letter two days ago concerning the vacant position of Secretary on the State Board of the League of Women Voters of Minnesota, I have been doing some very deep thinging.

It is with a sad heart that I must decline to accept the job for personal reasons. They are: (1) I have a baby daughter who will be only two weeks old tomorrow. She is therefore too young to receive nursery school care. My problem is one of baby-sitting. (2) My older daughter starts kindergarten next week for two short hours a day. We still do not know whether it will be morning or afternoon.

There is one bright side. Our local League holds evening meetings and therefore I can continue to do League work in the local League as extensively as before.

I can only hope that this unavoidable refusal will not shut the door to another opportunity such as this one in the future, when my children are a little older.

League work to me is still the most rewarding and worthwhile volunteer work that I can possibly do.

Board File June 4, 1955 Dear Mrs. Janski: Thank you for your very nice letter. It was a pleasure to meet with your League; I enjoyed it immensely and it was a real thrill to see such a large and enthusiastic turn-out for your annual meeting. I was glad too that your delegated enjoyed and were satisfied with the convention. As I have told you before, we are very proud of our Richfield League, which has grown so strong and effective under your expert guidance and wise leadership - which leads me into what I started to say to you when I was in Richfield, namely: That the State Board has had its "eye on you" for quite some time, and the nominating committee wanted very much to ask you to accept a board position, but were loathe to ask you to add to your duties as local president. However, a crisis has now arisen -- Mrs. Popp is unable to continue as Secretary because her husband is Mayor of Hutchinson -- and, after consulting with a member of the hominating committee and several others whose judgment I respect, and from my own knowledge of your ability, I am wondering if we could not again look at that possibility, and ask you to consider accepting the position of Secretary, rationalizing it thusly: The job of secretary is not a heavy one; I promise it would not involve any extra jobs - correspondence will be taken care of either by the office or myself. It would mean of course your attending board meetings once a month, and writing up the minutes - but that would be all. 

October 10, 1963 Dear Mrs. Phillips: I'm overjoyed at the possibility that the national Board may recommend in January a change in the program structure, Article KIII, to be considered by the 1964 Mational Convention. I am writing in favor of the single list. I have been in the League almost 20 years now and in the little snitches of time available around the rearing of four children it has been my pleasure to see the organization from a variety of viewpoints - the inactive member, the active member, the executive secretary to a city League in the east, the small midwest suburban League Board member with a variety of portfolios ranging from finance to organization to foreign policy chairman to president and now the state Board with public relations and currently legislative chairman. Through the years I have become increasingly concerned that we fail to capture the full potential of this really unique experiment in democracy". Instead, we have been more and more inclined to bury ourselves in structure and terminology. The result is that we stiffle our membership and waste valuable Board time on "can we?" details rather than "should we?". The new member of high potential and dedication - but not in sympathy with the organization woman outlook - finds it too difficult to out through this structure and terminology to make her mark on better government. Too often we lose her. That third reason for membership loss, Disenchantment, I feel comes primarily from the frustrations of this stiffling and secondarily from personal treatment she may have received as a member of a minority opinion on a program item (here we need to do a better job in our units in personal relations and in a more thorough job of discussing a new area of agreement from all viewpoints and more carefully unbiased resource presentations). The national Board's proposed By-law changes plus the single list will go a long way towards freeing the member so she can fully take part and in freeing the Boards so they can focus their energies on doing what their membership wishes. Looks like this is going to be a glorious year - 2 major policies at once! I'm overjoyed. I'm referring to Article HIII plus the revision in the Area policy. The strict delineation under which we lived for so long was, as you know from my complaints as a bl

president, a continual source of irritation. Here again we were burying the member in artificial structure. I was delighted to see this spring that we are now free from these confines in the current policy which I feel is much more realistic and life-giving.

Now, while you're at at - could my cup runneth over? - the nonpartisanship policy. The policy itself is excellent and, plus the unique people in League, accounts through the years for the sigmificant contribution we have been able to make towards better government at all levels. Our focus on the issue, rather than the partisan individual, plus our ability to mold together the support from both sides of the political fence, accounts for our achievements at City Hall, the Legislature and Congress. My difference of opinion is with the interpretation of this policy - no Board member having any contact with her party. This is the easy way to avoid criticism. We should take the harder way - freedom to interpret this policy as it applies to our community. I think the past league leader, prominently known in her community as "League" but now active in her political party (this we encourage) has a greater impact on the League's reputation than a new young LL bulletin editor who has a minor party job (this we do not allow). What's lacking is common sense; we're emphasizing structure rather than spirit. The spirit of nonpartisanship - League working impartially on issues for the general good of all - is being stiffled. This is because at the action phase we're blocked-off in our ivory tower unable often enough to close this gap between our excellent publications and better government as seen through legislation. I feel the only people it's necessary to have completely divorced from their political parties during their terms of office are presidents, public relations chairmen, finance, legislative, voters service and the agenda chairman at that level of government (eg. local program sheirman on local Boards, state on state etc.). In fact in setting up a new Board we might consider as one of many criteria: are both political parties or shades of opinion represented? The major opinion builders in the community? This to me is realism to speed our goals to better government. Monpartisanship comes in in the way we look at issues, in our voice of independence ahead of our times in the community, in the fine League spirit with which we do things. Our unnecessarily strict intrepretation of this policy has caused Disenchantment and flight among many of our best 10-15 year members, and we have suffered unnecessarily in the program action field, I believe.

We're ready to move ahead to a new plateau in the League. 40 Years has made a difference. The next 40 will too if we can free ourselves from unnecessary structure and straight jacket intrepretation of policies. Free our members to do the League job more quickly, productively and with greater personal satisfaction. We need to invigorate ourselves anew with the human approach, the person, the common sense so that we can carry on in our desires to help the beague member help herself to better government in this shaky democracy on trial for all humanity in the world today. This

Dear Annette and Fellow Board Members;

It is with regret that I find I must resign as a director on the League of Women Voters State Board.

Shortly after my election to the board I was appointed by the Mayor of St. Paul to serve as chairman of a newly created Minority Housing Committee. This is a committee which, under the citizen participation phase of a city's workable program for community improvement, is charged with suggesting to the Mayor and the Council and also to the Citizens Advisory Committee ways and means of securing better housing for all ethnic and minority persons.

As the Summer wore on and the increased attention was being given to discrimination in minority employment and housing it became apparent that the job of this committee was growing and was becoming more time consuming.

I know that just as all Americans are involved in the strugggle to achieve first class citizenship for all, you will understand why I have chosen to concentrate what time I have in this area. It seems to me, as one who participated in the study and action of the League's item on discrimination which was only recently concluded, that I have no choice but to continue our stand directly in my community. Although I may have doubts as to just how much this committee can accomplish, nevertheless the responsibility has been offered and I feel I can do no more than to accept a portion of it.

May I thank all of you for the opportunity of serving with you in this most respected organization. May I also hope that the cry of 1963, "Freedom Now" will be attatined by all means possible, including the thoughtful, forthright and continuing programs of the League of Women Voters of Minnesota

State Board Minutes, March 19, 1964 - p.2 MOTION: To accept with regret Mrs. Rothnem's resignation from the Board of Directors. Mover: Watson Second: Diefenbach Board members were asked to give suggestions for a new Organization Chairman to the Nominating Committee. This person must be able to travel and be away from home frequently. It would be most convenient to have someone from the metropolitan area. Mrs. Whiting also announced that Mrs. Elton Johnson will be leaving in August to accompany her husband to Washington for a year's stay, and we must be thinking of someone to work with her now and be ready to take over the State CRs when she leaves. Miss Barbara Stuhler, national Board member, joined our meeting to answer questions pertaining to the second round of national Program suggestions. Many questions were raised about the scope and focus of the equal opportunity item, foreign economic policy re-evaluation, four item current agenda, elimination of loyalty-security, difficulty in calendar planning, the not-recommended item on election laws. This portion of the meeting and the discussion of second round national Program suggestions is on tape in the office. Miss Stuhler said that there may be a preliminary Time for Action on foreign aid before the April 30 Aid meeting. We thanked her for her help, and she left. SECOND ROUND NATIONAL Mrs. Whiting read our first round suggestions before we dis-PROGRAM SUGGESTIONS: cussed those suggested by the national Board. Equality of Opportunity: some members like it for its timeliness, some felt it should not be called a civil rights item, others wondered if action might already be taken by the government before we would have time to study it. A majority of the state Board was not in favor of this item. Mrs. Watson and her committee will write to the national Board to comment and make recommendations on focus and scope as they re-evaluate this item. MCTION: To substitute Election Laws for the Equal Opportunity item and go along with the other three national Current Agenda items. Mover: Janski Second: Lundquist Carried. Reasons for proposing Election Laws were: close to home, clear cut, easy to understand, etc., with the possibility of study of standardization, voter registration, campaign practices, uniform codes and electoral college. REVISION OF AGENDA: Mmes. Diefenbach, Colborn, Nash and Janski asked for additional time. Mmes. Hutchens and McCoy requested less time than planned. PRESIDENT'S REPORT: Mmes. Murray and Whiting went to Virginia to visit the League there and discuss the Taconite Amendment. The Virginia League has done an excellent job with the amendment issue.
