



#### REPORT OF CONGRESSIONAL INTERVIEW

#### Congressman Richard M. Nolan

District 6 - Minnesota - Democrat (DFL)

Particular legislative interests (committee preferences if new): Agriculture Committee - assignment has been made. Hoped to be on the Banking and Currency Committee, too.

- 1. Trade Reform Believes in maximum production and the development of reserves. Thinks we should import no food, that it is immoral. Is for free trade basically, but thinks imported foods should have to meet same standards as domestic supplies. The dairy industry was used as an example. Would use a food reserve to assure farmer a fair profit.
- 2. Land Use Favors a national land use plan. Would classify all land in the United States (as has been done in Minnesota) to provide an inventory of what we have to work with. We need a projection analysis on housing, agriculture, development, etc. Need input from knowledgeable people and federal control over how we use land. Minnesota has a land computerized system under the Department of Natural Resources, but not as much control of planning as is necessary. Some counties have land use plans now managed by zoning and the state of Minnesota has laws regarding use of lake shore, but land use should be a federal function. States could administer a plan, but we must have a national outlook. We have to consider allocation of people.
- 3. Public Service Employment Favors public service employment. Government should provide jobs if private sector can't. All people should be able to have jobs. Favors a guaranteed annual income with higher pay for unpopular jobs. Prefers alternative employment and training instead of unemployment insurance. Would re-allocate funds to pay for this out of the present budget or, if necessary, raise taxes.
- 4. Development Aid Concerned with health and food which led us right back to our domestic concerns in these matters.

Welfare - Current system archaic. Need an income maintenance plan with broad range of social services that would be nationwide - financial counseling, family counseling, mental health care. Favors giving money instead of food stamps.

OEO legislation - need separate department with continuous support of OEO.

<u>Health</u> - Emphasis on prevention and out-patient services. Need health care under the same concept as education. Need a new definition of health, including nutritional health. Has a compromise plan for national health care.

5. Air Quality - Discussion turned to energy and he favors rationing for fuel and gasoline. Thinks a tax increase is not economically sound.

As a result of the interview, how do you think the League can work more effectively with the Congressman? What is his attitude toward the League as an organization and in general toward the League's national position?

We established a fine rapport with the Congressman. Much of this was established prior to his being elected to office. The Congressman's wife, Marjorie, is a member of the League of Women Voters in St. Cloud. The Congressman agreed to send us material that would benefit the League. We asked to be put on the mailing list for the Congressional Record; he agreed. He indicated that he found us stimulating to talk with and later stated that it had been one of the best discussions he had entered into.

Other organizations and/or individuals to whom he is particularly responsive: Common Cause, farm organizations (such as NFO, Farmer's Union, Farm Bureau, etc.), labor unions, PUSH (People United for Sound Health), the elderly.

Kind of interview: in St. Cloud, MN at the home of Doreen Keable, 909 6th Ave. N. on January 9, 1975. The interview was information, held in livingroom--

coffee--but following outline of items to be covered. Two Leagues (St. Cloud and Buffalo) were represented and a state Board member - about 12 people.

#### Congressional Interview

Congressman John M. Zwach - 6th District - Republican

On January 4, 1974 a Congressional Interview with Sixth District Congressman John M. Zwach was held at 2:00 p.m. at the home of Carol Dahl at Willmar, Minnesota. Due to the icy roads and cold weather the crowd was limited to fourteen League members from St. Cloud and Willmar, Minnesota. Those who were present found the interview interesting and informative. Our moderator was Harret Ball of the St. Cloud League of Women Voters. Questions revolved around the national program.

Environmental Quality: Congressman Zwach indicated that we can get additional energy from solar energy and atomic energy. Waterfall would be the ideal one while coal is less desirable. In regard to atomic energy, we have a problem with so-called environmentalists who just recently jumped aboard the bandwagon and do not take a realistic approach. They have not allowed a refinery to be built in ten years. "We're going to have to have refineries if we're going to have energy. We're going to have to find the answers to living with refineries. They have opposed every effort to the development of atomic energy. They think they have some other answers. We have to-if we're going to live the way we do--we have to find a way to produce energy with the least damage--and we can."

The other major point on environmental quality dealt with automobiles. Congressman Zwach stated, "Regarding automobiles we may have made some mistake in insisting that the antipollution devices be used on cars where there is not a heavy population. We have slipped a lot by not having improved carburation on automobiles. The carburetor today is no more efficient than it was on the Model T Ford." He continued, "Rather than put all kinds of devices on the inefficient carburetor, we should approach the real good use of fuel by carburation."

Another concept which he felt merited some exploration was putting a little alcohol in gasoline. The addition of 10% alcohol in gasoline would improve mileage at least 10% and reduce the bad polluted residues perhaps 25 to 50% since gasoline would do a cleaner job of burning. The state of Nebraska has done a lot of pioneering in this field.

Basically Congressman Zwach feels we went too far with standards for emission control devices in Detroit and not far enough in trying to prevent pollution through poor consumption of gas and bad carburation.

Land Use: Questions arose regarding federal zoning. Congressman Zwach's philosophy simply is as follows: "As a Republican I am a State's Rights, and I always think nobody does things as well as the people that are closest to it." Work is being done in Washington to get some type of legislation. Zoning should be a cooperative venture between the federal, state and local levels of government. We already have excellent cooperation on all three levels in our Watershed Districts. Local boards are really the thing that are important.

Questions also arose regarding federal lands within the states and who ought to control or regulate them. Congressman Zwach indicated that these lands would always have to be regulated by the federal government. About one-third of our land is federal land.

Regionalism is a part of this overall structure. Many people are opposed to this concept. Congressman Zwach indicated that, "Cooperation is desirable

on a regional basis. Regional domination is not desirable."

Human Resources: On this topic we dealt mainly with the Indian question. Here too, Congressman Zwach felt that local control would work better than federal control. He believes the federal government should supply the funds, but that there should be more Indian control via an Indian Council. Zwach stated that the Indian Bureau in Washington has not done a good job. He also stated that the Indians should be given block grants for categorical aids. The government shouldn't force excessive spending in certain areas.

The conversation also turned to Wounded Knee. Congressman Zwach indicated that though it was a sad event, some good did come out of it. Wounded Knee brought about an awakening of the American people and an awareness in Congress and in the Indian Bureau. It is leading to the revising of the Indian Bureau.

International Relations: Our discussion here dealt mainly with world trade. Congressman Zwach favors open trade. He says it is better to "feed people than to shoot them." The Midwest is currently suffering in the world trade situation. Zwach feels we are giving too much power to the executive branch of the government. Congress should reserve the right to approve or disapprove things.

Congressman Zwach disapproves of the Flanagan Report. This would be an agreement between two countries regarding what each would produce. One country would grow all the grain; the other would produce all the milk. We ought to be able to sell all our finished products--eggs, chickens, beef, pork--rather than just the grain. It would dry up our farms.

Regarding Japan's current influx into the United States, Zwach thinks it is a temporary thing. Japan can convert their money to our dollars and come out ahead. He believes they have the right to build factories here just as the United States has been granted that right in other countries. He does feel, though, that Japan is making a mistake--that they can't raise soybeans cheaper here.

Representative Government: Representative government dealt mainly with the topic of campaign financing. Congressman Zwach's main concern was, "How do you restrict it and be fair?" You need to be fair to the one who is running against an incumbent. He has many advantages before the campaign starts. Some congressional districts are larger than others. It takes more money to travel around the 6th District than it does to travel around the 4th District in Minnesota.


Congressman Zwach does think there should be some limit on campaign spending, but there are still a lot of questions about it.

<u>Watergate</u>: Closing comments dealt with Watergate. The Congressman stated that he felt Congress was not involved in Watergate to any great extent, but he said, there are "always a few."

He said the President has one basic weakness. He places "too much confidence in a few people and centralizing the power." The President ought to spread out the responsibility.



THE DISTRICT: The sixth congressional district in Minnesota is a largely rural area encompassing only one large city, St. Cloud, with a population of 33,815. St. Cloud College, with 10,000 students, is also in the district. The population in 1969 was estimated at 427,000, only 7,000 more than in 1960. The median income of \$4,054 was below the state average of \$5,575, as was the median education, 8.9 years compared to 10.8 years statewide. Farming, transportation and construction industries, in that order, employ the majority of the work force. In 1960 the district's unemployment was 5.5% compared to 5% for the state.

Politically the district is considered marginal or leaning Republican. The Democratic Farm Labor Party has been strong. Incumbent Congressman Zwack (R) has been elected to two terms with margins of 51.4% in 1966 and 56.2% in 1968. Before 1966 the district had been represented by a Democratic congressman with margins of 50.1% in 1962 and 51.8% in 1964. In presidential elections the Democrats (DFL) have managed to win the district in both 1964 (62.9%) and 1968 (50.7%). Of course Humphrey is from Minnescta, so the 1968 figure is not really indicative of a solid national Democratic vote. Both Democratic Senators Mondale and McCarthy have won the district with 53.5% and 59.4% respectively. The district supported the Republican governor LeVander with 54.5% in his successful bid for governor in 1966.

THE CANDIDATES: Terry Montgomery, 32, was raised on a farm in Meeker County and graduated from Grove City High School. He worked his way through college as a radio-television news reporter, attending both the University of Minnesota and St. Cloud State College. He received the NBC News Fellowship in nation-wide competition, attended Columbia University for his master's degree and graduated with high honors. While working as a reporter for the Minneapolis Tribune and WCCO-TV, he appeared several times on nationwide CBS News. He gained statewide exposure in his four years of on-the-air news coverage at WCCO-TV. In 1967 he built and began operating his own radio station WKPM at Princeton. He was appointed a Vice-President of St. Cloud State College in 1968 after working as an instructor and assistant to the president for four years. In 1968 he was named one of the Ten Outstanding Young Men in Minnesota for leadership in business,

education and rural development. He has been a long time member of the Democratic-Farm Labor Party and currently is a member of the State DFL Executive Committee.

John M. Zwach (R-Inc.) is sixty-three years old, married with five children and two grandchildren. He received a teaching certificate from Mankato State College and earned a B.S. degree from the University of Minnesota. He served in the Minnesota State Legislature from 1934 to 1946, in the Minnesota State Senate from 1946 to 1966, and was majority leader from 1959 to 1966. During his stay in the state legislature, he was Chairman of the Rules Committee, chairman of the Education Committee, and chairman of the Interim Agricultural Commission. His prelegislative experience was in public schools. He has also been an active farmer since 1940. Now that he is in the U.S. Congress, he is on the Agriculture and Veterans Affairs Committees. 1

Montgomery is particularly involved with rearranging THE ISSUES: national priorities to concentrate on domestic issues. To do this, he calls for an end to the war, but also a public evaluation of our involvement to insure that the policies which led to Vietnam are not repeated. He opposes further development of ABM, SST and other unnecessary military and space spending. He is for immediate control of pollution and feels that Congress has the responsibility . to draft legislation (i.e. stiff federal laws) and provide appropriate funds. Montgomery sees education as an important issue in his district and calls for additional federal support at all levels. He is also concerned about the plight of senior citizens, crime prevention, consumer protection, draft reform, veteran's benefits, welfare reform and opportunities for the poor and disadvantaged. None of these domestic programs, says Montgomery, can be handled effectively until we re-order priorities.

Though Zwach is definitely more conservative than his Democratic predecessor, it is unclear exactly what his opinions on domestic issues are, because of his inconsistent voting record. In 1967-68 he voted for the Civil Rights Act, but against the Model Cities program, for food stamps, but against rat control, and for stricter meat inspection laws but against OEO. On military policy Zwach has voted for funds for ABM and for the November 4 and December 2 resolutions supporting Nixon's policies in Vietnam. He has an ADA rating of 20 and an ACA rating of 72.

THE CAMPAIGN: The central issue in Montgomery's campaign will be reordering priorities. He has travelled extensively through the 19 counties talking to the people and considering their views. In a press release telling of his candidacy, Montgomery lists the priorities in this order: inflation, tax reform, improving farm income and farm bargaining power, pollution, education, senior citizens; he lists other needs but does not elaborate on them as

he has on the ones mentioned above.

This is definitely a district where the Democrats could regain a seat with the swing of a few marginal voters. Montgomery, by emphasizing the local issues and showing how they can be helped by reordering national priorities (first end the war), has a good chance. Montgomery is new, fresh, and he worked and grew up in the area. He is running a vigorous campaign. Zwach has appealed for student support but Montgomery seems to have most of it. 2





Thanks so much for taking on the job of Congressional Action Coordinator for the 6th District. We were pleased to hear from Phyllis that you had accepted.

The most important reason for having a coordinator is to get the Leagues in the habit of responding to National Times for Action. To accomplish this, we have asked the Leagues to make an official reply within 5 days of receiving a Time for Action mailing. At this time they are to either send you a carbon of their letter or send you a reply card we have provided. You should hear from your Leagues within a week. If you don't hear, you should contact them, reminding and encouraging them to take action.

Another part of the position is to encourage Leaguers to get acquainted with their Congressmen, to know their position on League issues and to use this knowledge to be more effective in writing them. At the state level, we are keeping track of voting records, bills introduced, etc. and this will be sent out from time to time. (If you would like to do your own research, you could ask Representative Zwach on behalf of the Leagues of your district to be put on the Congressional Record mailing list. St. Cloud took it for a while and then asked to have it stopped as they found they weren't getting it read.)

National League asks us to have an official League interview with our Congressmen and Senators every year before the begining of the session. We feel this is most effectively handled by the Coordinator. Your responsibility will be to contact Mr. Zwach and request a chance to talk with him soon, at his convenience, before Christmas is possible. Representative Zwach has an office at 216 Federal Building, St. Cloud (Phone 612-251-2120). You can set up the meeting in Buffalo, or St. Cloud or elsewhere. (The State League will reimburse you for your expenses.) When the meeting is set you can notify Leaguers you would like to attend - your contact people in the other Leagues, the president and resource people from Buffalo, Mrs. William Brascugli (Mary) - State Board 1560 6th Ave. N., St. Cloud 56301 (Phone 612-537-0694), perhaps Eli Colborn, etc. and I would like to attend if at all possible. Irene Janski, the Lea ue's State President will soon send a congratulatory letter with a carbon to you. She will let him know that our Coordinator will soon be in contact to set up an interview.

Unless you hear differently from them, your contacts will be these presidents. A copy of their letter is enclosed. We are also sending these woman a procedure sheet, some Time for Action response cards, and brief fact sheets about Minnesota's two Senators. All except the cards are enclosed. You should be getting them from your Leagues as they respond to Times for Action.

The Coordinator's job will have three parts. Most important, as a start, is to get the Leagues in the habit of responding to Times for Action. You are supposed to hear from all 5 Leagues within a week of the time you receive your mailing from national. (We are getting you a national Time for Action subscription service.) If you don't hear from the local Leagues, you will have to use your judgement on what to do about it. If the issue isn't already settled in Congress, a prodding note is probably best. We can't afford phone calls unless there is a real urgency. Our goal is to get the minimum of an official League letter from each League in the state on the Times for Action.

September 19, 1967 The job of summarizing League activity from time to time and letting everyone know will depend on how much the Leagues do and how good they are about letting you know. The third part of your job is to help them share information about Representative Zwach. Here you can take the lead by getting some basic information from his office - his address, biography, current committees, legislation he has introduced, his positions on issues the League is concerned with, etc. We at the state level and national also would be interested in getting this information. If typing is any problem, send it along to the state office. We'll be happy to get it done and out. (The state will reimburse you for expenses for postage, etc. Some expense voucher sheets are enclosed.) If as you get into this job you can suggest any way we can be more effective, please let us know. It maybe that setting up a meeting with your Leagues (just once) might be a good idea. We would be happy to participate in that. Encouraging your Leagues to meet with Zwach; setting up interviews with yourself and the national action contact person from some of your Leagues with Zwach; etc. are further possibilities you might want to look into. Congressman John M. Zwach was born in Gales Township, Redwood County, on February 8, 1907. He attended the public schools and graduated from the Milroy High School in 1926. He received a teaching certificate from Mankato State College in 1927 and was awarded his BA degree from the University of Minnesota in 1933, graduating with distinction. In 1940 he married Agnes Schueller. They have three daughters and two sons.

Congressman Zwach served in the Minnesota House of Representatives from 1934 to 1946 and in the Minnesota Senate from 1946 to 1966. He was Senate majority leader from 1959 to 1966 and also Chairman of the Rules Committee. He served as Chairman of the Education Committee from 1955 to 1957, Chairman of the Interim Agriculture Commission, 1955-57, and served on committees on agriculture, education, game and fish, highways, finance, and taxes.

Congressman Zwach was a school teacher and superintendent for 14 years and an active farmer since 1940. He is a member of the Farm Bureau, National Farmers Organization, Farmers Union and the Knights of Columbus. He was elected to the 90th Congress on November 8, 1966. He maintains his legal residence at his farm home near Walnut Grove, Minnesota.

#### REPORT OF CONGRESSIONAL INTERVIEW

John M. Zwach

6th District, Minnesota

Republican...

Committe Assignments -- Agriculture -- District of Columbia

District of Columbia Representative Zwach is a member of the conference committee to work out differences with the Senate on the bill allowing DC to elect its own school board. He supports self-government, and feels that home rule in part will come, but as District of Columbia is the Capitol of the United States, there will always be need for some federal control. He favors representation in Congress and sees no trouble in getting a bill for non-voting interim representation out of committee. The proposed constitutional amendment which now provides for two Senators and two Representatives he probably would not support, however, he does favor a constitution amendment allowing some representation.

Foreign Policy - United Nations He favors placing the Vietnam question before the United Nations. United States: made a mistake in not keeping the military burden on the Vietnamese with economic and technical aid being of more benefit to the Vietnam people. The United States' dream of the United Nations has not been fulfilled: United Nations power is at an impasse.

Foreign Policy - Aid Although Representative Zwach voted against the foreign aid authorization and appropriation bills, he has supported many foreignbills, such as Export-Import, Peace Corps and others. He believes there is at least \$6 billion of unspent money "in the pipeline" available for programs and that a cut-back need not hurt necessary programs. The major problem is for the United States to become fiscally responsible. Unless we are in sound fiscal shape, we will not be able to assist any country. This should have been done earlier, but now we are at a point of crisis where our first responsibility is to assure the soundness of the American dollar.

Foreign Policy - Trade We should encourage free trade, but not at the expense of our needed industries and producers. Congressman Zwach points to a study done by the Trade Relations Council of the United States where 147 selected industries (meat and dairy products, textiles, apparel, wood products, paper, leather, steel, motor vehicles, sporting goods, electrical equipment, etc.) had an \$8.3 billion trade deficit in 1966. Many of these industries will be affected by the 50% tariff cut in the Kennedy round. Mr. Zwach's solution is to apply quotas on these imports. He feels this action will not be subject to retaliation because GATT allows quotas to be used for balance-of-payments reasons. He has authored quota bills and feels they are justified because so many dairy farms have gone out of business in his district. He must support that which is of first concern. The real problem is the small, family farm. The United States is spending AID money abroad to break up large land holdings and yet here, through governmental policies, we are forcing large land holdings. (He doesn't think subsidizing the farmer instead of crops is the answer. It's too complicated what if the corporation farms overproduce and flood the market?).

Development of Human Resources - He feels that educators should know the amount of federal aid in time to plan wisely for its use. He favors giving education funds to the states for distribution. The Green Amendment to the Economic Opportunity Act, which gives state and local governments control over the poverty programs, was the result of placating southern and big city Democrats. It was a set-back to the poor. We fight poverty by providing opportunity.

Mater Resources Polution is definitely a problem. He has suggested a single federal agency to control America's fight against water pollution. He also feels that the approach used in the air pollution bill is good. This bill requires that the whole country comply equally. With water pollution, we must do what we can now, but this is an area where men and money should be used to maintain a stable economy as soon as Vietnam is controlled. We must practice conservation of our resources.

Local water problems were discussed: the federal ditching program around Big Stone Lake; the silting in of the Granite Falls reservoir; the problems of the Minnesota River; the general problem of nitrogen polution.

You will receive from time to time bulletins issued from the main office regarding school activities, programs, and announcements. We want to keep you informed so you know what is going on at Willow. Some general school procedures follow: THE SCHOOL LUNCH PROGRAM: Lunch money will be collected daily at noon in the cafeteria. Hot lunch with milk costs 25¢ per day. Milk for those who carry their lunch costs 3¢ per day. Money will be collected from each student as he enters the cafeteria. IOU slips will be issued if a child has lost or forgotten his money. The IOU slip should be redeemed the next day. If an IOU slip has not been redeemed two days after it has been issued, parents will be contacted by the school secretary. This procedure has been established this year in order to provide more instructional time for students and teachers. May work for lunch if qualified and work is available. d. Families not on welfare, but in severe financial straits because of illness etc. Yes - by certification of head school nurse. Children receiving free lunch who and for the grade or above will be encourage to do tasks in the cafeteria commencurate with their age, size, and ability. However free Lunch 11 not be denied a child who is otherwise qualified because he is unable to work, unsuited to the work, or there are no tasks available. PLAYGROUND CUPERVISION: Two Lakewood Junior College students will supervise our playground during the noon hour. They are Miss Rory Freas and Miss Rory Mishler. WILLOW LANE PTA: Because of the nature of our enrollment, last year's executive board had considerable difficulty in obtaining a board for the 1967-68 school year. Mr. Roy Havenor, last year's president, makes a plea for people to come forward and volunteer to help promulgate the Willow P.T.A. This is your school and it should be represented at the Area Council level. Please contact Mr. Havenor (429-7577) or the school office if your are willing to help maintain a Willow P.T.A. THE SCHOOL PATROL: The Willow Lane School Patrol, under the direction of Mr. Robert Bergstrom, sixth grade teacher at Willow, will provide supervision for walkers on Orchard Lane and Elm Street. Qualified 6th grade students are chosen to be school patrols. The patrols also supervise areas on the school grounds. Contact Mr. Bergstrom if you wish more information regarding our school patrol.

Dear Mrs. Ebbott:

In the absence of the Congressman who is in the District during the official Easter recess, this will acknowledge receipt of your recent letter expressing deep concern about Amendment Report #668 which was attached to the Tax Adjustment Act of 1968.

This Amendment, offered by Senator Hollings, does provide an import quota system for man-made textiles. It was passed by a roll call vote of 55-31 on March 27. While it is true that our agricultural exports were greater than our imports, still, none of these exports sold at our domestic market price. Consequently, we have a situation in which we have greatly increased our exports at the expense of earned farmer income. Farmers are thus forced to take the world price which is much lower than the domestic price but they have to pay the higher domestic costs of producing that product.

Congressman Zwach has long been a strong believer in the necessity and desirability of trade between nations, and especially in the complementary type, not supplementary. Supplemental imports serve as a replacement for the need of a local industry in society without providing an opportunity for them to develop a higher income market, or to become trained in another vocation. It is his belief that some protection in the form of quotas should be offered to domestic producers to allow them time to make needed adjustments. We would be most happy to fully explore all other possibilities in lieu of quotas to effectuate the problems of finding occupations for the displaced American laborers and farmers.

Thank you for taking the time to share the concern of the League of Women Voters with us on this vital matter, and I can assure you that I shall bring your letter to the Congressman's immediate attention upon his return.

## MEETING WITH REP. ZWACH by Jackle Hays

St. Cloud -

A delegation of our members met with Rep. John Zwach on Saturday morning, October 28. Because of a hurried thiry minute appointment, no one subject was discussed in depth.

Rep. Zwach reported that home rule for the District of Columbia is closer to reality than eyer before. HJR 396 has passed the House Judiciary Committee, a big hurdle to clear.

Mr. Zwach is deeply concerned about the budget deficit. He reiterated his view that it is the responsibility of Congress to bring fiscal responsibility to government. He feels that some national needs will have to be passed over until a solution to the Vietmam crisis is found. It is Mr. Zwach's opinion that the United States is almost totally supporting the war for the free world.

On the subject of foreign aid, Mr. Zwach told us he felt military ai was foolishly spent more often than not, and that he favors giving assistance in the form of technical aid.

All League members will be interested to know that anyone can use the library at Mr. Zwach's office located in the St. Cloud Federal Building. His secretary will be glad to help with questions.

A local League shall check its prospect list with that of any other

League which might have the prospect listed.

- 2. In the case of duplication of prospects' names, decisions as to which League will solicit the prospect shall be made with these considerations in mind:
  - a. Former contributors shall continue to be solicited by the same League unless the contributor voluntarily expresses a wish to contribute elsewhere or a League voluntarily chooses to release his name.
  - b. If a conflict of interest arises about the solicitation of a new prospect, choice should be made in the light of the following considerations:
    - 1) A contributor is more likely to contribute to a League in the community where he is most active in civic affairs.
    - 2) A contributor is more likely to give substantial support to a League with a larger budget.
    - 3) In the event the foregoing factors are not relevant, decisions may be based on what best serves individual League needs.
- 3. In the event that the Leagues involved cannot agree as to which shall solicit the prospect, the matter may be brought before the state finance chairman and/or her committee, or the Arbitration Committee for resolution.
- 4. The Arbitration Committee shall consist of three voting members, with a member of the state Board as chairman without vote, to be appointed when needed by the state President and approved by the parties involved.
- 5. Meetings consisting of one representative from each of the participating local Leagues may be called at the discretion of the state finance chairman or as requested by a substantial number of Leagues comprising the Metropolitan Finance Committee.

Dahl: We were planted to receive a copy of your letter to Con ressman Ewach about con remained representation for the District of Columbia. Your prophages in responding to this tipe for action call is appreciated. There appears to be a misunderstanding about Rep. Swach's position on the D.C. issues. If we have erred in getting the correct information to you, we are sorry. Mr. Zwach did vote assinst President Johnson's plan to change the structure of Washington's city government from continuous to a "mayor" and "councilnes". The President had only the power to change the organization of the city government; he did not have the power to make these positions elective. The mayor and councilmen are still presidential appointees. The residents of the District still do not have home rule. Since home rule was not a factor in that vote, the League had no position on it. Actually Rep. Swach has been important on the D.C. Com ittee helping to bring out the bill which will let D.C. residents elect their own school board. This is the first time since 1874 they have been allowed may control of their own affairs. The bill was introduced by Minnesota's Congressman Relsen with Rep. Zwech supporting it and voting for it. Since congressional representation for D.C. requires a constitutional econdment, that bill has come through a different House counittee. We don't yet know of Iwach's stand on it, but in view of his vote on the school boards question, he could be in favor of it. I am inclosing for your information come material on writing congressmen. We surgest that letters give thanks for feverable past votes when possible. It is also best to write stating your position, why you think you are right, and then express your hope that he will take your view into consideration when voting. We don't really have the right to derend a favorable vote. Perhaps you can find an optortunity to let Swach know that the League appropiates his vote on the school board bill. It is a good first step. If the acondrest providing for Congressional representation passes, that will be a second step. These may well lead to the final step. The Longue has been concerned with D.C. since 1924. We shouldn't be too disappointed if we don't get everything all at once.

MAY 30, 1967 Mr. Wolf, Monsignor Higgins, Reverend McClellan, Reverend Fauntroy, Rabbis, and friends of Israel, the Rabbis from Minnesota who spoke to me earlier and apologized in asking me to come here on Memorial Day. Certainly there was no need for any such apology, and I can think of no better place to be today than speaking to you while all around this country we take stock of what our record has been in the defense of freedom and honor and the measure of our responsibility as we look to the future. The legal case for our involvement in the Middle East is one that we can trace clearly back to 1945 when President Truman first asked the British to admit Jewish refugees into Palestine. And that request was followed in 1947 when we supported the United Nations Assembly in the establishment of Israel. We did not stop short with that general endorsement and support in the family of nations, but proceeded in 1950 to agree to the Tripartite Declaration by which we took responsibility upon ourselves in a very special and national way, promising our continuing support to preserving the integrity and the life of the State of Israel. And on down through the years, each time that that integrity was challenged, each time we were called upon to make public a position, our government speaking through the President has responded. President Eisenhower in 1957 spoke of freedom of the seas and the right of Israel to have access to all the oceans of the world, and in 1963 President Kennedy reaffirmed our support of Israel and its integrity. And in 1967, President Johnson has reviewed and summarized and taken to himself all of these earlier commitments and stated them for this nation to the world. MORE

League members all over the nation are asked to write to their Congressmen and Senators concerning the Federal budget for sewage-facility construction grants.

The President's budget request of \$203 million is less than half the \$450 million the House and Senate Public Works Committee agreed should be invested in this program in fiscal 1968. The President's budget propasals for fiscal 1968 hold new water projects to a minimum and stretch out projects already underway. But this is one public works program that the League thinks must be carried on with no slow-down.

Many congressmen are unaware of how much less than the recommended amount the President's budget was.

All League members--write to our senators, McCarthy and Mondale, and to our Congressman, John Zwach. Tell them how important we feel an adequate appropriation is, and that we would like them to recommend to the subcommittee that the amount called for be the original \$450 million!

The Public Works Subcommittee of the Appropriations Committee for the House is scheduled for its report on June 16, with the budget request going to the House floor on June 20. Each goes to the Senate two weeks later.

It is inconceivable that the Federal Government withhold this needed money just when local action and public opinion are reaching a peak toward pollution clean-up.

League members, act now. Tell our Congressmen the problems of St. Cloud. It will cost the city about \$138,000 if they put in the new lift station for 5th Ave. North.

Let our Congressmen know we want the whole amount—\$450 million—NOW!

RESUME OF CONGRESSMAN ALEC OLSON'S VIEWS ON LEAGUE PROGRAM ITEMS CA 1 - Apportionment of State Legislatures Congressman Olsen submitted a bill last session similar to Senator Dirksen's but not as detailed. He favors the idea that the membership in one house be based on a factor other than population. CA 2 - Development of Human Resources He favors regional planning. Problems which cut across state lines cannot be selved through state cooperation because the states to date have not cooperated: therefore, a federal program is desirable. He favors antipoverty programs whith local administration because they are closer to their own problems. Also, he believes that the success of these programs rests with the local people; and, he hopes that they will use the money wisely and as it is intended to be used. Congressman Olson favors reviewal by the Congress to determine the effectiveness of the programs. CA 3 - United Nations Congressman Olson supports the United Nations. He feels that unless Red China is admitted to the U.N., the United Nations could not be very effective in bringing about the settlement of the conflict in Vietnam er in effecting disarmament. He said that it is unrealistic that a disarmament agreement -- new in the talking stage -- could become effective unless Communist China agrees to talk and comply. CA 4 - Fereign Economic Policy International Coffee Agreement; In 1964, he voted for the Coffee Agreement Implementation legislation which failed to pass in the House. From a letter of April 12, 1965 - "I am advised that the House Ways and Means Committee is going to be helding hearings very soon on the Senate bill Coffee Agreement, and I expect that it will also be considered by the full House during this session. I shall support this legislation again this year. " Restrictions on Imports: Generally agrees that there should be free trade, but was caught in the pressure from back-home in regard to limitations on imports of meat. He did indicate that he was opposed to same of the Senate amendments on H.R. 1839, but did not commit himself as to how he would vote. Chesley 612 North Eighth Street Brainerd, Minnesota Dear Mrs. Chesley: C Mrs. Stuart has asked me to thank you for your letter of January 19 in which you asked "whether or not the League of Women Voters of the United States has taken a stand, or has power to take a stand, advocating that the present Vietnam crisis be brought before the United Nations for settlement." I am not certain whether you have had an opportunity to see the January 1966 NATIONAL BOARD REPORT but on pages 67-68 (under UN and FEP Outlook) we discussed this matter and reported that "rs. Stuart did send the President a letter, dated January 14, 1966 (reproduced in full in the Appendix), the last paragraph of which reads: "We wish to express our earnest hope for the ultimate success in the many initiatives toward negotiations for peace in Vietnam. We welcome, as a valuable follow-up to your July 28 letter to U.N. Secretary-Ceneral U Thant, Ambassador Goldberg's January 4 letter and his request that it be communicated to all members of the United Nations. In our judgment the full resources of the United Nations should be brought to bear on this conflict." Actually, we have communicated several times with the President on foreign policy matters of League interest in the not too distant past: Last July 30 we sent letters to both President Johnson and Ambassador Goldberg at the time of the first official indication of a shift in U.S. attitude toward using the United Nations in general -- and U Thant's good offices in particular -- to try to evolve a peaceful solution in the Vietnam dispute (see September 1965 NATIONAL BOARD REPORT, pp. 19-20). Prior to that, on April 8, 1965, Mrs. Stuart sent President Johnson a telegram after his Johns Hopkins University speech on Vietnam in which we commended his proposals for the economic development of Southeast Asia's Mekong River basin (see May 1965 NATIONAL BOARD REPORT, pp. 24-26).
