The following is a preliminary draft which expresses my position on the current situation in which you are interested. I have already started conveying my views to the Republican leadership in Congress privately, and will begin checking this exact statement with my top advisors at once. In my judgement if fifteen or more first-rate people of both political parties and including business and labor and if possible, clergy of the three faiths, willjoin in such a letter, it should be delivered to the Committee on the first indication that they are violating these principles in the manner in which they are conducting the investigation, and then released to the press and radio after delivery. I

I will welcome criticisms or suggestions as to wording of the message.

We the undersigned citizens of the United States,

Republicans, Democrats and Independents, of divergent religious

faiths, nationality backgrounds and occupations, none of whom are

affiliated in any ways manner to the Motion Picture Industry, re
spectfully request your consideration of this letter.

It is our view that the motion picture, with its remarkable facility for presenting viewpoints and facts simultaneously and dramatically to both the eye and the ear of the people, is an implement of exceptional value to America and to the future freedom of manking.

It is our conviction that the top leadership of the Motion Picture Industry and the overwhelming majority of the stars, writers, directors, cameramen, and technicians, are unquestionably loyal to the United States of America and to the fundamental concepts of human rights and individual freedom in our constitution, and are as anxious to serve our common country and our common cause as are any other citizens in government, or business, or labor, or any other

walk of life, as was demonstrated in the War.

It is our understanding of the laws of the United States that it is not at this time nor has it been in the years past, against the law to be a Communist unless it is proven that the objective is to overthrow our government by force or unless treasonable conduct is established and it is our further understanding that it willrequire action by Congress to change this present state of our laws.

It is our view that anyone who is a Communist or Fäscist who masquerades behind a false name or a false front should be vigor-ously exposed.

It is our firm belief that there should be complete respect for the constitutional rights, and civil liberties, and just and fair opportunities, for every man and woman in America, and that to depart from this will weaken our country rather than strengthen it.

In the light of the above premises we respectfully urge upon you and your committee that under the tension of current world relationships, exceptional care be taken that the motion picture industry as a whole be not unjustly smeared, that innocent and loyal

and the state of the state of the state of people be not carelessly humiliated and disgraced, that real evidence of Communist or Fascist subversives be thoroughly presented, and government rather seek the cooperation of the motion picture industry as to the exceptional part which it can take in the tasks which America faces and as to any laws which are needed to correct existing problems. We the undersigned Republicans and Democrats of the Motion Picture Industry, wish to state our protests to certain aspects of the Investigation of the Industry presently taking place in Washington.

This nation has been warned of the threat to our security and peace from International Communism. These warnings have come from national leaders of both great political parties, and from those charged with our national defense; from our President, who owes his high office to the studied faith and confidence of the liberal Democrat, Franklin D. Roosevelt; and from George Marshall, our Secretary of State, a man of unquestioned wisdom and integrity.

Under these circumstances, the Congress would be remiss in its duties if it did not examine the threat, looking towards a determination as to whether or not new legislation is necessary. Before criticizing the present hearing, we must bear in mind that the duties of the Congress include protection of "the common defense, the general welfare, and the blessings of liberty, to ourselves and our posterity."

The law of the land makes it a criminal offence to plot the overthrow of the Government by force. We trust the Congress will always be alert in taking whatever measures may be necessary to further implement this law, and to guard the nation against any plot against democracy, whether emanating at home or abroad.

However, the Congress is bound equally by the Bill of Rights, composed of the ten original Amendments to the Constitution.

Article Nine of the Bill of Rights states: "The enumeration in the Constitution of certain rights shall not be construed to

-

deny or disparage other rights retained by the people." We believe that those rights of the people include the protection of their good name, protection from libel under whatever guise.

Specifically, Article Six of the Bill of Rights provides that "in all criminal prosecutions the accused shall enjoy the right to be informed of the nature and cause of the accusation ... to be confronted with the witnesses against him, to have compulsory process for obtaining witnesses in his favor, and to have the assistance of counsel in his defense."

We maintain that Congressional investigations such as the one presently taking place are not merely investigations, for if this were their full nature, they could be conducted without endangering the reputations and livelihood and happiness of the innocent for the alleged purpose of tracking down the guilty. We maintain that such investigations are tantamount to trials, in which the investigators assume the roles of prosecutors, on which public opinion sits in judgment, with effectiveness at least comparable to that of highly constituted judges.

We therefore urge, in the name of justice, that any person so questioned be ringed about with all the protections accorded by our law to those under indictment.

There is in us, and we must confess it, a suspicion that such unnecessary, destructive and un-American procedure is motivated by the desire for publicity at the expense of Hollywood and its people, always a target for those desiring to advance themselves politically on a popular issue. And we call attention to the fact that the Constitution and Bill of Rights were expressly

designed to protect minorities and unpopular opinions.

attitude towards Communism: We are opposed to it as a way of life. We have no sympathy with nor understanding of those Americans who would trade for our proud democracy a way of life and a form of Government which, wherever tried, have proved to be destructive of the rights and freedoms of the individual, which we so dearly cherish. Of course, we feel strongly that any American whose allegiance to a foreign power can be proven, is a traitor. Of course, we feel strongly that any alien who perjures himself in entering this country should be punished with deportation or otherwise.

But, however strong our feelings against Communism, we feel, just as strongly, that mass hysteria must not be permitted to usurp Constitutional privileges, nor to blur a single phrase of the Bill of Rights. It is our fear that tampering or compromising with any section of this charter of liberty, however expedient from the current viewpoint, however tempting to the current emotion, could destroy the whole, and for all time.

To add further strength to our protest against trials by implication, such as the current Congressional hearing, allow us to point out that Communism is not illegal. We presume and we hope fervently that, should the Communist Party of America or any other party or group, be proven to the satisfaction of our law-makers and the Courts to be disloyal, it will be outlawed. But until or unless laws are passed establishing Communism as being a subversive or otherwise criminal philosophy, we are obliged in

scrupulous devotion to our Constitution and Bill of Rights, to protect every man and every woman from the inquisition of pseudotrial and popular judgment for a non-existent crime.

Any contrary attitude seems to us to be the unthinkable equivalent of the treatment of Democrats in those countries where Communist or Fascistic dictatorship presently prevails. We hope always to be jealous of our political freedom, however strongly we may disagree with political philosophies that are espoused under its protection. And we wish to protect the rights of the individual against lynch law as a substitute for Constitutional and legal processes, regardless of whether the noose be made of rope or of public opinion.

In these tense times, it may seem inexpedient to defend the political rights of some who perhaps assail democracy itself.

However, the strength of democracy lies in its tolerance, without which we are no longer a free people. We have little fear that opening the forum to extreme fringes can result in the American electorate's trading its glorious heritage for potential tyranny.

We do not deny that there are Communists in Hollywood, as there are in many American communities, but we, as members of the Industry, know them to be an inconsiderable minority. We therefore can see no reason for making a circus of what pretends to be an investigation.

In this connection, we resent bitterly the careless hurling of the word "Communist" at Left-wing members of the Democratic Party or of independent non-Communist Leftist groups. We resent

this exactly as much, and for precisely the same reason, as we have resented the hurling of the terms "Fascist" and "tool of Wall Street" at sincere Right-wing Americans of the Republican Party -- including Wendell Willkie, who so nobly and successfully rushed to the industry's defense when it faced an unwarranted and similar attack.

The America we love and defend is the traditional America where men of good will and of different political faiths assemble in town meeting, discuss their political differences, and remain friends. For when the freedom to disagree, the right to dissent, is threatened in America, the whole fabric of our beloved country is endangered.

We wish to emphasize at this point that we are prepared to support the Constitutional privileges alike of both Right-wing and Left-wing political groups, insisting as a prerequisite to our support, that they hide behind no masks of name or purpose; and that they recognize the privileges of all minorities.

We feel that no witness should object to being asked under oath concerning his allegiance to this country, without reservation and without obligations, real or implied, to any foreign power or party.

We offer wholehearted support to those who can give such an oath. We have no support for any who refuse to swear fealty.

Until an individual is proven guilty of treachery under the law, we feel that the motion picture industry should give another demonstration of its Americanism by mobilizing itself, in all its

untapped power, in defense of the reputations of any of its members who are being unfairly tried before public opinion. We feel that this defense should include a united front in support of continuing employment, and new employment, for those whose talents warrant it, and who are guilty of nothing but free exercise of the American vote.

We hope that we may obtain the aid of the motion picture's sister media, the press and the radio, in this endeavor -- for it is clear that jeopardy to the freedom of one medium means eventual jeopardy to the freedom of all.

Finally, we resent the fact that our industry, our professions, our families and our friends, should be recurrently placed in a defensive position by those who seek to discredit us. We have faith that the great majority of the elected Congressional representatives of the American people resent equally with us distortions of the powers of the Congress; and that, equally with us, they recognize that these rights flow to Congress from the people, and are intended largely for the preservation of the rights of the people and of every group, large or small, popular or unpopular.

We invite other Americans of the motion picture industry to join with us in the organization of a committee dedicated to the preservation of American civil liberties, and to the defense of the good name of the Industry and the individuals who comprise it.
