one sets, for a duration of sixty

3. Artist shall be entitled to engage additional musicians and  
performers as they deem necessary in order to fulfill the above comm-  
ittment at Artist's sole cost and expense.

4. In consideration for Artist's services as set forth above,  
Employer shall pay to CRESCENT MOON PRODUCTIONS, LTD., or its designee  
the sum of \$500 Flat, payable in one  
installments on the dates of 6/8/82, by certified check  
or in cash if so requested. Said payments shall be made prior to the  
commencement of Artist's performances as set forth above.

5. CRESCENT MOON PRODUCTIONS, LTD., hereby warrants and represents that they have the right to enter into this agreement f/s/o Artist.

6. Employer shall be responsible for all customary production and promotion costs in connection with the presentation of Artist's performances hereunder including but not limited to, first class sound and lighting. Employer shall supply to Artist at Employer's sole cost and expense, those items set forth on Schedule A annexed hereto.

7. Employer shall make the above performance site available to Artist for on-stage rehearsals at the following times: \_\_\_\_\_

8. Employer hereby agrees not hold Artist and/or CRESCENT MOON PRODUCTIONS, LTD., liable for the obligations hereunder in the event of Artist's illness, accident or other Acts of God.
