Additional Terms of Contract

Representative shall as agent of employer, enforce disciplinary measures for just cause, and carry out instructions as to selections and manner of performance. The agreement of the musicians to perform is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God or any other legitimate conditions beyond their control.

Breach of this contract is only acceptable if agreed upon by employer and the group POWER (Representative) or by any conditions not met above by either party. Any other breach of this contract is unlawful and parties shall suffer the consequences by law.

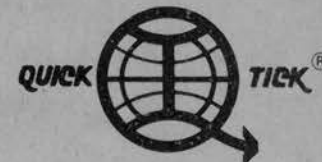

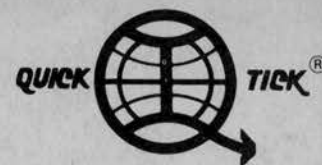
