7 Holifield, who is here with us, also.

8 Mrs. Humphrey and I will spend some time going
9 to each market. This is one of the great Federal projects,
10 and has character and meaning to this part of the great area
11 of the Metropolitan Los Angeles.

12 We want to compliment you on what you have done.
13 We want to compliment those who had the initiative and
14 vision to build this great market, and more important, we
15 want to thank those who are participants here, who are the
16 owners, so to speak, as well as the shopkeepers. They
17 have set an important example throughout the entire State of
18 California, or wherever people want to lift themselves and
19 engage in self-help.

20 Now, let's see if we haven't got some of our
21 good friends here. My good friend, Gilbert Lindsay, is
22 here with us; Congressman Chet Holifield; Assemblyman
23 Alex Garcia, who is with us here; and Supervisor Ernest
