Last month our government, and that of the Soviet Union, completed the first stage of the most important negotiations of the nuclear age. The Strategic Arms

SALT

Limitation (SALT) Talks, conducted in unprecedented amity in Helsinki, promise a new area of common effort to end the tyranny of nuclear weapons.

I have great hopes for the success of these talks, not as a "one shot conference" with a finite life and a single agreement, but rather as the beginning of a continuing cooperative effort to solve each new problem of nuclear development as it arises.

Caution

↳ I do not suggest that we should abandon caution, that we should blindly extend our trust of the Soviets beyond the arena of this conference table and into political areas where there is not yet a record of Soviet good intentions.

Halt Deployment

↳ But I do believe we should demonstrate our good faith by halting the deployment of all nuclear weapons, both offensive and defensive, while the SALT talks are in progress...and we should insist that the Soviets do the same.

↳ The United Nations General Assembly has called upon both countries to freeze production of weapons and delivery systems. I endorse this call.

And I urge once again that the United States halt further testing of the new and frightening MIRV warhead, in order to encourage the Soviet Union to halt its development of the weapon, which can make all our calculations about deterrence obsolete.

It will be difficult -- if not impossible -- to maintain the harmonious political atmosphere of the SALT talks if the United States continues to develop the MIRV.

↳ We can undertake this moratorium without in any way jeopardizing our own security for -- if we fail in this effort at nuclear control -- our existing supply of weapons is more than adequate for national security.

↳ But nuclear arms are not the only weapons threatening the human race with devastation and destruction. The plague of poisons and diseases spread by chemical and biological weapons present a threat of equal gravity to mankind. ~~(see next page)~~

↳ The gases that maim or kill, and the germs that spread diseases that medical science has long worked to control, are equally hideous arms in the national arsenal.

Last November President Nixon took a giant step toward peace when he renounced "the lethal biological agents and weapons, and all of the methods of biological warfare", and submitted to the Senate for ratification the Geneva Protocol of 1925 which prohibits the first use in war of asphyxiating, poisonous or other gases and bacteriological methods of warfare.

National and international leaders -- who had long urged the United States to join the major nations in ratification -- applauded the action.

~~Today we have reason to believe our applause came too soon. More than the honor of the United States is at stake.~~

But something has happened that dampens the ~~enthusiastic~~ ~~applause for the President's Action~~ -

~~Nations which are prevented by technological poverty from acquiring nuclear arms will have added incentive to acquire chemical and biological weapons so long as the United States does not, by example and moral suasion, reject these fearsome weapons.~~

~~What has happened to cause concern since the President's heralded announcement?~~

First:

The President announced that his interpretation of the Geneva Protocol does not prohibit the use of tear gas or of chemicals that destroy plant life. (The United Nations General Assembly voted to the contrary - 80 to 3.)

Our armed forces have been using both in Vietnam.

Second: The Secretary of Defense has announced that the Army will continue to produce disease-bearing toxins for military use -- toxins that cause plague, diphtheria and typhoid. The Army, in a semantic evasion, is contending that the toxins are chemicals -- unlike the germs that produce them -- and are, therefore, exempt from the ban announced by the President.

L This reasoning -- already rejected by the British government (which is sponsoring a new treaty on biological weapons -- a treaty Mr. Nixon claims to support) will:

The National Retail Furniture Association's Fiftieth Anniversary Banquet, at which Mr. Humphrey has agreed to speak on January 4 is the opening event in a year-long program NRFA has planned to mark its 50 years of service to the home furnishings industry.

The overall theme for the anniversary year will be oriented toward looking ahead and preparing our industry for the changes it will face. NRFA is calling it "Project 2020" ... indicative of a look ahead to the year 2020, 50 years from now.

Each banquet guest will receive a gold-bound copy of NRFA's Fiftieth Anniversary Golden Book ... titled Project 2020 ... as a souvenir. Editorially, Project 2020 will briefly recap the past 50 years of industry and NRFA history, and will concentrate on examining the industry's future. In keeping with the anniversary theme, it is our hope that Mr. Humphrey would select as the topic of his address his own view of some phase of the future which he feels would be appropriate to his audience of industry leaders who serve as the home furnishings purchasing agents for the homemakers of America.

NRFA looks forward to welcoming Mr. Humphrey to Chicago and would appreciate an indication of the subject of his address when he has made a decision.



An early decision on this invitation by you will be deeply appreciated.



Dear Hubert:

I have a firm and definite date for you on Sunday, January 4, 1970 for the 50th anniversary celebration of the National Retail Furniture Association to be held in Chicago, Illinois. I spoke with Mr. Gartner and he indicated to me that the date might be difficult but that I should put it in writing for your return on August 7 for a final decision. I have been told by Robert P. Gruenberg, Executive Vice President, to give you the following background.

The National Retail Furniture Association will celebrate its 50th anniversary on January 4, 1970 in an all industry banquet which will be staged in the Palmer House at which 1200 to 1500 industry leaders will assemble to pay a salute to home furnishing retailers for a half century of service to America's homemakers. The theme selected is "Project 2020" - e.g. covering a span of time from 1970 to 2020. It is our hope that the feature speaker will look ahead over this half century and discuss the dynamics of the social, political and economic forces for change which may be anticipated in the years ahead. In addition to the identification of these changes, it is our hope that the speaker will bridge the gap between the forces and the world in which we live, the manner in which our political, social and economic environments may change as it relates to businessmen and home furnishing retailing in particular.
