I THINK IT IS ENTIRELY APPROPRIATE THAT YOU HAVE
CHOSEN THE BEGINNING OF A WORKING DAY TO LAUNCH THE
ANNUAL DRIVE TO FIND JOBS IN THE MINNEAPOLIS METROPOLITAN
AREA FOR OUR FELLOW CITIZENS WHO ARE OUT OF WORK OR
UNDEREMPLOYED.

THIS IS UNCONSCIONABLE. IT IS ECONOMICALLY, SOCIALLY,

AND MORALLY WRONG.

LAST DECEMBER, THE NATIONAL LEAGUE OF CITIES AND THE
U. S. CONFERENCE OF MAYORS DOCUMENTED A TOTAL NEED ACROSS
THE NATION FOR AT LEAST 641,639 FULL-TIME JOB OPPORTUNITIES
FOR DISADVANTAGED YOUTH THIS SUMMER. YET THE
ADMINISTRATION'S BUDGET FOR FISCAL 1972 ALLOWED FOR ONLY
414,000 NEIGHBORHOOD YOUTH CORPS JOB SLOTS -- ABOUT THE
SAME AS LAST SUMMER. BUT HIDDEN IN THIS FIGURE WAS A
FURTHER REDUCTION OF THE TOTAL WORK-WEEK PERIOD UNDER THIS
PROGRAM FROM 10 TO 8 WEEKS. NOW, TO OUR YOUTH COORDINATORS
SERVING UNDER OUR CITY MAYORS THESE "WORK-WEEKS" ARE JUST
AS IMPORTANT AS JOB SLOTS, BECAUSE THEY PERMIT FLEXIBILITY IN
PROVIDING STILL MORE JOB OPPORTUNITIES OVER VARYING PERIODS.

ON THE FLOOR OF THE SENATE I ATTACKED THIS POLICY
OF OFFICIAL NEGLECT OF CRITICAL PROBLEMS CONFRONTING
OUR YOUTH ALREADY FACING THE ADVERSITY OF POVERTY. I
POINTEDLY ASKED: "AS THE SUMMER APPROACHES WITH OVER
5.4 MILLION AMERICANS OUT OF WORK, DOES THE ADMINISTRATION
PROPOSE TO COMPOUND THE ERRORS OF ITS PAST ECONOMIC
POLICIES BY DENYING HUNDREDS OF THOUSANDS OF DISADVANTAGED
YOUTH A FAIR CHANCE AT OBTAINING JOBS?"

↳ SENATORS AND REPRESENTATIVES OF BOTH POLITICAL
PARTIES STRONGLY ^{have} CRITICIZED THIS ADMINISTRATION POLICY
OF NEGLECT. ↳ THEY CALLED FOR IMMEDIATE FULL FUNDING OF THE
NEIGHBORHOOD YOUTH CORPS SUMMER JOBS PROGRAM COMMENSURATE
WITH THE SERIOUS NATIONAL NEED.

THEY ASKED WHY THE ADMINISTRATION HAD FAILED TO ANNOUNCE
 FIRM PLANS FOR SUMMER JOB PROGRAMS, RECOGNIZING THAT OUR
STATES AND CITIES NEED TO KNOW WHAT FEDERAL ASSISTANCE THEY
 CAN COUNT ON WELL IN ADVANCE IF THEY ARE TO BE ABLE TO
 FIND THE JOBS AND GET THE WORD OUT TO YOUNG PEOPLE IN POOR
 NEIGHBORHOODS IN TIME FOR ALL THIS TO COUNT FOR ANYTHING
 BOTH FOR LOCAL BUSINESS ITSELF AND IN THE LIVES OF THESE
 YOUTH.

L BUT I INTEND TO GIVE CREDIT WHERE CREDIT IS DUE.

JUST RECENTLY, THE ADMINISTRATION RESPONDED TO THIS CRITICISM
 BY ANNOUNCING A PARTIAL INCREASE IN SUMMER JOB PROGRAM FUNDS
 AND BY RAISING THE WORK PERIOD TO NINE WEEKS.

HAVING CALLED FOR AN IMMEDIATE SUPPLEMENTAL APPROPRIATION,

I LOOKED CLOSELY AT THE FIGURES WHICH CAN BE VERY MISLEADING.

L FIRST, IT SHOULD BE RECOGNIZED THAT ABOUT HALF OF

THIS ADDITIONAL \$64.3 MILLION AMOUNTED TO A RESTORATION

OF FUNDS CUT BACK FROM THE AUTHORIZED LEVEL FOR LAST SUMMER,

L THUS, TO SAY THAT ALL THIS MONEY WILL CREATE NEW JOB

OPPORTUNITIES IS TO DO VIOLENCE TO THE FACTS.

L SECOND, THE TOTAL WORK PERIOD IS STILL ONE WEEK LESS

THAN WHAT IT WAS LAST SUMMER, L SO WE ARE ACTUALLY TALKING

ABOUT A FEDERAL COMMITMENT TO PROVIDING 4,626,000 WORK

WEEKS, AS OVER AGAINST A NATIONAL WORK NEED DOCUMENTED BY

OUR MAYORS AT 6,416,390 WEEKS.

SINCE A FEDERAL EXPENDITURE OF \$481 -- COMPARED WITH \$442
LAST YEAR -- WILL BE REQUIRED TO PROVIDE EACH JOB OPPORTUNITY,
WITHOUT CUTTING THE HOURS OF PARTICIPATION, THE DOCUMENTED
NEEDS CAN ONLY BE MET BY AN ADDITIONAL APPROPRIATION OF
\$144.6 MILLION -- OR ABOUT \$80 MILLION MORE THAN THE
ADMINISTRATION HAS REQUESTED.

I INTEND TO KEEP FIGHTING FOR THE APPROPRIATION OF
THESE ADDITIONAL FUNDS. BUT THIS MUST BE ONLY PART OF
THE EFFORT AT THE NATIONAL LEVEL TO HELP OUR DISADVANTAGED
YOUNG PEOPLE. WHAT DEEPLY DISTURBS ME IS THE OVERALL
DECLINE IN JOB OPPORTUNITIES INITIATED OR STRONGLY ENCOURAGED
BY THE FEDERAL GOVERNMENT. AS CHAIRMAN OF THE PRESIDENT'S
COUNCIL ON YOUTH OPPORTUNITY, I WITNESSED A TOTAL OF AT LEAST
856,000 JOBS GENERATED IN 1968.

DIRECT FEDERAL HIRING RESULTED IN 78,000 JOBS FOR POOR YOUTH THAT SUMMER. THE NATIONAL ALLIANCE OF BUSINESSMEN ACCOMPLISHED SOME 141,000 JOB PLACEMENTS. BUT WHILE THE N.A.B. RECORD REMAINED FAIRLY CONSTANT THROUGH THE SUMMER OF LAST YEAR, DIRECT FEDERAL HIRING DECLINED TO ABOUT 60,000 AND THE TOTAL NUMBER OF JOBS CREATED IN THE PUBLIC AND PRIVATE SECTORS DECLINED TO A LEVEL ESTIMATED AT SLIGHTLY OVER 610,000.

NOW THERE IS ONE REASON FOR THIS DECLINE, AND THAT IS AN ABSENCE OF POLICY, OF DIRECTION, AND OF SOLID FORWARD THRUST AT THE FEDERAL LEVEL. THIS WAS MADE ABSOLUTELY CLEAR BY THE NIXON ADMINISTRATION'S RECENT ACTION TO DISCONTINUE THE PRESIDENT'S COUNCIL ON YOUTH OPPORTUNITY.

I AM SIMPLY AMAZED AT THIS EXAMPLE OF GROSS NEGLIGENCE
ON THE PART OF THE ADMINISTRATION.

IT WAS MY PRIVILEGE TO SERVE AS CHAIRMAN OF THIS COUNCIL
FROM ITS CREATION, ^{LATER FORMALIZED} BY EXECUTIVE ORDER IN MARCH, 1967, UNTIL
THE COMPLETION OF MY TERM AS VICE PRESIDENT. WE WORKED
LONG, HARD HOURS TO COORDINATE YOUTH OPPORTUNITY PROGRAMS
OF EMPLOYMENT, EDUCATION, RECREATION, AND HEALTH SERVICES.
WE PULLED TOGETHER FRAGMENTED FEDERAL RESOURCES AND
ACCELERATED THE DELIVERY OF FEDERAL FUNDS AND TECHNICAL
ASSISTANCE FOR SUMMER PROGRAMS FOR YOUNG PEOPLE ACROSS THE
NATION WHO WOULD OTHERWISE HAVE BEEN WITHOUT HOPE.
WE SUCCEEDED IN GENERATING A REMARKABLE COOPERATIVE EFFORT
BY OUR CITIES AND NATIONAL AND PRIVATE ORGANIZATIONS.

I REGARD THE OPPORTUNITY TO WORK CONTINUOUSLY WITH
MAYORS, GOVERNMENT OFFICIALS, AND DEEPLY COMMITTED CITIZENS
AS ONE OF THE FINEST EXPERIENCES OF MY PUBLIC SERVICE.

NOW THE ADMINISTRATION HAS DISSIPATED THIS INTENSIVE
EFFORT TARGETTED AT PROVIDING SOLID HELP AND ENRICHING
THE LIVES OF YOUNG PEOPLE WHO HAD ONLY KNOWN DESPAIR, ECONOMIC
CRISIS, AND THE VIOLENCE AND FILTH OF THE STREETS IN THE
CITY SLUM.

THE ADMINISTRATION WOULD DISTRIBUTE THE FUNCTIONS
OF THE PRESIDENT'S YOUTH OPPORTUNITY COUNCIL AMONG THE
DOMESTIC COUNCIL, THE OFFICE OF MANAGEMENT AND BUDGET, AND
THE DEPARTMENTS OF HEALTH, EDUCATION, AND WELFARE AND OF
LABOR.

I AM AMAZED AT THE ASSERTION THAT THIS FRAGMENTATION WILL IMPROVE THE EFFICIENCY OF THE COUNCIL'S OPERATIONS. IN ADDITION TO NOT KNOWING WHOM TO CONTACT ABOUT FEDERAL POLICY AND COMMITMENTS ON SUMMER YOUTH PROGRAMS WITHIN THESE SEVERAL AGENCIES, OUR GOVERNORS AND MAYORS WILL HAVE TO THUMB THROUGH A LIST OF SOME 65 CONTACTS IN THE FEDERAL GOVERNMENT ON SPECIFIC PROGRAM QUESTIONS.

THIS EXECUTIVE DECISION THAT WAS NOT EVEN FORMALLY ANNOUNCED, AMOUNTS TO THE ABANDONMENT OF ANY CONCENTRATED EFFORT TO HELP HUNDREDS OF THOUSANDS OF YOUNG PEOPLE AT A TIME WHEN THEY DESPERATELY NEED TO BE HELPED.

SEVERAL MONTHS EARLIER, THE VITALLY IMPORTANT YOUTH
COORDINATOR PROGRAM HAD BEEN BURIED IN THE MANPOWER
ADMINISTRATION OF THE DEPARTMENT OF LABOR, WITH YOUTH
COORDINATOR GRANTS BEING FOLDED INTO FUNDING FOR THE
COOPERATIVE AREA MANPOWER PLANNING SYSTEM. THE SPECIFIC
INTENT OF THIS TRANSFER BY THE OFFICE OF MANAGEMENT
AND BUDGET WAS THAT THE YOUTH COORDINATOR PROGRAM BE RUN
ON A LOW KEY BASIS. A HIGHLY VISIBLE PROGRAM WAS VIEWED
AS HAVING UNDESIRABLE IMPLICATIONS.

WHAT ALL THIS DEMONSTRATES IS THAT THIS ADMINISTRATION HAS NO INTENTION OF REGARDING YOUTH OPPORTUNITY PROGRAMS AS ACTION-ORIENTED, WHERE THE CENTER OF PLANNING AND TECHNICAL ASSISTANCE AT THE FEDERAL LEVEL CAN BE PINPOINTED, AND STATE AND LOCAL GOVERNMENT OFFICIALS CAN BE KEPT UP TO DATE ON SPECIFIC PROGRAM OPPORTUNITIES. AND BE ASSURED OF THEIR ON-TIME DELIVERY.

NOR, IN ADDITION TO FAILING TO PROVIDE ADEQUATE JOB OPPORTUNITIES FOR OUR DISADVANTAGED YOUNG PEOPLE, IS THERE ANY REAL THRUST IN THE CURRENT ADMINISTRATION'S POLICY TOWARD EXPANDING THEIR OTHERWISE VICIOUSLY-CONSTRICTED HORIZONS THROUGH NEVER-BEFORE-EXPERIENCED RECREATIONAL AND EDUCATIONAL OPPORTUNITIES -- A WEEK AT SUMMER CAMP WITH 3 SQUARE MEALS A DAY;

A CHANCE FOR A DAY AT THE CIRCUS OR FOR A TRIP TO THE
AIRPORT; A NEW WORLD OPENED THROUGH LEARNING A HOBBY OR
SKILL; OR THE CHANCE TO PARTICIPATE IN A SPORTS PROGRAM
RUN BY PROFESSIONAL ATHLETES. IN FACT, ONLY AT THE LAST

THE DESPAIR OF THE URBAN GHETTO, REFLECTED IN HIGH RATES OF SUICIDES AND ILLEGITIMATE BIRTHS AND ACTS OF CRIMINAL VIOLENCE, OUGHT TO SHOCK US INTO IMMEDIATE ACTION. WE KNOW THAT THE LONG LINES OF THE UNEMPLOYED WILL BE SWELLED AS THE SCHOOL YEAR COMES TO A CLOSE. HAVE WE EVEN BEGUN TO PREPARE FOR THIS CRITICAL SITUATION?

YOU CAN BE CERTAIN THAT I WILL DO EVERYTHING POSSIBLE TO
