OVER 15 MILLION MEN, WOMEN, AND CHILDREN FACING WEEKS AND MONTHS OF ECONOMIC AND EMOTIONAL TRAUMA ARE DEPENDING UPON OUR FEDERAL GOVERNMENT TO MOBILIZE OUR NATION'S ECONOMY NOW TO HELP OUR PEOPLE HELP THEMSELVES. THEY ARE ASKING NOTHING MORE THAN THE CHANCE TO AGAIN EXPERIENCE THE DIGNITY OF WORKING FOR THEMSELVES AND THOSE THEY LOVE, AND THE SECURITY OF A DECENT INCOME.

WE HAVE SIMPLY GOT TO GET AMERICA'S POWERFUL BUT CRIPPLED INDUSTRIAL AND BUSINESS SECTOR ON ITS FEET AGAIN, RESTORING OUR ECONOMY TO ITS FULL POTENTIAL. AND, GOVERNMENT MUST BE A FULL PARTNER IN ASSURING USEFUL EMPLOYMENT FOR ALL WHO WANT AND NEED TO WORK.

THAT WAS THE FUNDAMENTAL MANDATE OF THE EMPLOYMENT
ACT OF 1946. I SAY THE REPUBLICAN ADMINISTRATION IS
VIOLATING THIS LAW, FOR IT HAS, IN FACT, CREATED UNEMPLOYMENT
WHILE SIMULTANEOUSLY FAILING TO HALT INFLATION. AND I
SAY THE JURY OF THE AMERICAN ELECTORATE WILL RENDER ITS
VERDICT IN NOVEMBER, 1972.

WE ARE A STRONG, INTELLIGENT, AND RESOLUTE PEOPLE. WITH
ADEQUATE GOVERNMENT ASSISTANCE WE WILL GET THIS COUNTRY
MOVING AGAIN. AMERICA CAN GET HOLD OF ITSELF. OUR GOVERNMENT
DOES HAVE THE CAPACITY TO RESPOND AND DELIVER ON THE
EMERGENCY ORDERS PLACED BY THE CITIZENRY TODAY. YOU CAN BE
SURE THAT I WILL DO EVERYTHING POSSIBLE TO SEE THAT THIS
IS DONE. FOR WE ARE TALKING ABOUT PEOPLE -- PEOPLE WHO
DESERVE A LIFE OF DECENCY AND DIGNITY.
